- Quarterly estimated tax payments are required for taxpayers with a tax liability after withholding credits of more than \$200.00.
- Late payment penalty of 15% is charged on unpaid income tax balance (including unpaid or underpaid estimated tax). Interest is 0.583% per month on past due tax.
- If your return is postmarked after midnight of the due date and you are not on a federal extension, a late filing penalty of \$25.00 will be charged.
