- ALL items pertaining to your request listed above must be submitted to the Division of Building and Zoning Inspection no later than 4:30 p.m. on the Wednesday before the meeting date that month. If the application is incomplete, the request will not be sent to the Board for consideration.
- Please supply any information that the applicant feels is pertinent to the request.
- Incomplete applications will be returned to the applicant.
