



RETIREMENT

In April 2010 Patrolman Bob Lindsay retired after twenty-eight years of service to Maumee. Bob was Maumee's first DARE Officer and first School Resource Officer. His career was dedicated to the youth of our community where he had a positive impact on several hundred young people.

INTERNSHIP/RIDE-ALONG

In 2010, the Division hosted four interns. Two were from the University of Toledo who interned January – May and August – December. One student from Owens Community College interned April – May. Also in May we hosted an intern from St. John's High School. The students observed officers at the patrol level, investigations, and assisted in various aspects of police operations.

Various students and professionals also participated in the police division ride-along program where citizens were able to ride in a marked police cruiser and observe an officer in his/her daily duties.

UNDERAGE ALCOHOL SALE "STING"

The Maumee Police Division conducted one underage alcohol sting in December of 2010. The purpose of the sting is to enforce the existing laws and policies regarding underage alcohol violations, and serve as a deterrent to those who seek to violate such laws and policies by increasing the perception of "risk of apprehension."

Thirteen establishments selling carryout alcoholic beverages were targeted. Only one of these establishments failed to check identification and sold alcohol to an underage informant. As a result, the clerk was charged with first-degree misdemeanor for sales to underage persons. Letters of support and appreciation were sent to the twelve businesses that were in compliance. Grant funds, in the amount of \$962.00, from the Community Partnership of Greater Toledo were used for this operation.





BULLETPROOF VEST GRANT

The Maumee Police Division participated in the US Department of Justice bulletproof vest partnership grant. The Division purchased 13 bulletproof ballistic vests for officers in 2010 and was reimbursed a total of \$4,959.44 from this grant.

OVI SATURATION PATROL

As a member of the Lucas County OVI Task Force, the Maumee Police Division conducted grant funded OVI saturations patrols once again in 2010. These patrols were directed toward identifying and apprehending motorists who drive while under the influence of alcohol and/or drugs of abuse.

Saturation patrols were conducted on a monthly basis and totaled 168 hours in 2010. One hundred sixty-six traffic stops were made, 81 traffic citations issued, and six OVI arrests. Additionally, \$10,863.60 in personnel costs were reimbursed to the City of Maumee from the OVI task force grant for saturation patrols and the sobriety checkpoint.

SOBRIETY CHECKPOINT

As a member of the Lucas County OVI Task Force, the division conducted an OVI checkpoint in August of 2010 in the 1200 block of Conant Street. A total of 587 vehicles entered the sobriety checkpoint. Three Child Restraint citations were issued, two subjects were arrested for Driving Under Suspension, one subject was arrested for Operating a Vehicle while under the Influence, two other subjects were arrested on outstanding warrants, and six "other" traffic citations were issued. Assisting the Maumee Police Division were members from the Toledo Metro parks, Whitehouse Police Department, the Ohio State Highway Patrol, Waterville Township Police Department, and volunteers from the Maumee Citizen Police Academy.



Year in review

DARE

This year DARE was taught to seven hundred seventy-seven students in the first, fifth, seventh, and tenth grades. The fifth grade program culminated in two graduation ceremonies. Charlie's Dodge continues to provide the Maumee DARE program with a donated vehicle with graphics. The program continued to receive funding assistance from the State of Ohio Attorney General's Office with a grant award of \$14,239.00

BIKE SAFETY RODEO

Seventy-seven children participated in the rodeo free of charge. Maumee Police Division Bike Officers, Citizen Police Academy Volunteers, and volunteers from our Healthy Maumee Partners assisted the crime prevention staff by inspecting each bike, conducting safety checks, and making repair recommendations. Bicycle helmets were given away free of charge to any cyclist or skateboarder who needed a helmet.

SPEED MONITORING TRAILER

The Maumee Police Division utilizes the speed trailer as a tool to slow traffic and reduce accidents.

The speed trailer was used in the school zones as a means of gaining compliance with the speed limits during school hours. The speed trailer was deployed in residential areas where the Police Division received complaints of speeding. In addition, the speed trailer was deployed on Conant Street when there was an uptown event where there would be a lot of pedestrian traffic. This included parades, Maumee Summer Fair, and the Rock-the-Block events. The speed trailer was also helpful in slowing traffic in road construction areas such as U.S. 24 and W. Dussel Drive. The speed trailer was deployed over 48 days during 2010.

The Maumee Police Division will continue to utilize this equipment as a valuable tool in gaining compliance with speed limits and in lowering traffic crashes.

COPS – N – SHOPS

In 2010 we conducted two of these operations, one in April and one again in October. We again partnered with JD's Drive-Thru to deter and enforcement underage persons from attempting to purchase alcoholic beverages. We are pleased to report no violations were observed during either date.





There was one fatal accident in 2010 that occurred in the 5900 block of Monclova Rd.

Seven of the thirty-six accidents involving deer occurred at the Anthony Wayne Trail and I-475 compared to six of twenty-seven last year.

Following the 10 most hazardous intersections is a summary recap of all accidents occurring within the City of Maumee during 2010, both on public and private property, and a graph showing the number of accidents occurring each month.

The number of accidents at the most hazardous intersection stayed the same in 2009 and 2010 at 45. The total number of accidents in the 10 most hazardous intersections increased, from 246 in 2009 to 248 in 2010. There were 2 two-way ties in both years; one for second place and one for eighth place in 2010 and one for sixth place and one for ninth place in 2009.

Three intersections dropped from the list this year: Arrowhead Rd. & W. Dussel Dr., Holland Rd. & W. Dussel Dr., and Ford St. & W. Dussel Dr. Three intersections were added: the Anthony Wayne Trail & Conant St., the Anthony Wayne Trail & Gibbs St., and Holland Rd. & W. Dussel Dr.



Retired DARE Officer

Officer Bob Lindsay retired May 2010. All the DARE and Crime Prevention responsibilities were transferred to Officer Urbanski.

Officer Jillian Urbanski handled all sector assignments for Crime Prevention from May 2010 thru end of year. Officer Urbanski also received her Crime Prevention Specialist Certification in August 2010. Officer Jeff Medere is also Crime Prevention Specialist Certified and maintains his certification by attending continuing education classes.





SAFETY CITY

The City of Maumee Safety City program celebrated its 31st year in 2010. Ninety-three children participated in the summer program to help prepare four and five year olds to safely attend kindergarten. Safety City consisted of classroom instruction, crafts, songs, and practical exercises in vehicle and pedestrian safety. Lessons were conducted on our miniature Safety City equipped with streets, crosswalks, traffic signals, railroad tracks, and faux buildings. In 2010, there was one 2-week session in June lasting 2-1/2 hours each day.

The staff included two Maumee Police Officers, two teachers, and 18 high school student volunteers. Safety City is located at Wayne Trail Elementary School.

The Maumee Police Division and Maumee Board of Education sponsor Safety City. McDonald's (Conant St.), Motophoto (Foundation Park), and the Maumee Municipal Court support the program through donated products and services. St. Luke's Hospital provides each graduate of Maumee Safety City with a bike helmet.

This year Maumee Rotary donated funds for the purchase of new motorized jeeps.



D.A.R.E. PROGRAM

The DARE program provides the students with the tools necessary to make the right decisions when it comes to alcohol, tobacco, and other drug choices. It is taught in all of the Maumee City Schools. This year DARE was taught to777 students in the first, fifth, seventh, and tenth grades. The fifth grade program culminated with one graduation ceremony.

DARE officers had a booth at the Maumee Uptown Fair. Many of the area DARE students attended this event and DARE night at Ohio Skate, which provided an opportunity to reinforce the DARE drug free choice.

Charlie's Dodge continues to provide the Maumee DARE program with a donated vehicle with graphics each year.



SEAT BELT SAFETY

The Crime Prevention Officers taught the Third Grade Safety Belt Program to all third grade students in the Maumee School District including St. Joseph's Catholic School. Two hundred nineteen students received practical training in the Ohio Department of Public Safety education program. The program encompassed the proper use of seat belts, statistics about accidents/seatbelt usage, and information on air bags. Each child received material and information to share with their family members. As part of the program, each student was deputized as Seat Belt Deputies as they pledged to wear their seat belt.

ARE YOU OK? PROGRAM

For twenty-one years the Maumee Police Division has operated the "Are You O.K.?" program. Known as R.U.O.K., the program continues to check the safety of our senior citizens as well as our hotel night clerks and gas station attendants. Each participant receives a daily or nightly call checking on his or her safety. A police crew is sent to check their safety if there is no answer.

The program has helped many participants since its inception. The program has expanded to check the safety of 24-hour gas station employees. The program currently has ten individual subscribers, along with nine hotels and five gas stations.



CHILD SAFETY SEAT CHECKS

The Maumee Police Division has two officers that are certified technicians in child seat safety. Officer Newsome and Officer Urbanski are certified through Safe Kids Coalition, Child Passenger Safety Training Program. This training enables the Maumee Police Division to provide our community with highly trained experts in the proper installation and implementation of child car seats.

In 2010, Officer Newsome performed two child safety seat checks and Officer Urbanski performed sixteen child safety seat checks.

BIKE SAFETY

Bike safety/education is an important part of the Maumee crime prevention program. Again this year, a bike rodeo was held in May at Fairfield Park. Approximately seventy-seven children participated in the rodeo free of charge. Maumee Police Division Bike Officers and Citizen Police Academy Volunteers assist the crime prevention staff by inspecting each bike, conducting safety checks, and making repair recommendations. Cyclists participated in an agility course to test their skills.

Those who attended received a safety packet and bicycle helmets were given away free of charge to any cyclist who needed a helmet.

Again this year Healthy Maumee and the Senior Center participated by providing health fitness screenings to all participants.

The Maumee Police Division again participated in the Maumee Municipal Court's Bike Helmet Reward Program. The Court, under the leadership of Judge Gary Byers, supplied area police officers with coupons. When the officers observe children wearing bike helmets, they provided them with the coupon good for a free ice cream cone. These coupons have helped to increase the use of bike helmets by cyclists, skateboarders, and roller-bladders.



Home

The Maumee Police Division continues to provide bike licenses free of charge. A licensed bike enables an owner to be identified and the bike returned when found or recovered.

The training bureau continued to create a balance between minimizing training expenses and maintaining proficiencies of police division personnel. We continued to restrict conference attendance and out of state training as part of our cost cutting effort for the 3rd year. The challenge is always finding the correct balance between training in high frequency/low risk tasks (HF/LR) versus low frequency/ high risk (physical harm, liability & profile) (LF/HR) tasks.

HF/LR training efforts tend to be conducted in-house by instructors with specialized or in-depth training with a particular skill. Additionally, much of our LF/HR training is focused on the Special Response Unit regular in-house training. The officers that facilitate these in-house training efforts must continue to expose themselves to a variety of training to stay up to date on tactics, equipment, legal issues, and professional standards.

Additionally, some special duty assignments or tasks such as School Resources Officer (SRO), Drug Abuse Resistance Education (DARE) Officers, photographers, investigators, bomb technicians, tactical dispatchers, negotiators, supervisors, and managers are best supported by networking with others that perform the same duties from other agencies. This networking helps to maintain skill sets, renews motivation, and develops improved approaches to achieving the division's goals in these specialized areas.

Much of our training effort for our core function, patrol operations, is limited to in-house training addressing the basic skill sets necessary to perform the patrol function: 1st Aid, CPR, AED; Firearms Qualifications, Taser, OC, and Use of Force; Continual Professional Training (Internet Based Training) offered by Ohio Peace Officers' Training Academy; and Firearm Training Simulator (decision making). Additionally, we used various sources in continual efforts to expose all officers to Crisis Intervention Training; Alcohol Detection and Prosecution; Criminal Procedures; Vehicle Operation; Radio Resource Management; and Active Shooter Response.

Major Investigations

An investigation was conducted into a Maumee High School coach for alleged inappropriate conduct with students. The investigation was centered around three students involved allegations of continued/unwanted text messaging, unwanted touching as well as kissing students. The investigation resulted in multiple criminal complaints being filed for gross sexual imposition and assault.



Sex Crimes

Rape

Three rapes were reported in 2010. All rape cases were cleared by presentation to the prosecutors office for prosecution.

Eight reports of Sexual Imposition were reported in 2010. One report was found to be unfounded. One victim refused to cooperate with the investigation. The remaining cases were all successfully prosecuted.

Robbery

Three robberies of businesses were reported in 2010. Two have been cleared through investigation.

Two robberies of persons were reported and remain under investigation.



Residential Burglary

Twenty-nine residential burglaries were assigned for investigation. Investigations resulted in the arrest of three suspects.

Auto Theft

Six cases of auto theft were reported. Investigation resulted in one arrest and prosecution. The autos were recovered in all cases.

Breaking and Entering to Businesses

Ten cases were assigned for investigation. One case resulted in an arrest and prosecution. One case the victim refused to prosecute once the suspect was identified. Three cases are pending while evidence is waiting to be evaluated at the crime lab.

Personnel changes were made in 2010

Ptl. LaPlante was reassigned from the detective bureau to a position as school resource officer. This move was the result of Ptl. Wegman's retirement from the police department.

This was the 9th year for the School Resource Officer (SRO) Program in the City of Maumee. The Maumee Police Division began its fifth school year with two full-time SRO's. Officer Weaver provided SRO coverage to all Maumee City Schools from March 17 to June 6, 2010 due to an extended absence of Officer Wegman. Officers Wegman and Weaver completed their assignments as SRO with the Maumee Police Division at the end of the 2009 - 2010 school year.

Officer Paul LaPlante completed the Basic School Resource Officer training program in August of 2010 and began as the Division's new SRO for the 2010 - 2011 school year.

The goal of the SRO Program is to provide a resource of law enforcement knowledge to the students and teachers, plus work closely with school administration on law enforcement issues. The SRO's duties include campus security/safety and working with school personnel and students on problems related to law enforcement and community services. Other duties include classroom instruction on such topics as alcohol and drug prevention, violence, crime prevention, and safety programs as well as other criminal law related topics. A substantial amount of time is spent by the SRO's utilizing alternative dispute resolution with students, teaching them problem solving skills and using arrest as a last resort.

The SRO's sits in on 1 to 5 disciplinary meetings per day, providing insight and behavioral recommendations at the discretion of the school administrators. The SRO's also meet with school administrators, counselors, and the In-School Reassignment (ISR) Supervisors on a daily basis.

SRO LaPlante was involved with developing a Student of the Month for Maumee High School. This program is to award positive behavior and students who show acts of kindness.

SRO's assisted with one lock-down drill at Gateway Middle School, two at Maumee High School, one at Wayne Trail, and one at Fairfield Elementary. All of the schools performed lockdown drills, but not all drills may have been attended by SRO's.



SRO's continue to reach out to the Maumee City School District's four elementary schools to provide an improved level of support. SRO's have been able to assist elementary school principals in situations ranging from consultations with students to safety/security issues and investigations of criminal complaints. Although these callsfor-service are few and far between regarding the elementary schools, Principals have expressed their gratitude when an SRO is able to respond.

In 2010, Mr. Chris Conroy, the retiring Principal of Gateway Middle School, was nominated for "Administrator of the Year" with the Ohio School Resource Officer's Association (OSROA). Mr. Conroy learned he was the chosen nominee and received his award at the annual OSROA conference held at Oregon Bay State Park on June 29, 2010.





The SRO is an integral part of the school organization, playing a special role in each school day. Not only do SRO's enforce local and state laws, but also their visibility in many classrooms and talking with students in non-enforcement situations creates a fabric of understanding upon which the stability of the whole school community rests. This cooperative effort, integrated with the total school program, builds a reservoir of understanding for good citizenship between the police and students. Below is a recap of daily activities:



Police Response to Calls by Day of Week







Motor Vehicle Crash Reports By Month










2,221 Total Citations by Day of the Week






Citation by Age & Sex












