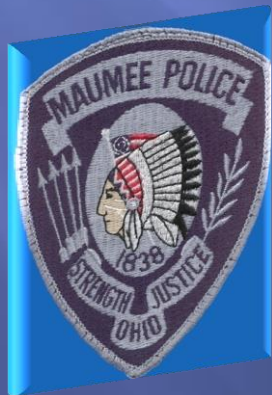

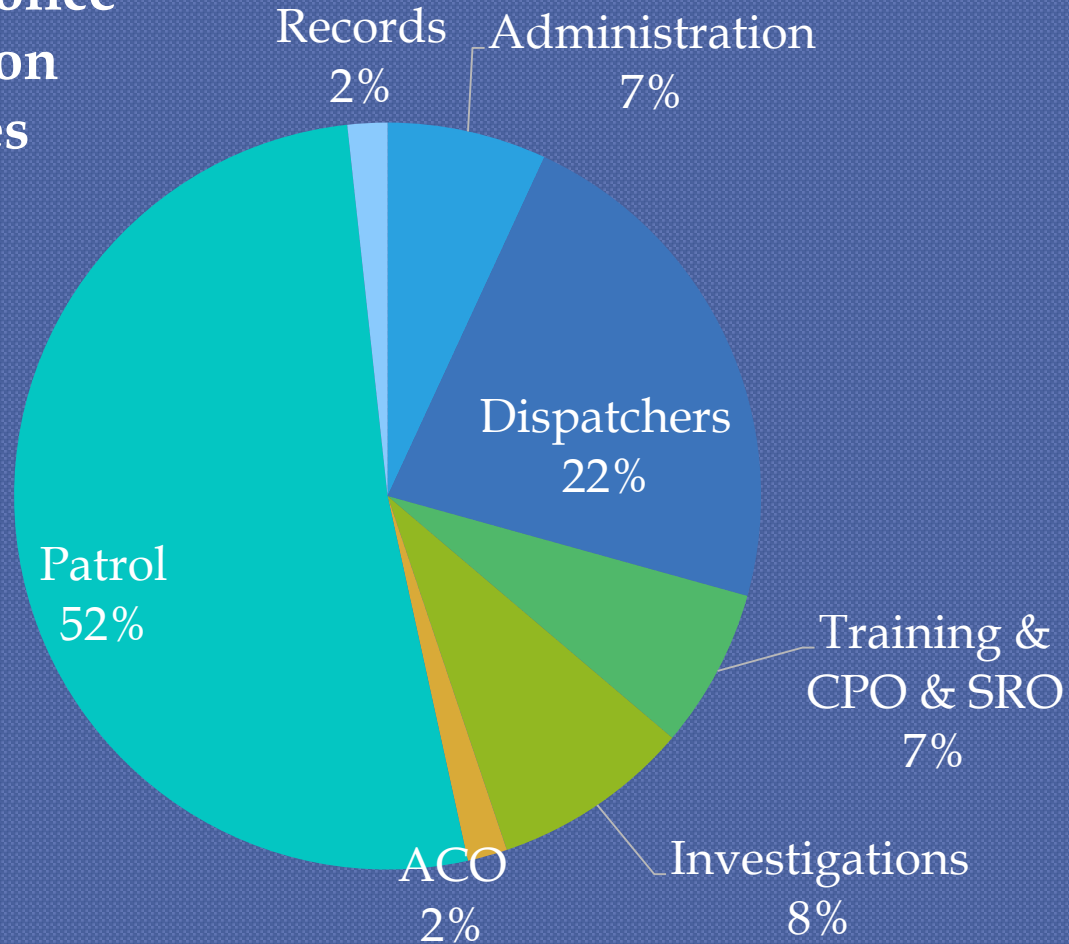

# Year in review

## STAFFING

James MacDonald was appointed Chief of Police for the division. Chief MacDonald served as a Sergeant in charge of patrol operations and crime prevention/training bureau. He was promoted to Lieutenant supervising the support operations. Chief MacDonald is a firearm and use of force instructor. He holds a Master degree in Public Administration, completed the Police Executive Leadership College offered by the Ohio Association of Chiefs of Police, and completed the FBI National Academy, Quantico, Virginia in the fall of 2014.

David Tullis was promoted to Lieutenant in charge of support operations in April 2014. Lt. Tullis is a twenty nine year veteran with the police division. He had held the rank of Sergeant since 1990, with duties including supervision assignments in patrol operations, crime prevention bureau, and the detective bureau. Lt. Tullis is a graduate of the Police Executive Leadership College sponsored by the Ohio Association of Chiefs of Police.



# Year in review

Jonathan Warden was promoted to sergeant in April 2014. Sergeant Warden was a field training officer for new recruits, served a four year assignment as an investigator in the detective bureau, and is a member of the special response unit. He also serves as a firearm and use of force instructor. Jon served sixteen years as a Patrolman when he was promoted to Sergeant.

In November of 2014 Dispatcher Constance Sullivan retired after 25 years of service. Connie received numerous letters of commendation during her tenure with the Maumee Police Division. She was instrumental in the implementation of a new CAD operating system and served as a field trainer for new hires.

# Year in review

## A.L.I.C.E.

Alert, Lockdown, Inform, Counter, Evacuate. Three members of the PD, in cooperation and partnership with the Maumee Board of Education and Superintendent Office, continued training the ALICE concept of school safety to the Maumee City School district. All staff, faculty, teachers, and administrators were involved in this school safety enhancement program. Ongoing training, information, and drills will take place at all MCS facilities with the continued commitment to this training.

## SCHOOL RESOURCE OFFICER

The Maumee Police Division assigned a full time school resource officer at Gateway Middle School as well as a second officer at the Maumee High School.

## BULLETPROOF VEST GRANT

The Maumee Police Division participated in the US Department of Justice bulletproof vest partnership grant. The Division purchased eight bulletproof ballistic vests for officers in 2014. The City of Maumee was reimbursed a total of \$3,196 from the grant.

## COLLEGE INTERNSHIPS

The PD facilitated four college internships for students. Mr. Joshua Muir completed a 240 credit hour internship and graduated from the University of Toledo in May 2014 with a Bachelor of Science degree. Mr. Bryan Fritz, a Maumee resident and UT student completed his 240 credit hour internship in December 2014. Mr. Brad Whitman of Maumee completed a 30 hour internship while attending Owens College. Ms. Victoria Plummer of Perrysburg performed a 100 credit hour internship and will graduate in 2015 from Defiance College with a Bachelor of Science degree.

Additionally, several students and professionals also participated in the police division ride-along program where citizens were able to ride in a marked police cruiser and observe an officer in his/her daily duties.

## CITIZEN POLICE ACADEMY

The Police Division continues to support our Citizen Police Academy volunteers. Citizen Police Academy graduates contributed 150 hours of volunteer time to various police supported functions. Examples of their efforts include the annual fireworks display and the Maumee Uptown Summer Fair.

# Year in review

## LUCAS COUNTY OVI TASK FORCE

The City of Maumee received \$10,879.95 of federal grant funding for MPD's participation in the Lucas County OVITF during 2014. The grant includes repayment of direct labor costs, fringe benefits, and transportation/fuel costs. Officers worked 192 hours of traffic enforcement, making 283 traffic stops and issuing 172 court citations.

MPD facilitated an OVI Checkpoint on Friday August 22, 2014. The event was held on US 24 at Country Blvd. The event was staffed by members of the Maumee Police Division and the Lucas County Sheriff's Department. A total of 817 vehicles traveled thru the checkpoint and 571 of those vehicles were checked by officers. Twenty-two vehicles were diverted for further investigation. Arrests/citations include: 1 OVI arrest, 5 warrant arrests, 2 suspended operators licenses, 1 driving without a valid operator's license, 2 child safety restraint, and 1 expired license plate.

## MPD OVI ARRESTS

The Police Division made 119 arrests during 2014. One hundred nine of the arrests involved suspects who are 21 years of age or older. Eight arrests were for suspects between 18 and 21 years of age. Three juveniles were arrested. Males comprised 92 arrests (77%) while 27 females (23%) were arrested. Sixty-one arrestees (51%) refused the requested breath / blood test while 58 arrestees (49%) submitted to the chemical tests. Ninety-three (78%) of the arrests involved traffic stops while 26 arrests (22%) involved traffic crashes.

# Accidents

The number of accidents at the most hazardous intersection increased from 25 in 2013 to 41 in 2014. The total number of accidents in the 10 most hazardous intersections also increased, from 173 in 2013, to 222 in 2014. There are ties for second, fifth and seventh place.

Two intersections dropped from the list this year: the Anthony Wayne Trail & Michigan and Arrowhead and W Dussel

There were two fatal accidents for 2014 that led to three deaths.



# Crime Prevention

## CRIME PREVENTION SPECIALIST

The Maumee Police Division maintains two officers certified as Crime Prevention Specialists. These officers maintain their certification by attending continuing education classes. In the beginning of 2014, a third officer also became certified.

## THE "ARE YOU OK?" PROGRAM

For twenty-five years the Maumee Police Division has operated the "Are You O.K.?" program. Known as R.U.O.K., the program continues to check the safety of our senior citizens as well as our hotel night clerks and gas station attendants. Each participant receives a daily or nightly call checking on his or her safety. A police crew is sent to check their safety if there is no answer.

The program has helped many residents since its inception. The program then expanded to check the safety of 24-hour gas station employees and hotel desk clerks. The program currently has twelve individual subscribers, along with ten hotels and four gas stations.



# Crime Prevention

## CHILD SAFETY SEAT CHECKS

The Maumee Police Division has two officers that are certified technicians in child passenger restraints. They are certified through Safe Kids Coalition, Child Passenger Safety Training Program. This training enables the Maumee Police Division to provide our community with highly trained experts in the proper installation and implementation of child car seats.

In 2014, twenty child safety seat checks were performed for citizens working or living within the City of Maumee.

## SEATBELT SAFETY

The Crime Prevention Officer taught the Third Grade Safety Belt Program to all third-grade students in the Maumee School District. Two hundred two students received practical training in the Ohio Department of Public Safety education program. The program encompassed the proper use of seat belts, statistics about accidents/seatbelt usage, and information on air bags. Each child received material and information to share with their family members. As part of the program, each student was deputized as Seat Belt Deputies as they pledged to wear their seatbelt.

## SAFETY CITY

The City of Maumee Safety City program celebrated its 35th year in 2014. Seventy-six children participated in the summer program to help prepare four and five year olds to safely attend Kindergarten. Safety City consisted of classroom instruction, crafts, songs, and practical exercises in vehicle and pedestrian safety. Lessons were conducted on our miniature Safety City equipped with streets, crosswalks, traffic signals, railroad tracks, and faux buildings. Safety City consisted of 2 sessions per day over a two week period in June. The sessions lasted 2-1/2 hours each day.

The staff included two Maumee Police Officers, two teachers, and 16 high school and middle school student volunteers. Safety City is located at Wayne Trail Elementary School.

The Maumee Police Division and Maumee Board of Education sponsor Safety City. McDonald's (Conant Street) and the Maumee Municipal Court support the program through donated products and services. St. Luke's Hospital provides each graduate of Maumee Safety City with a bicycle safety helmet.

## THE D.A.R.E. PROGRAM

The DARE program provides the students with the tools necessary to make the right decisions when it comes to alcohol, tobacco, other drugs, and violence. It is taught at Wayne Trail Elementary School, Gateway Middle School, and St. Joseph's Maumee School. The DARE program was taught to three-hundred and seventy-five students in the fifth and seventh grades this year. The fifth grade program culminated with two separate graduation ceremonies. The first graduation took place at Wayne Trail Elementary School and the second at St. Joseph's School in Maumee.

The Maumee DARE officer also had a booth at the Maumee Uptown Fair. Many of the area DARE students attended this event along with DARE night at Ohio Skate, which provided an opportunity to reinforce the DARE drug-free choice.

Charlie's Dodge continues to provide the Maumee DARE program with a donated vehicle with graphics.

The Maumee Police Division received a grant for the 2013-2014 school year from the Ohio Attorney General's Office. The awarded amount of \$20,193.08 helps to defer the cost of teaching the DARE program in the Maumee school system.

## BIKE SAFETY

Bike safety/education is an important part of the Maumee crime prevention program. A bike rodeo was held in June at Fairfield Park. Pending weather reduced the attendance to thirty-three children who participated in the rodeo free of charge. Maumee Police Division Bike Officers, Citizen Police Academy Volunteers, Safe Kids volunteers, as well as volunteers from TAB (Toledo Area bicyclists) assisted the crime prevention staff by inspecting each bike, conducting safety checks and making repair recommendations. Cyclists participated in an agility course to test their skills.

Those who attended received a safety packet and bicycle helmets were given away free of charge to any cyclist who needed a helmet.

The Maumee Police Division participated in the Maumee Municipal Court's Bike Helmet Reward Program. The Maumee Court, under the leadership of Judge Gary Byers, supplied area police officers with coupons. When the officers observe children wearing bike helmets, they provided them with the coupon good for a free ice cream cone. These coupons have helped to increase the use of bike helmets by cyclists, skateboarders, and even those on rollerblades.

The Maumee Police Division continues to provide bike licenses free of charge. A licensed bike enables an owner to be identified and the bike returned when found or recovered.

We continue to be a host site for the Northwest Ohio Bomb Squad and storage site for their equipment.

The Division added one new Firearms Instructor and one new TASER instructor to our staff.

Our Police Chief attended the prestigious FBI National Academy 3-month long intensive training at Quantico, Virginia.

The Division hosted a regional training class on Advanced Roadside Impaired Driver Enforcement (ARIDE).

Every Division employee went through Ohio Ethics Law training.

# Investigations

## MAJOR INVESTIGATIONS

### Drugs

In July, an undercover investigation initiated by the Detective Bureau resulted in the arrest of a male for felony Drug Trafficking. A search warrant was executed at the male's residence, located near a school in the City, subsequent to the arrest. As a result of the investigation, approximately 7.7 grams of marijuana, \$745.00 in cash, and drug paraphernalia were seized. Additionally, a laptop computer belonging to Maumee City Schools was recovered and returned. This case is currently pending in court.

In August, the Detective Bureau responded to a Residential Burglary in the City. Investigation at the scene revealed evidence of a possible drug trafficking operation. A search warrant was obtained for the residence and subsequently executed. As a result of the investigation, approximately 253 grams of marijuana, 110 grams of cathinone (bath salts), \$37,900.00 in cash, and drug paraphernalia were seized. A male was charged with felony Drug Possession and Trafficking, and the case is currently pending in court.

### Sex Crime

In October, the Detective Bureau, in conjunction with the Northwest Ohio Violent Crimes Against Children Task Force, conducted a prostitution sting at a local motel. As a result, \$259.25 in cash was seized and two females were successfully charged and prosecuted for Prostitution. Additionally, information gathered as a result of the operation was instrumental to a federal human trafficking case being investigated by the FBI in Chicago, Illinois.

# Investigations

## Rape

There were 3 reported cases of Rape investigated by the Detective Bureau. In all three cases, suspects were identified. Two cases were closed because the victim refused to cooperate further with the investigation. The other case was closed due to insufficient evidence to prosecute.

## Sexual Assault

Two cases of Sexual Assault were assigned for investigation by the Detective Bureau. In one case, a suspect was identified; however, it was closed because of insufficient evidence to prosecute. The other case was determined to be unfounded.

## Missing Persons

Two Missing Persons cases were assigned for investigation by the Detective Bureau. Both of these cases were cleared, as the subjects were located.

## Robbery

In September, a local business was robbed by a male with a handgun, and the lone female employee was tied up with duct tape. The robber got away with approximately \$250.00 in cash. Statements were obtained, and evidence collected at the scene by the on-call Detective was submitted to BCI. Subsequent investigation by the assigned Detective, combined with a DNA hit on a piece of submitted evidence, resulted in the identification and arrest of a male suspect. The male suspect is currently incarcerated in the Lucas County Jail awaiting trial.

Three other cases of Robbery were assigned for investigation by the Detective Bureau. In one case, the suspect was known to the victim; however, he refused to cooperate with the investigation and it was closed. Another case was closed after all investigative leads failed to identify a suspect. In the third case, a suspect was identified by Maumee Detectives through the investigative process, including victim/witness interviews and evidence collection/preservation at the scene, and charged.



# Investigations

## **Residential Burglary**

Thirteen Residential Burglary cases were assigned for investigation by the Detective Bureau. Two cases were cleared by arrest and 2 cases were determined to be unfounded. The remaining 9 cases were closed after all investigative leads had been exhausted.

## **Breaking and Entering**

Six Breaking and Entering cases were assigned for investigation by the Detective Bureau. One case was closed due to lack of investigative leads, and the remaining 5 cases were closed after all investigative leads had been exhausted.

## **Theft**

One hundred eighty-two Theft cases were assigned for investigation by the Detective Bureau. Of these, 88 cases were cleared. Sixteen cases are under investigation. The remaining 78 cases were closed due to lack or exhaustion of investigative leads.



# Investigations

## **Theft from Auto**

Fifty-three Theft from Auto cases were assigned for investigation by the Detective Bureau. Eight of these cases were cleared. One case is under investigation. The remaining 44 cases were closed due to lack or exhaustion of investigative leads.

## **Shoplifting**

Forty Shoplifting cases were assigned for investigation by the Detective Bureau. Thirty-two of these were cleared. One case is under investigation. The remaining 7 cases were closed due to lack or exhaustion of investigative leads.

## **Summary**

In 2014, due to a promotion, training, and extended leave, the Detective Bureau operated below full staff for most of the year. Despite staffing issues, illegal drugs, with a street value in excess of \$2,700.00, and over \$38,900.00 in cash were seized as a result of Detective Bureau investigations. For the year, the Detective Bureau had 424 cases assigned for investigation. Of those, 29 remain under investigation. Of the remaining 395 closed cases, 219 were cleared (55%) and 176 were closed due to lack or exhaustion of investigative leads (45%). An overwhelming majority of the cases investigated by the Detective Bureau were theft related (75%).



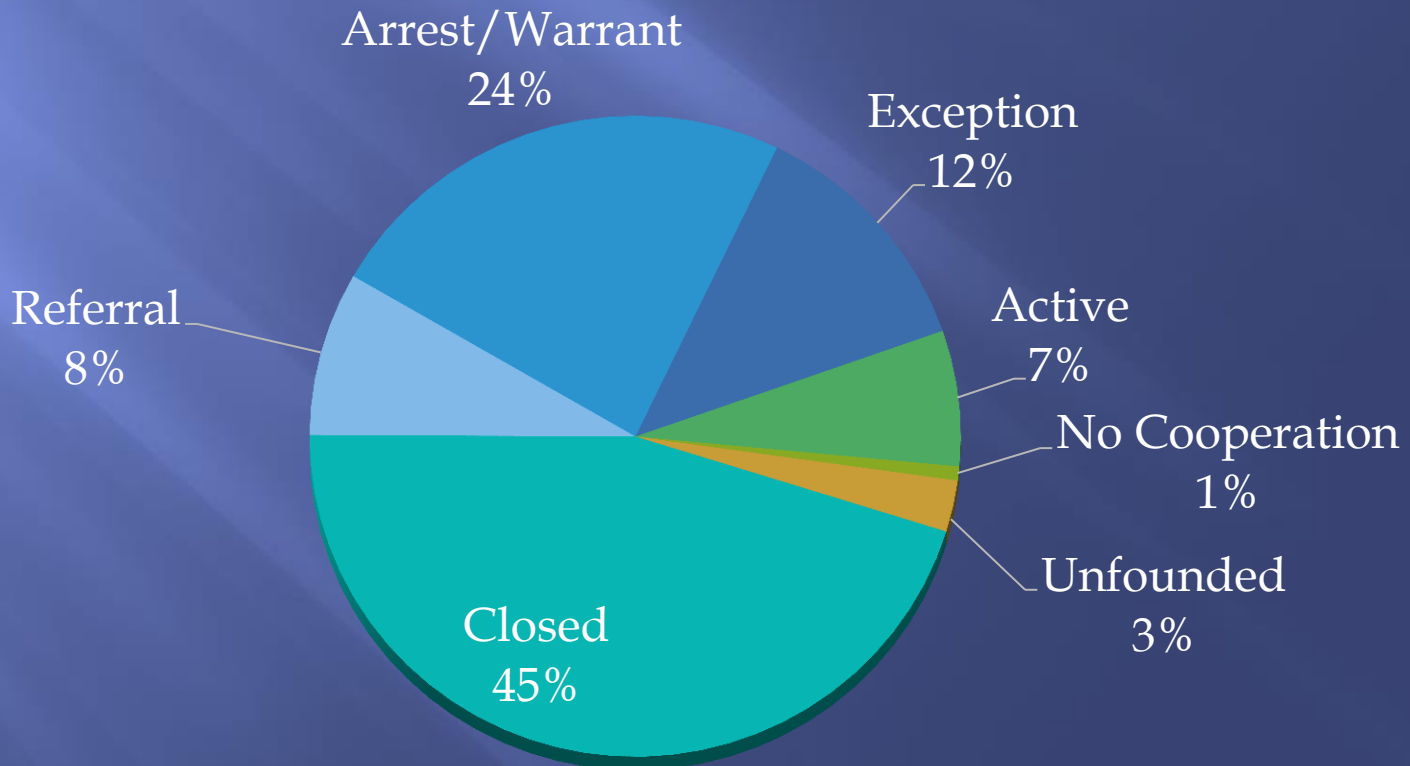

# Crime Prevention

This was the thirteenth year for the School Resource Officer (SRO) Program in the City of Maumee. Officer Paul LaPlante worked as the primary SRO for Maumee High School and assisted SRO Derek Sanderson at Gateway Middle School.

SRO LaPlante wrote 19 incident reports with 15 arrests during the 2014 school year. Officer LaPlante also received investigations from the road patrol and detective bureau for possible follow-up and all incidents that involved Maumee students were included in this summary.

# Crime Prevention

SRO LaPlante attends the majority of the disciplinary meetings at the Maumee High School. This provides insight and behavioral recommendations at the discretion of the school administrators. The SRO also meets with school administrators, counselors, the In-School Reassignment (ISR) Supervisor, and students on a daily basis. SRO LaPlante has also assisted on several suspension hearings at the Maumee Board of Education.

During the 2014 school year A.L.I.C.E. drills were performed at the Maumee High School with teachers and staff. A total of three A.L.I.C.E. drills with building evacuations, one unauthorized intruder drill, and one working lockdown were completed.



# Crime Prevention

The school resource officer attended disciplinary meetings, suspension hearings and parent meetings at the Maumee High School and Gateway Middle School. This participation was a valuable contribution in developing behavioral recommendations to the school administrators. The SRO also met with school administrators, counselors, the In-School Reassignment (ISR) Supervisors, and students on a daily basis.

During the 2013 season at the start of the school year A.L.I.C.E (alert, lockdown, inform, counter, evaluate) drills were performed at the Maumee High School with teachers and staff. These drills were the final product of the training Maumee City School staff received in the previous year.

Chief Macdonald implemented the use of the SRO to enforce truancy policy within the district. This new function now allows the SRO to work with school administration to assist in getting students back to school or finding alternate learning settings for them.



# Crime Prevention

SRO LaPlante has been able to assist elementary school principals in situations ranging from consultations with students, safety/security issues, and investigations of criminal complaints, parking complaints, and parent complaints.

The SRO has become an important resource for school administration, staff, and the students of the district. The visibility created by the SRO and the positive interaction with the staff and students of the district has continued to create a positive image of the Maumee Police Department. The SRO position has also continued to be a great tool in gathering information about criminal activity within the City of Maumee.

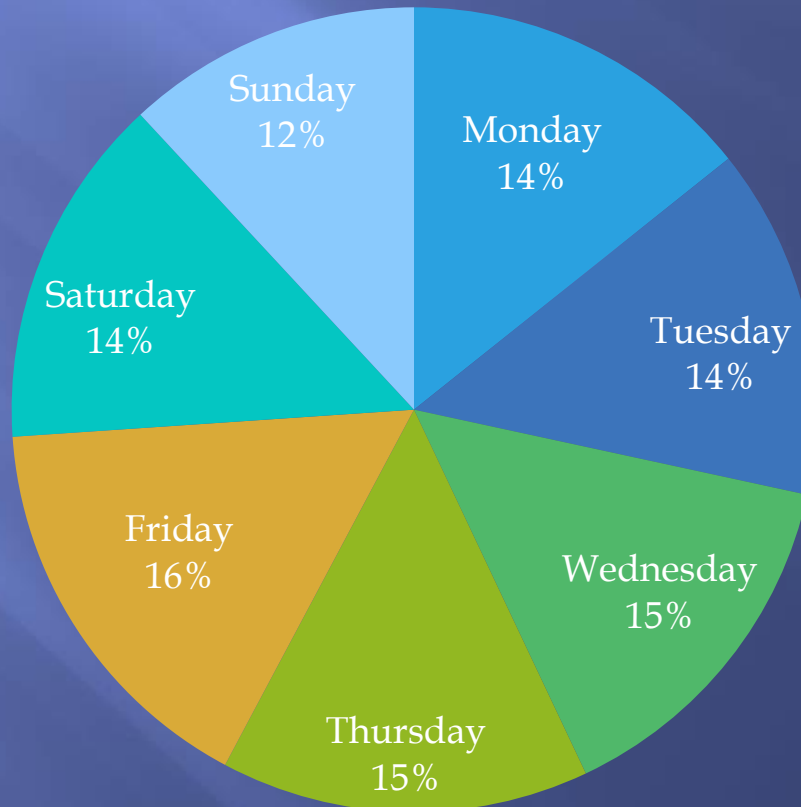

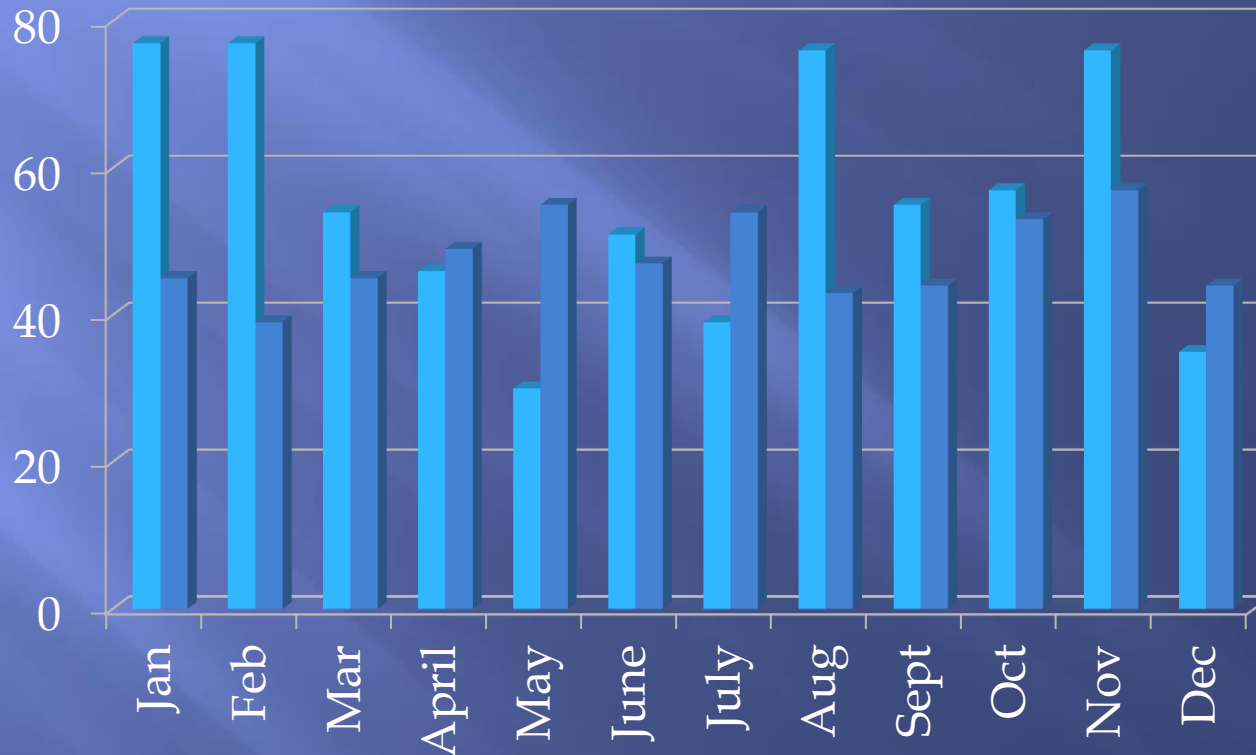

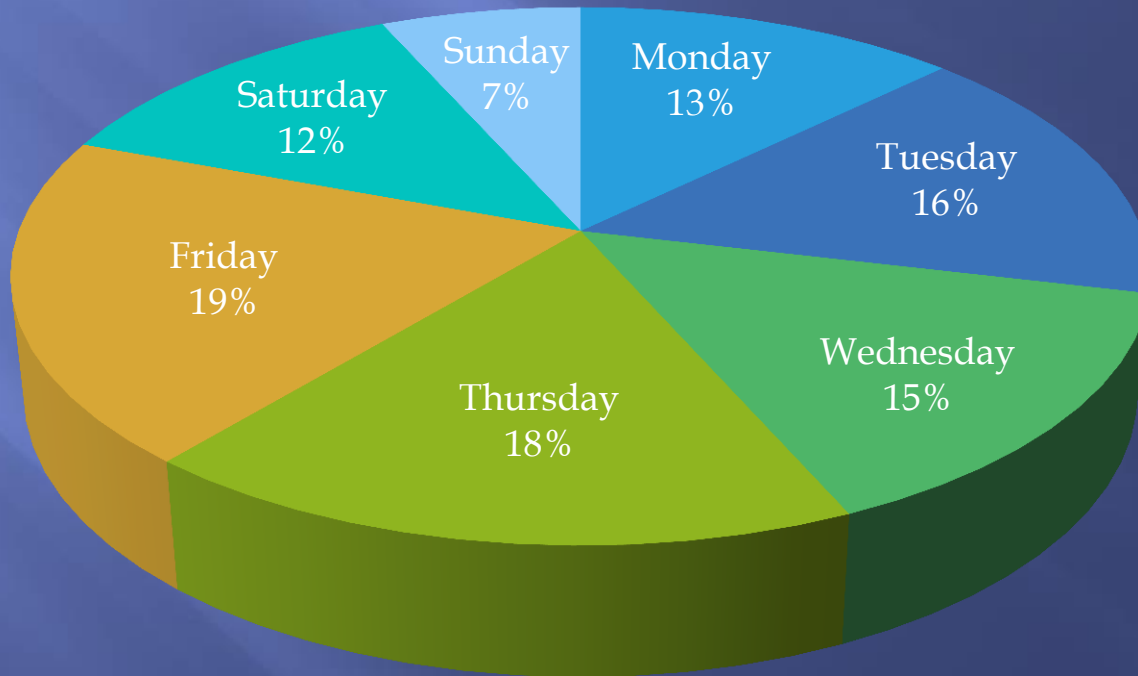

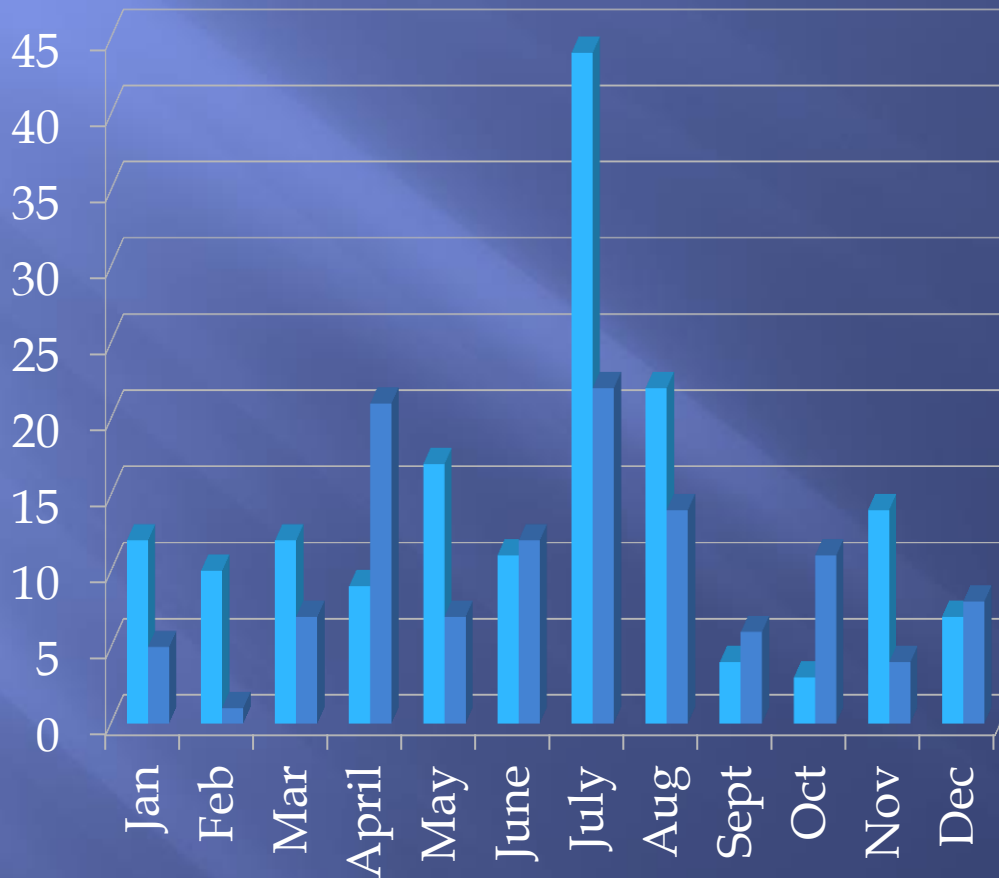

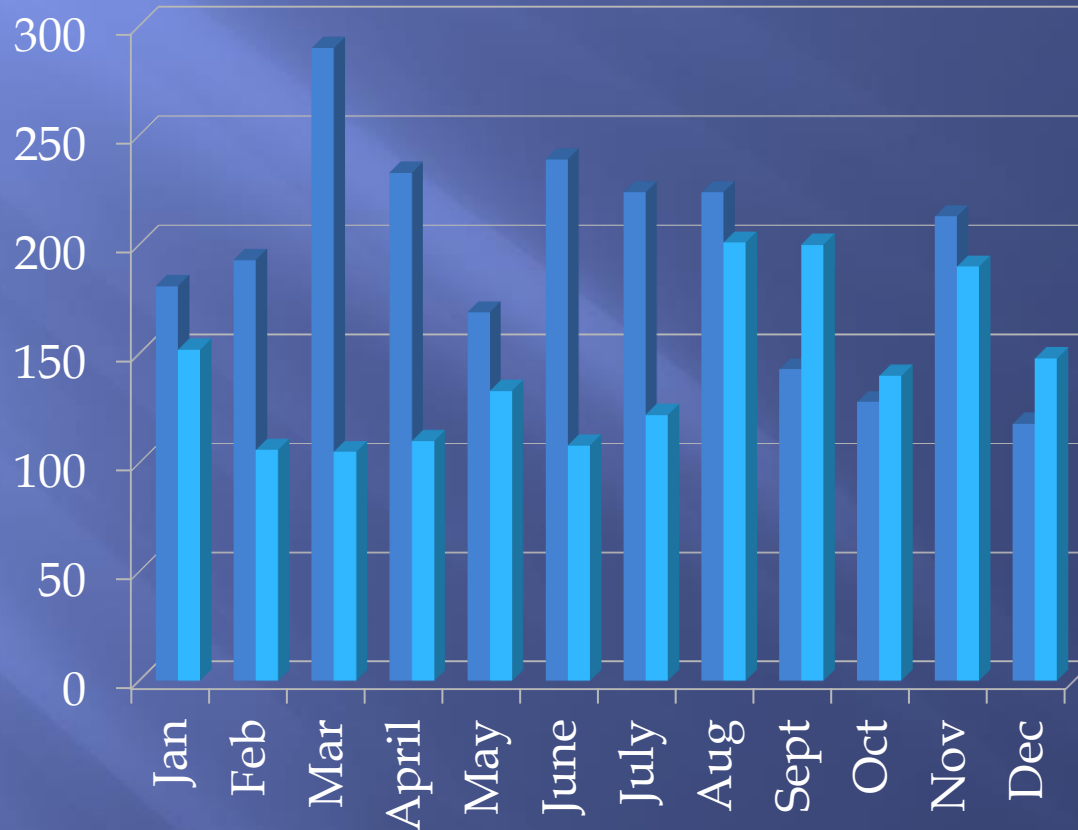

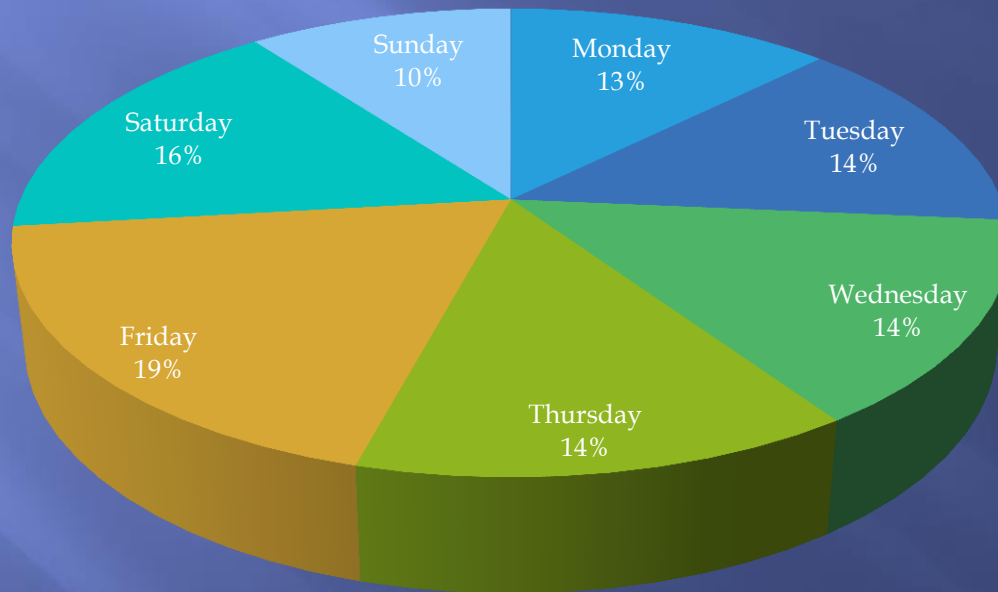

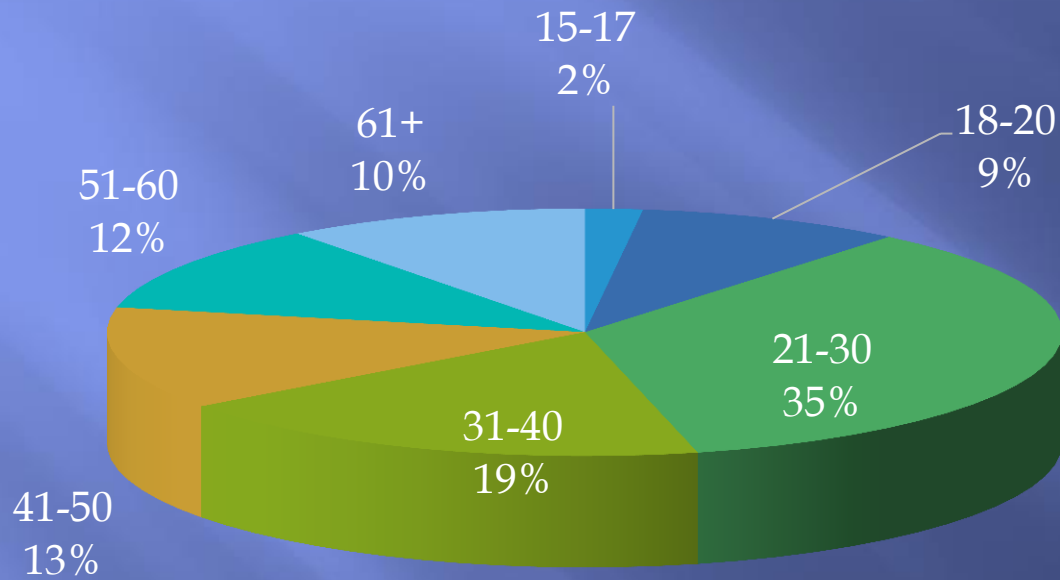

2355 Citations by Day of Week



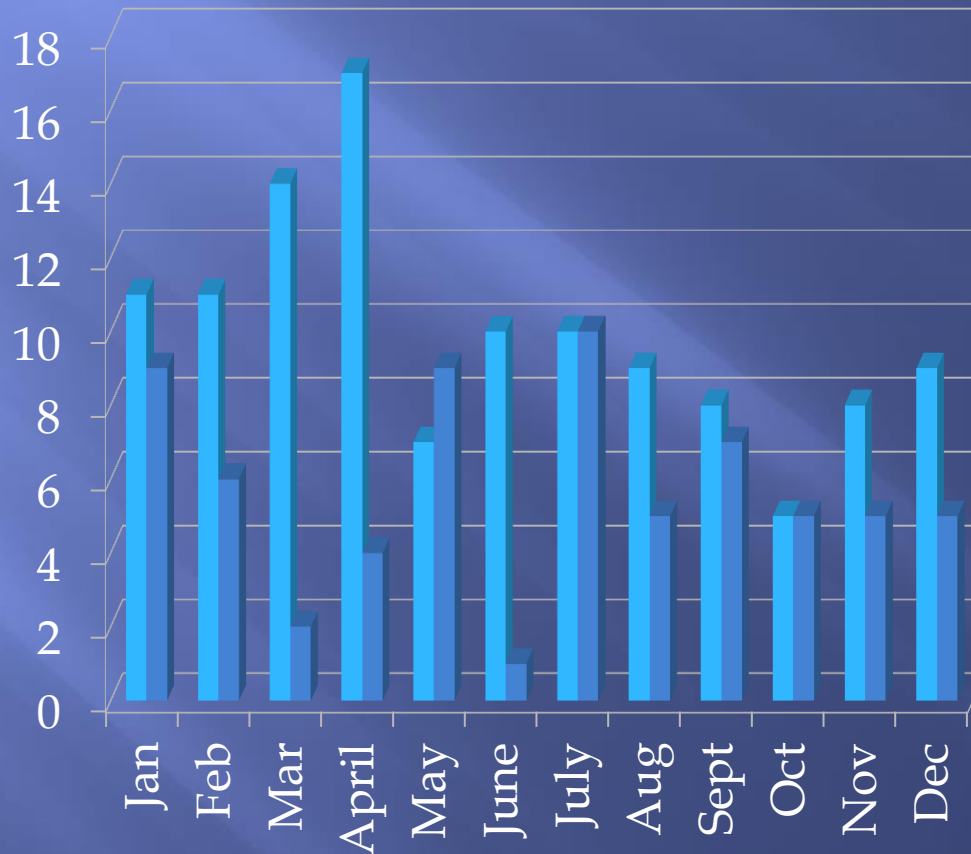

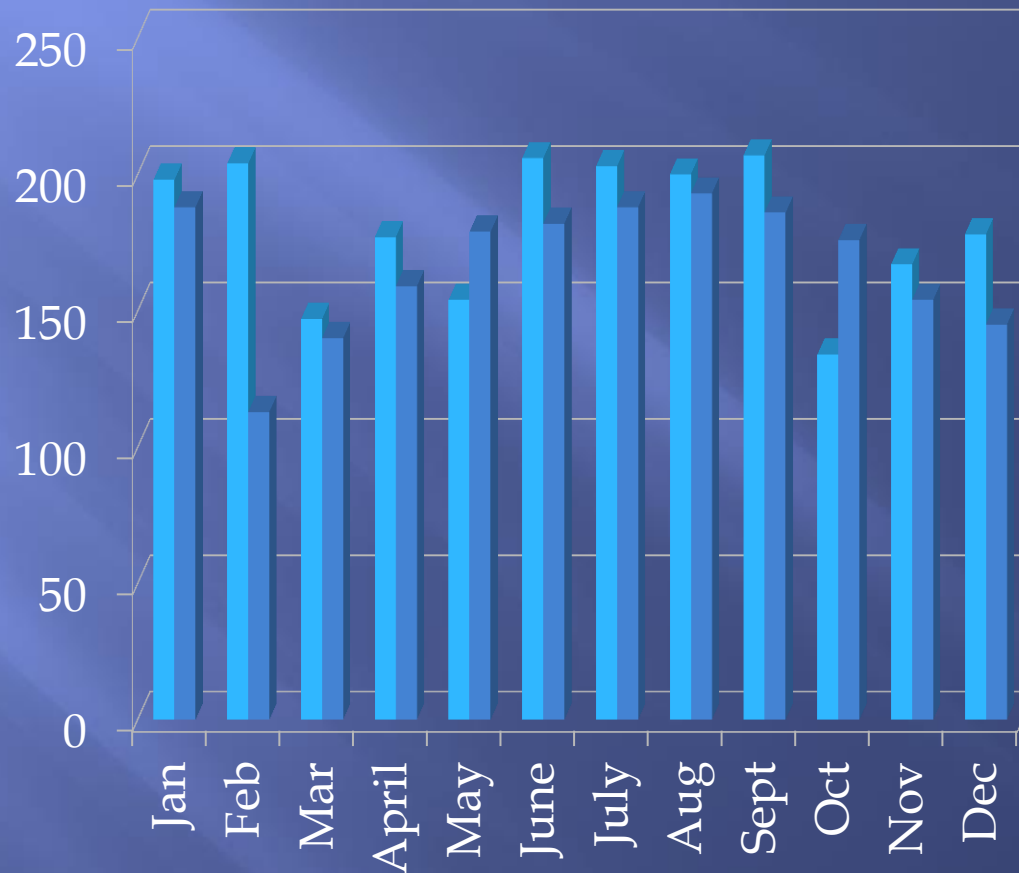

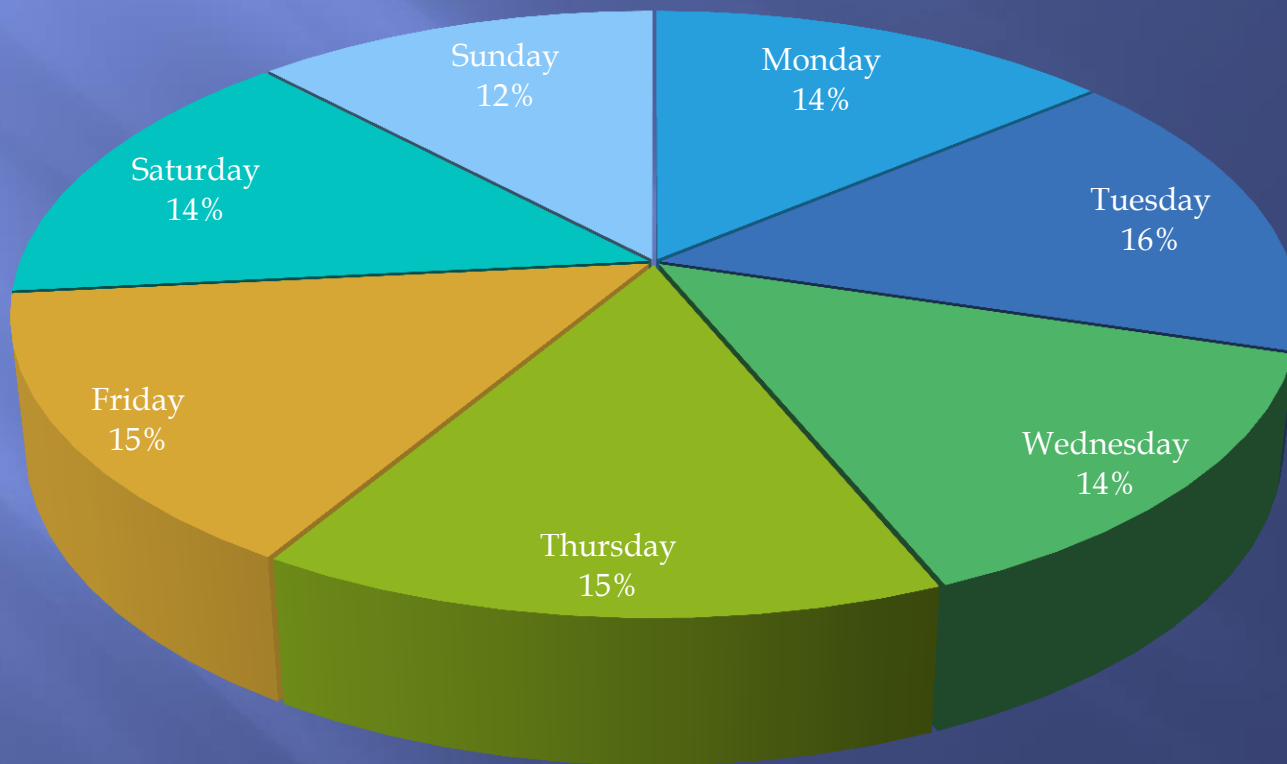

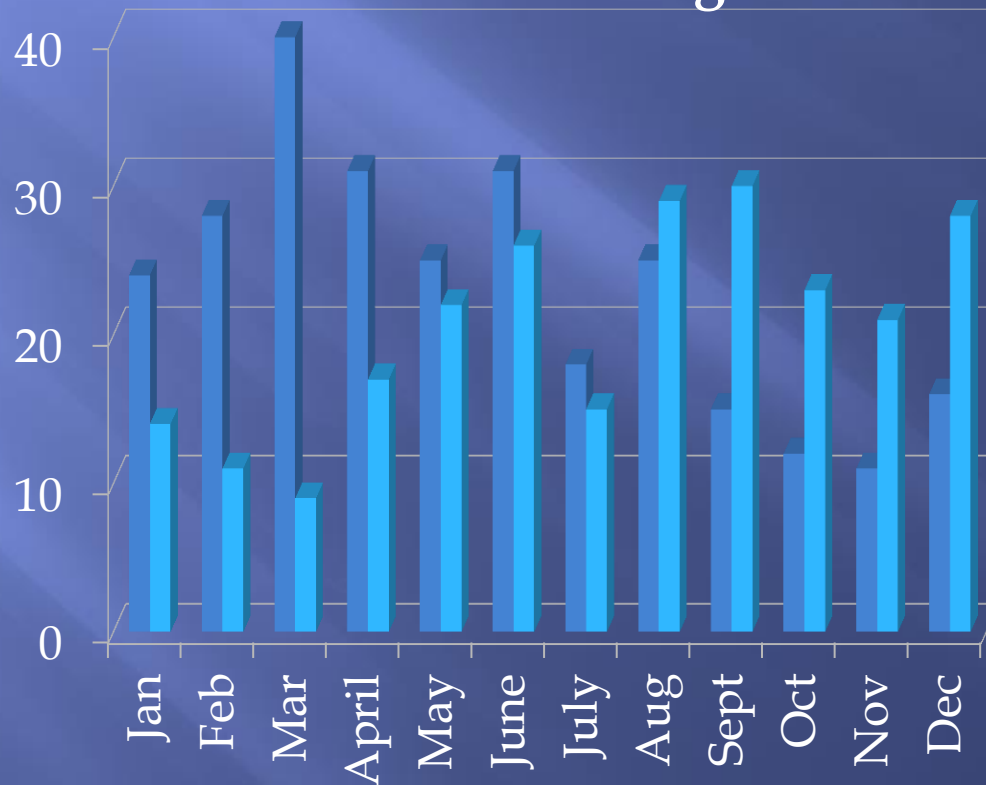
## 2175 Offense Reports by Day of Week

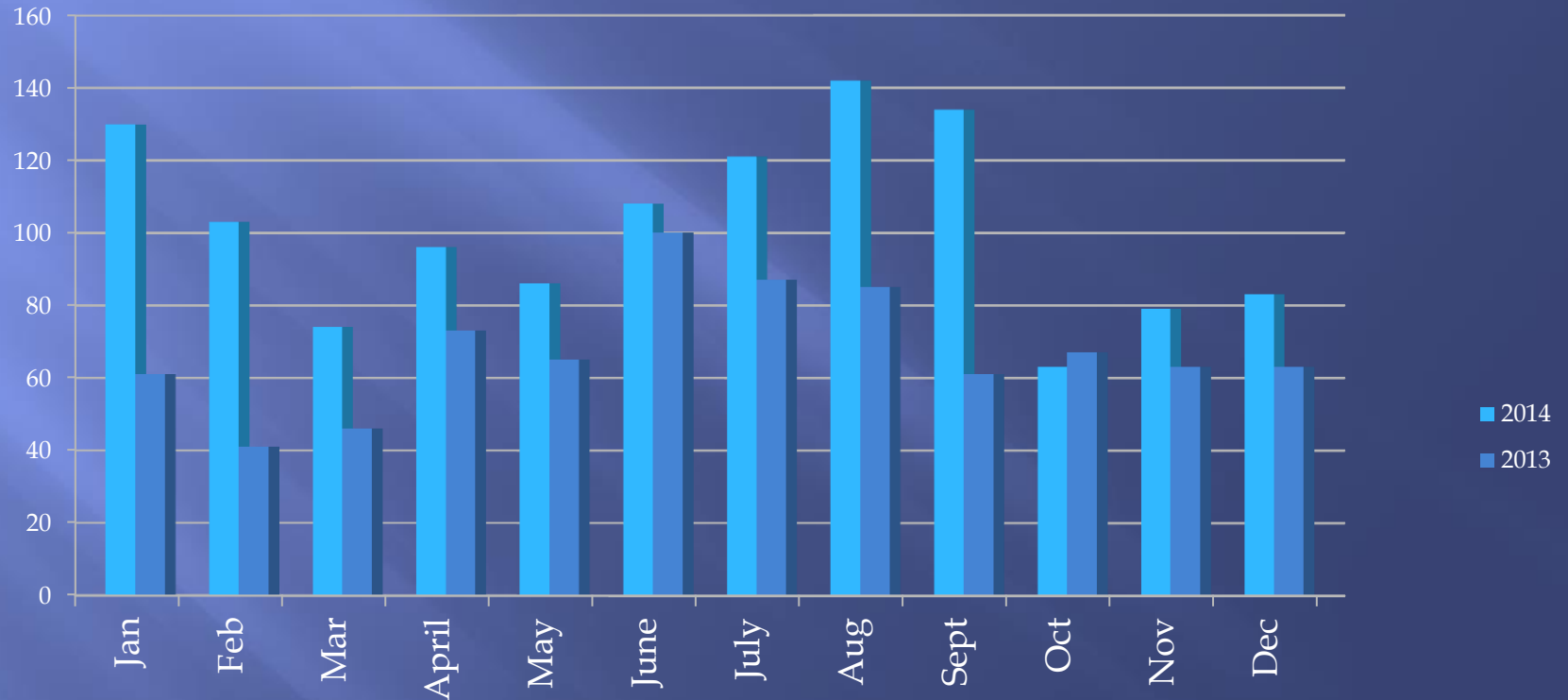

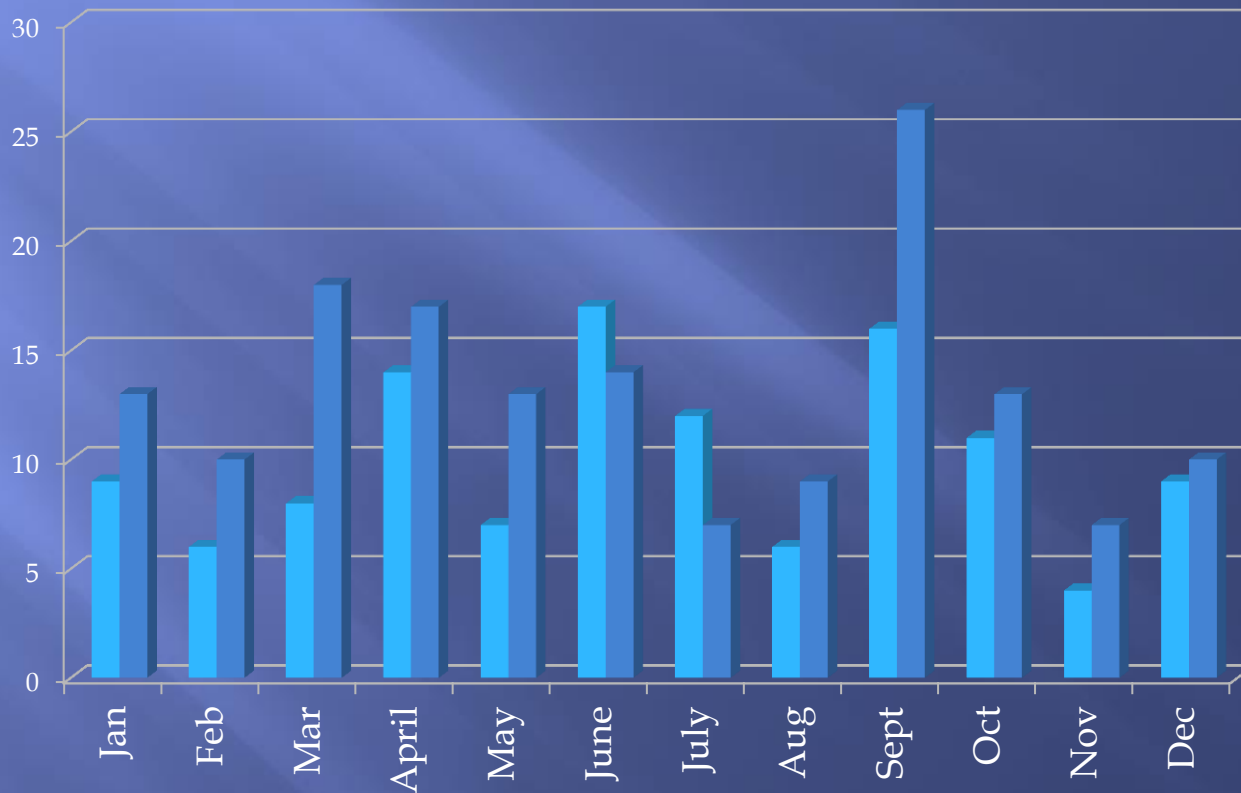

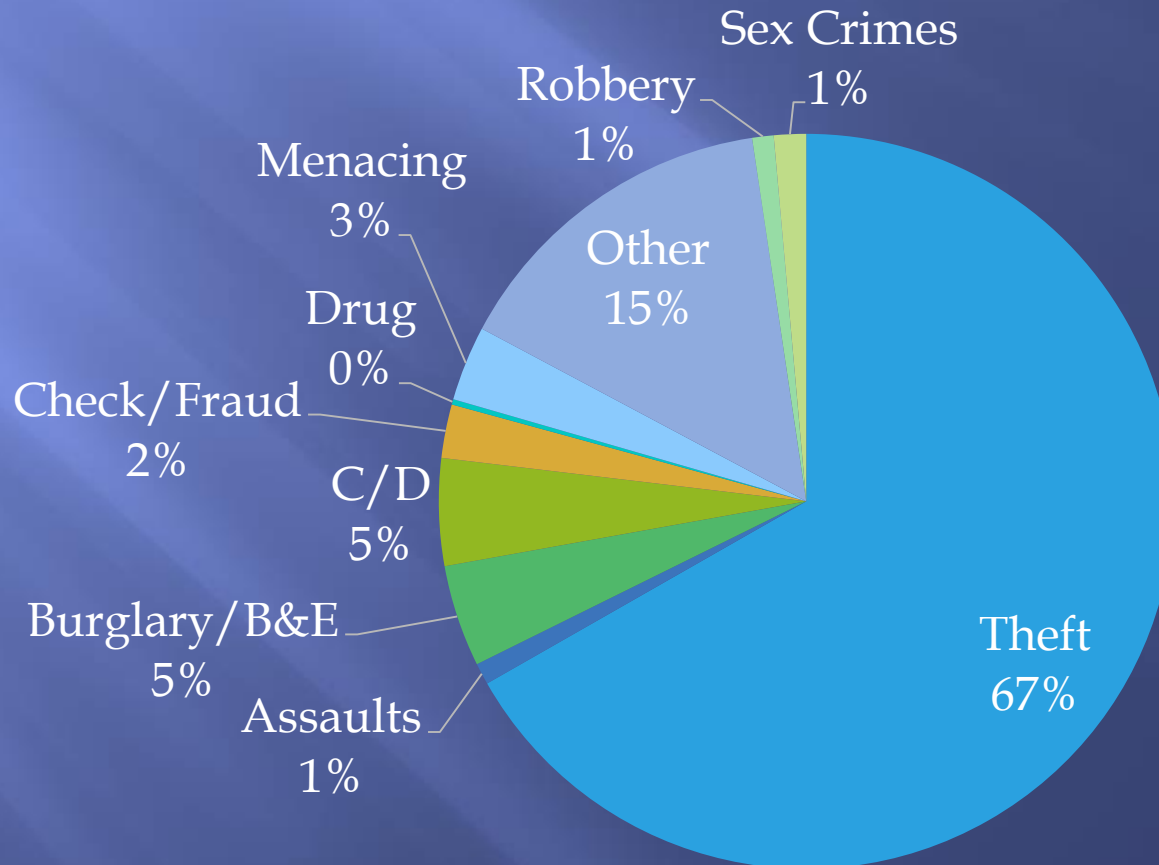
