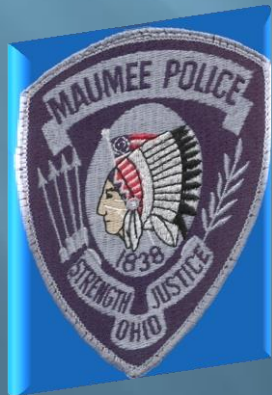

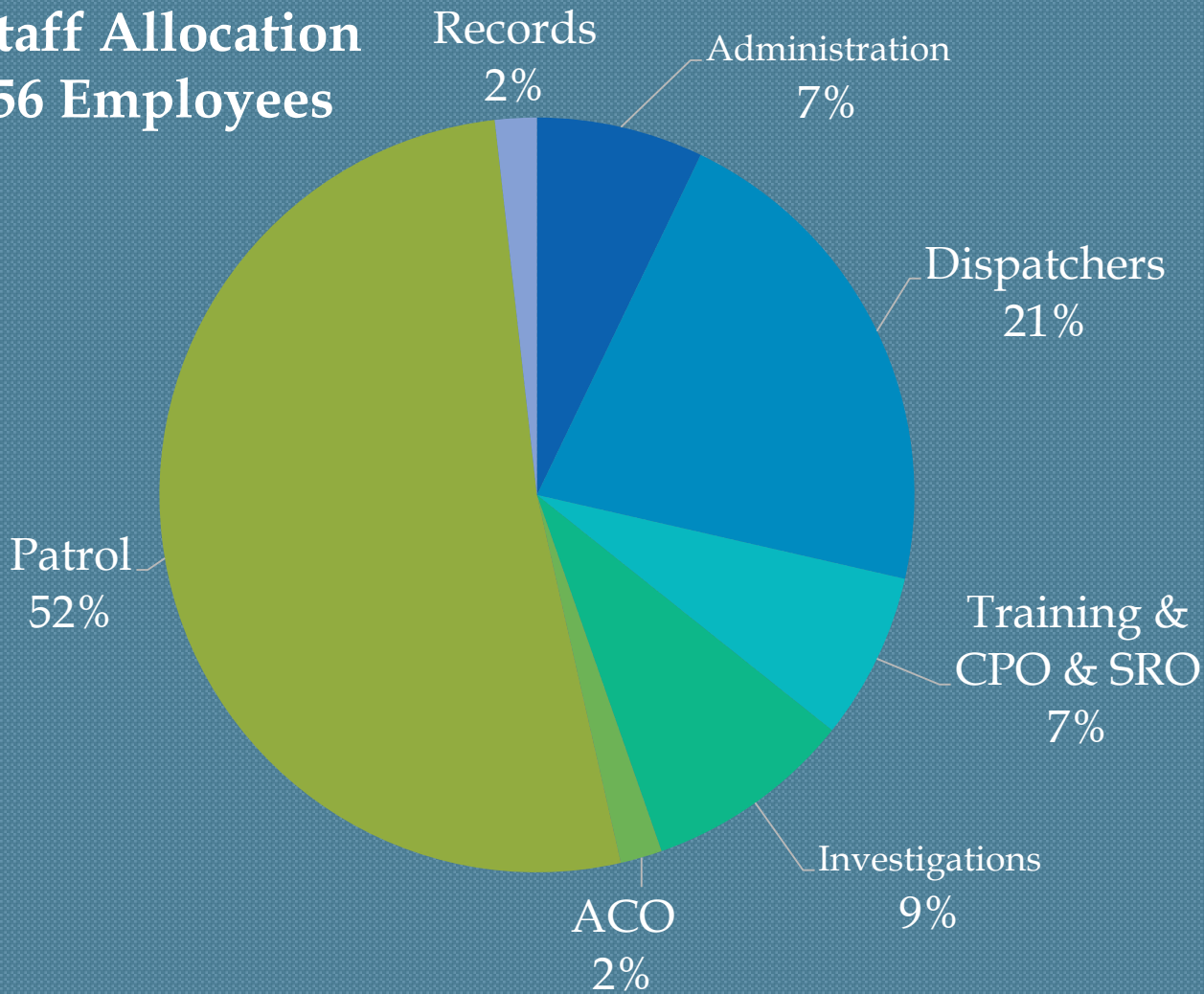

# Year in review

## STAFFING

Officer York was promoted to sergeant in March 2015. Officer York was a field training officer for new recruits, served as a bike officer, and is a member of the special response unit. He also serves as an instructor in use of force, defensive tactics, Taser and first aid. He served eighteen (18) years as a Patrolman prior to his promotion to Sergeant.

A patrolman, a sergeant and a dispatcher retired. Two (2) patrol officers and two (2) dispatchers were hired. All new employees completed field training.



# Year in review

## SCHOOL RESOURCE OFFICER

The Maumee Police Division re-assigned a new school resource officer to the Maumee High School. Maumee Police continue to staff a school resource officer at Maumee High School and Gateway Middle School.

## DISPATCH OPERATIONS

The City of Ottawa Hills consolidated their dispatch operations with Maumee Police. Maumee dispatchers now provide police dispatch services and enter calls for service for the Ottawa Hills Police Division.





# Year in review

## BUSINESS VISITS

The Maumee Police Chief along with the Maumee Fire Chief and Safety Director made weekly community visits to citywide area business's, companies and corporations. It was valuable to foster relationships and build networking with the Maumee business community.

## DRUG FORUM

The police division helped coordinate and participated in the first ever city sponsored drug forum at the Maumee Indoor Theater. The event was a great success and well attended by Maumee families. Presentations concentrated on the most common drugs the police are seeing today along with prevention and treatment recommendations. The panel included the police chief, police crime prevention/school resource personnel, St Lukes Hospital community outreach staff, an emergency physician, Maumee school administration personnel and the Maumee Mayor

## CITIZEN POLICE ACADEMY

The Police Division continues to support our Citizen Police Academy volunteers. Citizen Police Academy graduates contributed 150 hours of volunteer time to various police supported functions. Examples of their efforts include the annual fireworks display and the Maumee Uptown Summer Fair.

# Year in review

## LUCAS COUNTY OVI TASK FORCE

The City of Maumee received \$10,516 of federal grant funding for MPD's participation in the Lucas County OVI Task Force during 2015. The grant included reimbursement of direct labor costs, fringe benefits and transportation/fuel cost. Officers worked one hundred eighty (180) hours of selective traffic enforcement, initiating two hundred thirty two (232) traffic stops and issued one hundred fifty (150) court citations.

MPD facilitated an OVI Checkpoint on Friday August 21, 2015. The event was held on US 24 @ Country Blvd. The event was staffed by members of the Maumee Police Division, Oregon PD, University of Toledo PD and Waterville Twp. PD. A total of six hundred eighty (680) vehicles traveled thru the checkpoint. Five hundred sixteen (516) of those vehicles were checked by officers. Fifteen (15) vehicles were diverted for further investigation. Arrests/citations include: two (2) warrant arrests, five (5) suspended operators licenses, two (2) driving without a valid operator's license, two (2) child safety restraint and two (2) expired license plates.



# Year in review

## MPD OVI ARRESTS

The Police Division made ninety (90) OVI arrests in 2015. Eighty-five (85) of the arrested suspects were twenty-one (21) years old or over. Four arrests were for suspects between 18 and 21 years of age. One juvenile was arrested. Males comprised seventy (70) of the ninety (90) arrests (78%). Twenty (20) females (22%) were arrested. Forty (40) arrestees (44%) refused the requested breath and/or blood test and fifty (50) arrestees (56%) submitted to the chemical tests. Seventy-seven (77) or (86%) of the OVI arrested were the result of a traffic stop. Thirteen (13) arrests (14%) involved a traffic crash.

## COLLEGE INTERNSHIPS

The PD facilitated two college student internships. Ms. Jovonne Jones completed a 480 credit hour internship and graduated from Bowling Green State University in May 2015 with a Bachelor of Science degree. Ms. Ashley Jemerson, a UT student completed her 120 credit hour internship in August 2015. Mr. Laith Shehadeh and Mr. Andre Earle, students at St. John's High School completed Senior Projects with MPD by completing 40 Hr. internships.

# Accidents

The number of accidents at the most hazardous intersection increased from 41 in 2014 to 42 in 2015. The total number of accidents in the 10 most hazardous intersections also increased, from 222 in 2014, to 227 in 2015. There is a tie for sixth and seventh place.

One intersections dropped from the list this year: the Anthony Wayne Trail and S Detroit.

There was one fatal accident for 2015 that led to two deaths.

# Crime Prevention

## CRIME PREVENTION SPECIALIST

The Maumee Police Division maintains three officers certified as Crime Prevention Specialists. These officers maintain their certification by attending continuing education classes.

## THE "ARE YOU OK?" PROGRAM

For twenty-six years, the Maumee Police Division has operated the "Are You O.K.?" program. Known as R.U.O.K., the program continues to check the safety of our senior citizens as well as our hotel night clerks and gas station attendants. Each participant receives a daily or nightly call checking on his or her safety. A police crew is sent to check their safety if there is no answer.

The program has helped many residents since its inception. The program then expanded to check the safety of 24-hour gas station employees and hotel desk clerks. The program currently has ten individual subscribers, along with ten hotels and four gas stations.



# Crime Prevention

## CHILD SAFETY SEAT CHECKS

The Maumee Police Division has two officers that are certified technicians in child passenger restraints. They are certified through Safe Kids Coalition, Child Passenger Safety Training Program. This training enables the Maumee Police Division to provide our community with highly trained experts in the proper installation and implementation of child car seats.

In 2015, thirty-three child safety seat checks were performed for citizens working or living within the City of Maumee.

## SEATBELT SAFETY

The Crime Prevention Officer taught the Third Grade Safety Belt Program to all third-grade students in the Maumee School District. Two hundred and twenty-nine students received practical training in the Ohio Department of Public Safety education program. The program encompassed the proper use of seat belts, statistics about accidents/seatbelt usage, and information on air bags. Each child received material and information to share with their family members. As part of the program, each student was deputized as Seat Belt Deputies as they pledged to wear their seatbelts and even remind their family members.

## SAFETY CITY

The City of Maumee Safety City program celebrated its 36th year in 2015. Seventy-three children participated in the summer program to help prepare four and five year olds to safely attend Kindergarten. Safety City consisted of classroom instruction, crafts, songs, and practical exercises in vehicle and pedestrian safety. Lessons were conducted on our miniature Safety City equipped with streets, crosswalks, traffic signals, railroad tracks, and faux buildings. Safety City consisted of 2 sessions per day over a two week period in June. The sessions lasted 2-1/2 hours each day.

The staff included two Maumee Police Officers, two teachers, and 17 high school and middle school student volunteers. Safety City is located at Wayne Trail Elementary School.

The Maumee Police Division and Maumee Board of Education sponsor Safety City. McDonald's (Conant Street) and the Maumee Municipal Court support the program through donated products and services. St. Luke's Hospital provides each graduate of Maumee Safety City with a bicycle safety helmet.

## THE D.A.R.E. PROGRAM

The DARE program provides the students with the tools necessary to make the right decisions when it comes to alcohol, tobacco, other drugs, and violence. It is taught at Wayne Trail Elementary School, Gateway Middle School, and St. Joseph's Maumee School. The DARE program was taught to three-hundred and forty-seven students in the fifth and seventh grades this year.

The fifth grade program culminated with two separate graduation ceremonies. The first DARE graduation took place at the Maumee High School Performing Arts Center with the fifth-grade students of Wayne Trail Elementary. The second event occurred at St. Joseph's School Maumee.

The Maumee DARE officer also had a booth at the Maumee Uptown Fair. Many of the area DARE students attended this event along with DARE night at Ohio Skate, which provided an opportunity to reinforce the DARE drug-free choice.

Charlie's Dodge continues to kindly provide the Maumee DARE program with a donated vehicle with graphics.

The Maumee Police Division received a grant for the 2014-2015 school year from the Ohio Attorney General's Office. The awarded amount of \$18,782.00 helps to defer the cost of teaching the DARE program in the Maumee school system.

## BIKE SAFETY

Bike safety/education is an important part of the Maumee crime prevention program. A bike rodeo was held at Fairfield Park in May 2015. One hundred and six children participated in the rodeo free of charge. Maumee Police Division Bike Officers, Citizen Police Academy Volunteers, Safe Kids volunteers, as well as volunteers from TAB (Toledo Area bicyclists) assisted the crime prevention staff by inspecting each bike, conducting safety checks and making repair recommendations. Cyclists participated in an agility course to test their skills.

Those who attended received a safety packet and bicycle helmets were given away free of charge to any cyclist who needed a helmet.

The Maumee Police Division participated in the Maumee Municipal Court's Bike Helmet Reward Program. The Maumee Court, under the leadership of Judge Gary Byers, supplied area police officers with coupons. When the officers observed children wearing bike helmets, they provided them with the coupon good for a free ice cream cone. These coupons have helped to increase the use of bike helmets by cyclists, skateboarders, and even those on rollerblades.

**The Maumee Police Division continues to provide bike licenses free of charge. A licensed bike enables an owner to be identified and the bike returned when found or recovered**

# Training

## Overview

The Police Division continued the tradition of training our officers to be the very best in the area.

- 1) 2015 saw a 20% increase in the total number of training hours officers received over last year's numbers.
- 2) We hired 2 new Patrol Officers, each went through an extensive 20-week Field Training Program.
- 3) We also hired and trained 2 Full-Time Dispatchers and 3 Part-Time Dispatchers.
- 4) We trained another officer to be a Field Training Officer.
- 5) The Police Division continues to commit an officer to the Northwest Ohio Bomb Squad, holding monthly training. We also serve as storage site for the team's equipment.
- 6) The Division added another Impact Weapon Instructor to our training staff.
- 7) A new detective went through considerable technical training.
- 8) A new School Resource Officer was trained.
- 9) We continue our commitment to train every officer in Crisis Intervention.
- 10) The entire Patrol staff participated in annual Use Of Force training, Firearms qualifications, and completed State-mandated Continuing Professional Training requirements.
- 11) To combat heroin overdoses, each officer received training on the administration of Narcan.

# Investigations

## MAJOR INVESTIGATIONS

### Drugs

In June, Detectives responded to a residence in the City of Maumee, after Maumee Fire personnel discovered an indoor marijuana grow while extinguishing a dryer fire. Investigation by Detectives resulted in the seizure of 388.6 grams of marijuana, with an estimated street value of \$3,100.00, as well as numerous items associated with the cultivation of marijuana. The male resident was successfully charged and prosecuted.

In June, Detectives executed a search warrant at a townhouse in the City of Maumee, following a drug investigation. As a result, \$517.00 in cash and .83 grams of powder cocaine was seized. A male and female were charged, and the case is currently pending in court.

In July, Detectives responded to a residence in the City of Maumee, after receiving a tip about an indoor marijuana grow. Investigation by Detectives resulted in the seizure of 727.85 grams of marijuana, with an estimated street value of \$5,800.00, as well as numerous items associated with the cultivation of marijuana. Several residents were successfully charged and prosecuted.

In August, Detectives responded to residence in the City of Maumee, after a tip was received about an outdoor marijuana grow. Investigation by Detectives resulted in the seizure of 887.4 grams of marijuana, with an estimated street value of \$7,000.00. The male resident was successfully charged and prosecuted.



# Investigations

## Sex Crime

In May, 3 cases of Public Indecency were investigated by the Detective Bureau. All 3 cases were related, and a male suspect was identified. The male was successfully charged and prosecuted.

In July, the Detective Bureau, in conjunction with the Northwest Ohio Violent Crimes Against Children Task Force, conducted a prostitution sting at a local motel. As a result, \$160.00 in cash and .37 grams of powder cocaine was seized. Three males were successfully charged and prosecuted.

In September, Detectives conducted a prostitution sting at a local hotel. As a result, two females were successfully charged and prosecuted.

## Rape

There were 4 reported cases of Rape investigated by the Detective Bureau. One case was referred to the Toledo Police Division, after investigation revealed that it had occurred in their jurisdiction. One case was closed due to lack of cooperation from the alleged victim. Two cases were unfounded, with one of the alleged victims being successfully charged and prosecuted for making a false report.

## Sexual Assault

There were 3 Sexual Assault cases investigated by Detectives that were closed due to lack of cooperation by the alleged victims.



# Investigations

## Robbery

In November, a local business was robbed by a male with a handgun. The robber got away with approximately \$1,000.00 in cash. This case is still under investigation, and Detectives have developed several leads, which are being actively pursued.

## Residential Burglary

26 Residential Burglary cases were assigned for investigation by the Detective Bureau. 10 cases were cleared by arrest, 4 cases were closed with no leads, 2 cases were closed due to lack of victim cooperation, and 1 case was determined to be unfounded. The remaining 9 cases were closed after all investigative leads had been exhausted.

## Breaking and Entering

18 Breaking and Entering cases were assigned for investigation by the Detective Bureau. 5 cases were cleared by arrest. 7 cases were closed due to lack of investigative leads, and the remaining 6 cases were closed after all investigative leads had been exhausted.

## Missing Persons

3 Missing Persons cases were assigned for investigation by the Detective Bureau. All of these cases were cleared, as the subjects were located.



# Investigations

## Theft

181 Theft cases were assigned for investigation by the Detective Bureau. Of these, 84 cases were cleared, 63 by arrest. 6 cases are currently under investigation. The remaining 91 cases were closed due to either a lack of investigative leads or exhaustion of investigative leads.

## Fraud

40 Fraud cases were assigned for investigation by the Detective Bureau. Of these, 22 cases were cleared. 5 cases are currently under investigation, and the remaining 13 cases were closed due to either a lack of investigative leads or exhaustion of investigative leads.

## Summary

In 2015, due to training and other concerns, the Detective Bureau operated below full staff for most of the year. Despite staffing issues, investigations by the Detective Bureau resulted in the seizure of illegal drugs, with an estimated street value in excess of \$15,900.00. Additionally, \$617.00 in cash was seized. For the year, the Detective Bureau had 380 cases assigned for investigation. Of those, 13 remain under investigation. Of the remaining 367 closed cases, 228 were cleared (62%) and 139 were closed due to lack or exhaustion of investigative leads (38%). An overwhelming majority of the cases investigated by the Detective Bureau were theft related (70%).





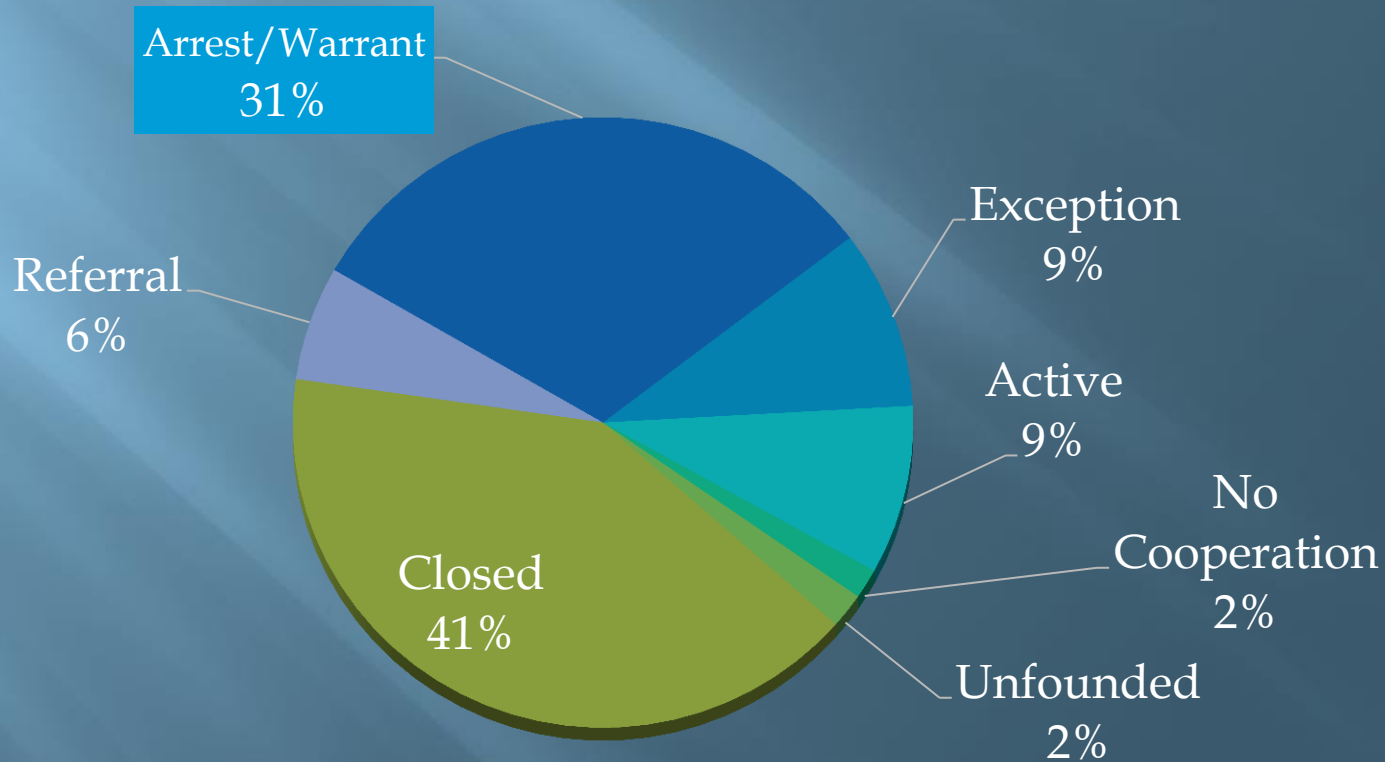

# Crime Prevention

## SCHOOL RESOURCE OFFICER

This was the 14<sup>th</sup> year for the School Resource Officer (SRO) Program in the City of Maumee. Officer Paul LaPlante worked as the primary SRO for Maumee High School for the first half of the year until Officer Scott Russell took over the assignment at the start of the new school year in August. Both Officer LaPlante and Officer Russell assisted SRO Derek Sanderson at Gateway Middle School.

SRO LaPlante wrote (19) incident reports with (15) arrests during 2015. Officer LaPlante also received investigations from the road patrol and detective bureau for possible follow-up and all incidents that involved Maumee students were included in this summary.

SRO Russell wrote (15) incident reports with (18) arrests during the 2015 school year. Officer Russell also assisted the Detective Bureau in follow up of two investigations that involved Maumee students, conducted a crash investigation which occurred on school property, and documented two incidents of students in mental crisis.

# Crime Prevention

SRO LaPlante and SRO Russell attend the majority of the disciplinary meetings at the Maumee High School. This provides insight and behavioral recommendations at the discretion of the school administrators. The SRO also meets with school administrators, counselors, the In-School Reassignment (ISR) Supervisor, and students on a daily basis. SRO LaPlante has also assisted on several suspension hearings at the Maumee Board of Education.

During the 2015 school year SRO Russell assisted with three A.L.I.C.E drills performed at the Maumee High School with teachers and staff. A.L.I.C.E drills with a building evacuation due to an unauthorized intruder drill, a lockdown, and one table top discussion about best practices were completed.

SRO LaPlante assisted Maumee High School staff in the placement of security cameras for the campus. This task was completed with Principal Matt Dick and Dean of Students Gretchen Brown. The cameras were installed for the start of the 2015 school year.

Chief Macdonald implemented the use of the SRO to enforce truancy within the district. This new function now allows the SRO to work with school administration to assist in getting students back to school or finding alternate learning settings for them.



# Crime Prevention

SRO LaPlante and SRO Russell have been able to assist elementary school principals in situations ranging from consultations with students, safety/security issues and investigations of criminal complaints, parking complaints, and parent complaints.

The SRO has become an important resource for school administration, staff, and the students of the district. The visibility created by the SRO and the positive interaction with the staff and students of the district has continued to create a positive image of the Maumee Police Department. The SRO position has also continued to be a great tool in gathering information about criminal activity within the City of Maumee.

# Crime Prevention

Gateway Middle School Resource Officer:

The goal of the Gateway Middle School S.R.O is to develop positive student and staff relationships to facilitate open communication regarding any criminal activity or behavior that would endanger the students or staff. Throughout the year, the Gateway Middle School School Resource Officer provided student and staff instruction on response to active threats.

The Gateway Middle School S.R.O. spent time in the classrooms, teaching lessons on internet safety to the sixth, seventh and eighth grade students. When violations of the law occurred within the school, the individual incidents were investigated and prosecuted, when appropriate.

During the 2014 year, the Gateway Middle School Resource Officer gave Gateway Middle School, Ft. Miami Elementary, Fairfield Elementary and Union Preschool additional instruction in the A.L.I.C.E (Alert, Lockdown, Inform, Counter, Evacuate) program. Staff only drills were conducted at the elementary schools. Staff and student drills were performed at Gateway Middle School.





# Crime Prevention

Parent-Teacher Organization meetings were attended to convey the goals of the SRO and explain the principles of A.L.I.C.E, for those in the community that had questions.

During one school recess, “Run, Hide, Fight” active threat training was provided to the Maritz Research Corporation in Maumee.

In the Summer months, both the high school and middle school resource officers instructed at the Safety City Program. In addition, both attended the 2014 Ohio School Resource Officers annual conference. The Gateway Middle School Resource Officer attended A.L.I.C.E. instructor’s training and was certified to instruct in A.L.I.C.E.

During the remainder of the 2014 Summer school recess, the Gateway Middle School Resource Officer was assigned traffic enforcement duties, initiating fifty-six traffic stops and issuing forty-four traffic citations.

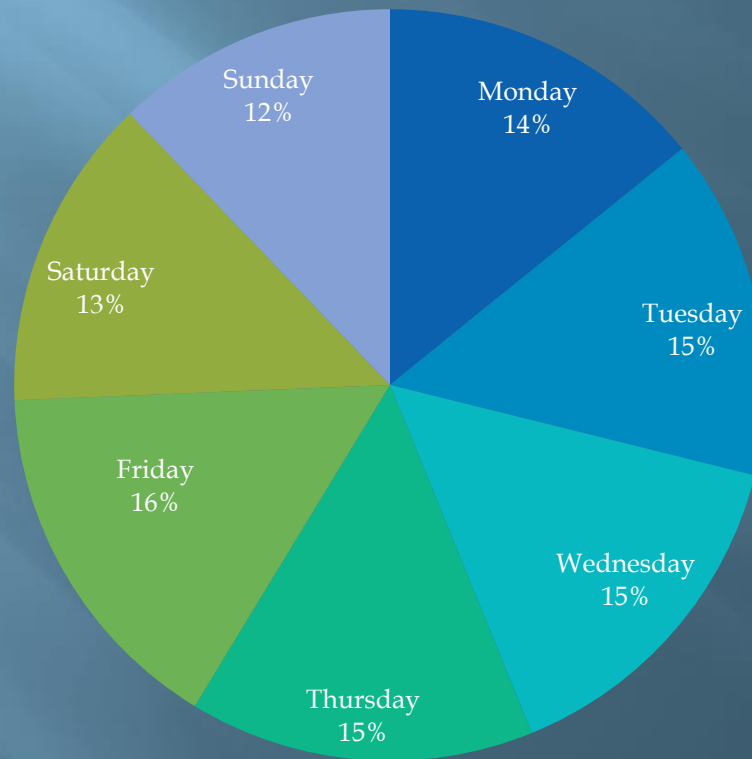

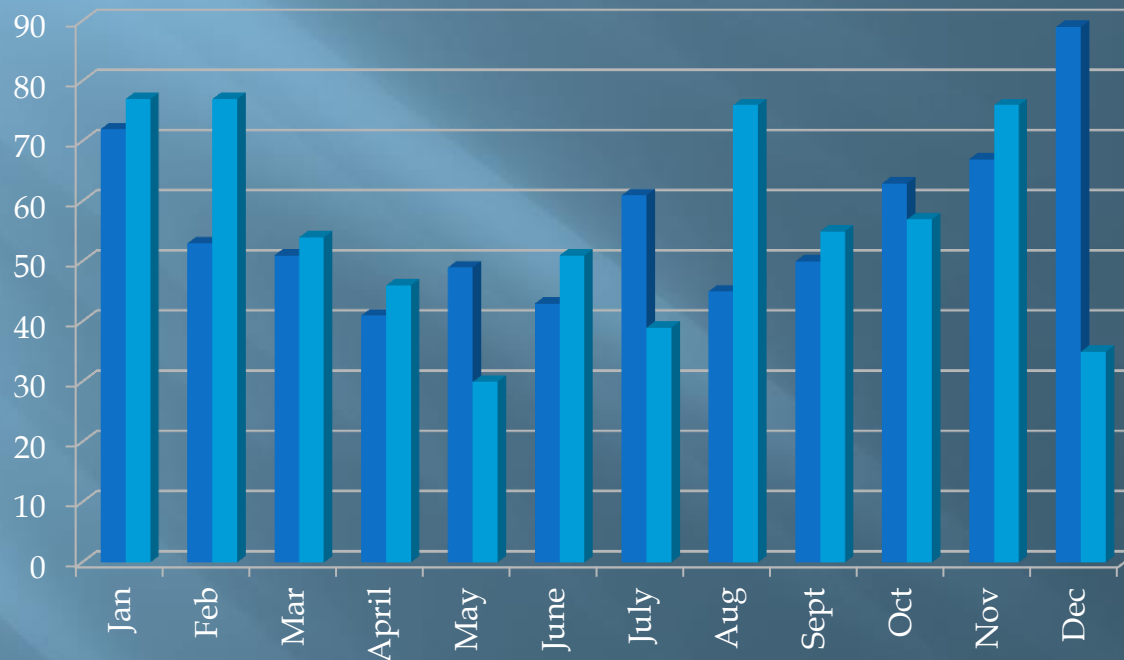

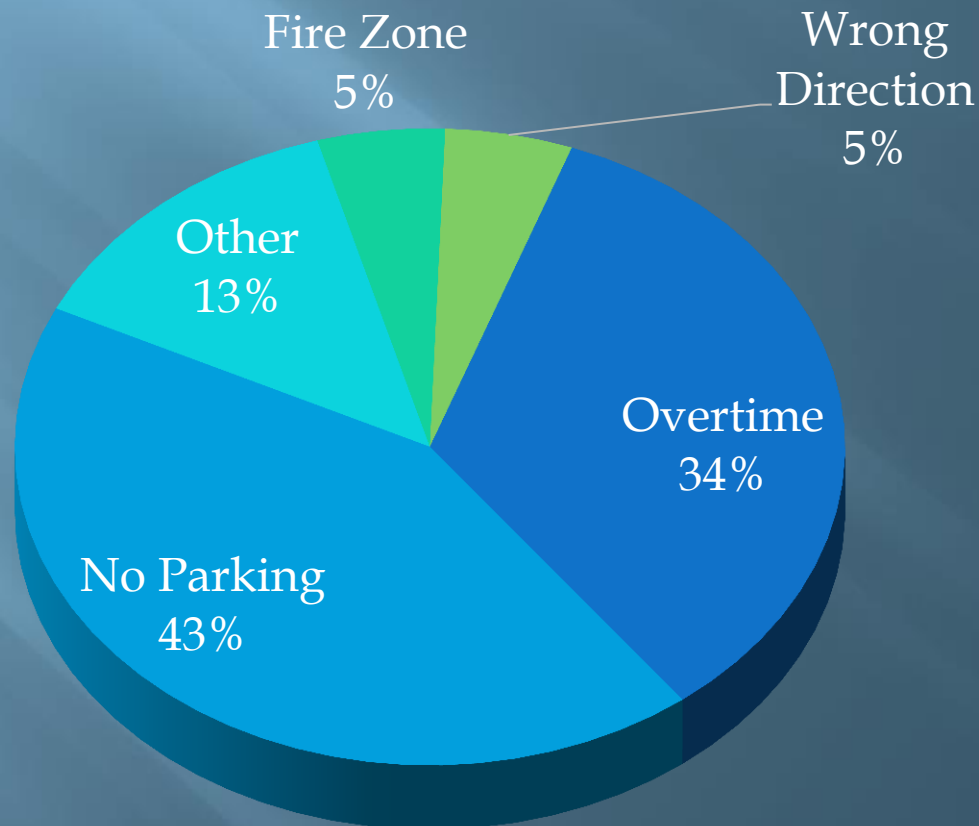
## Motor Vehicle Crash Reports Taken by Day of Week

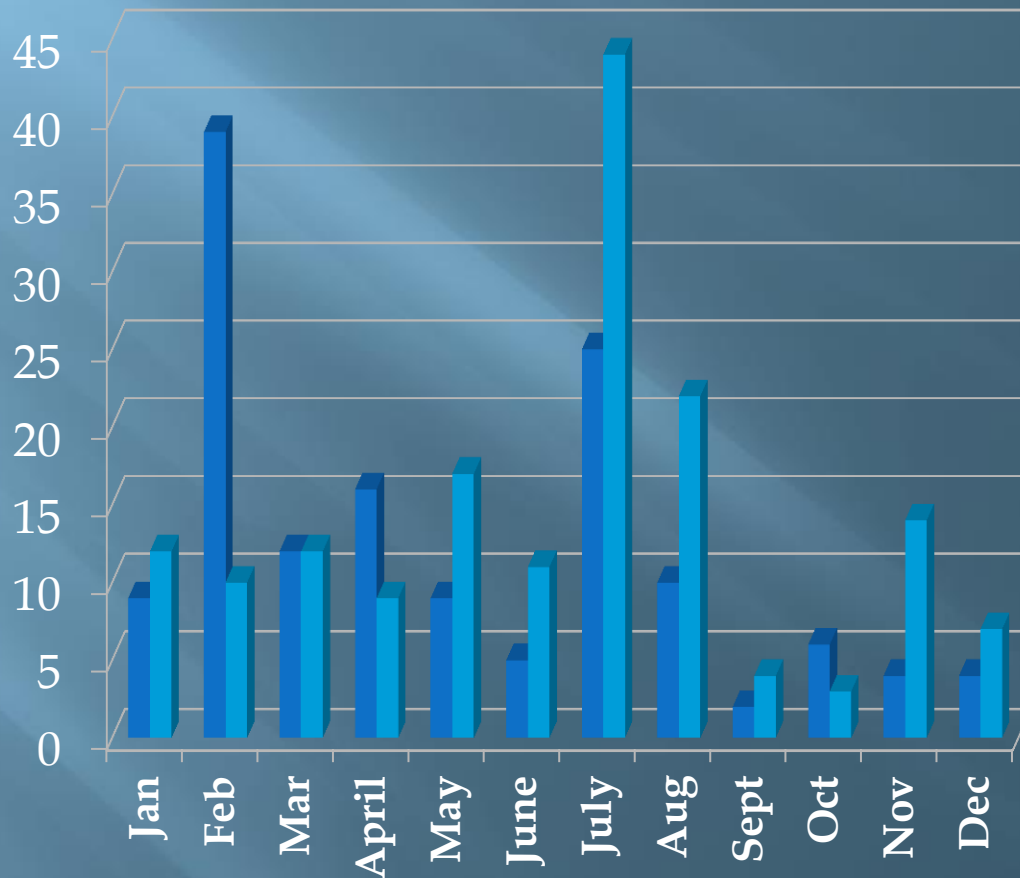

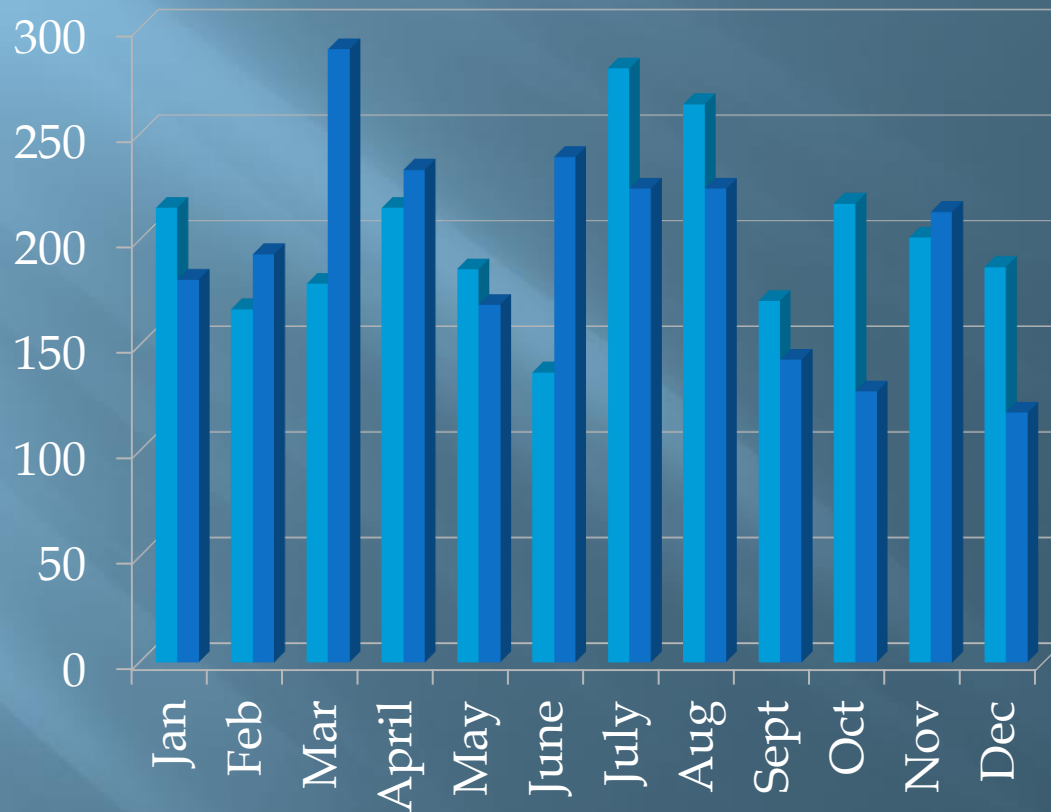

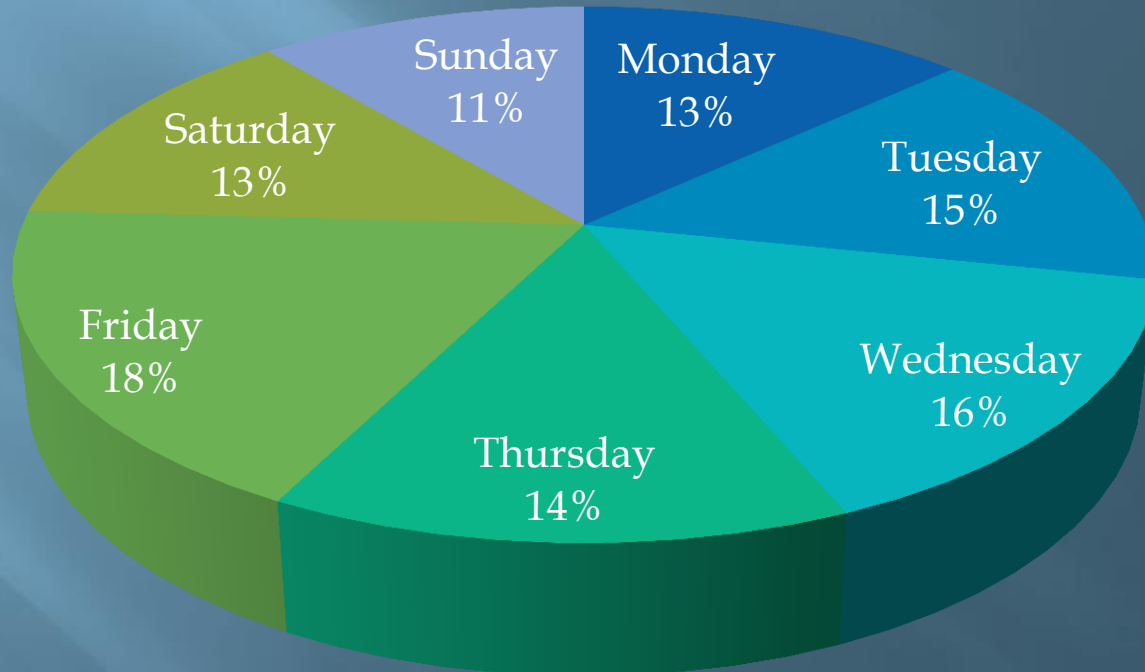

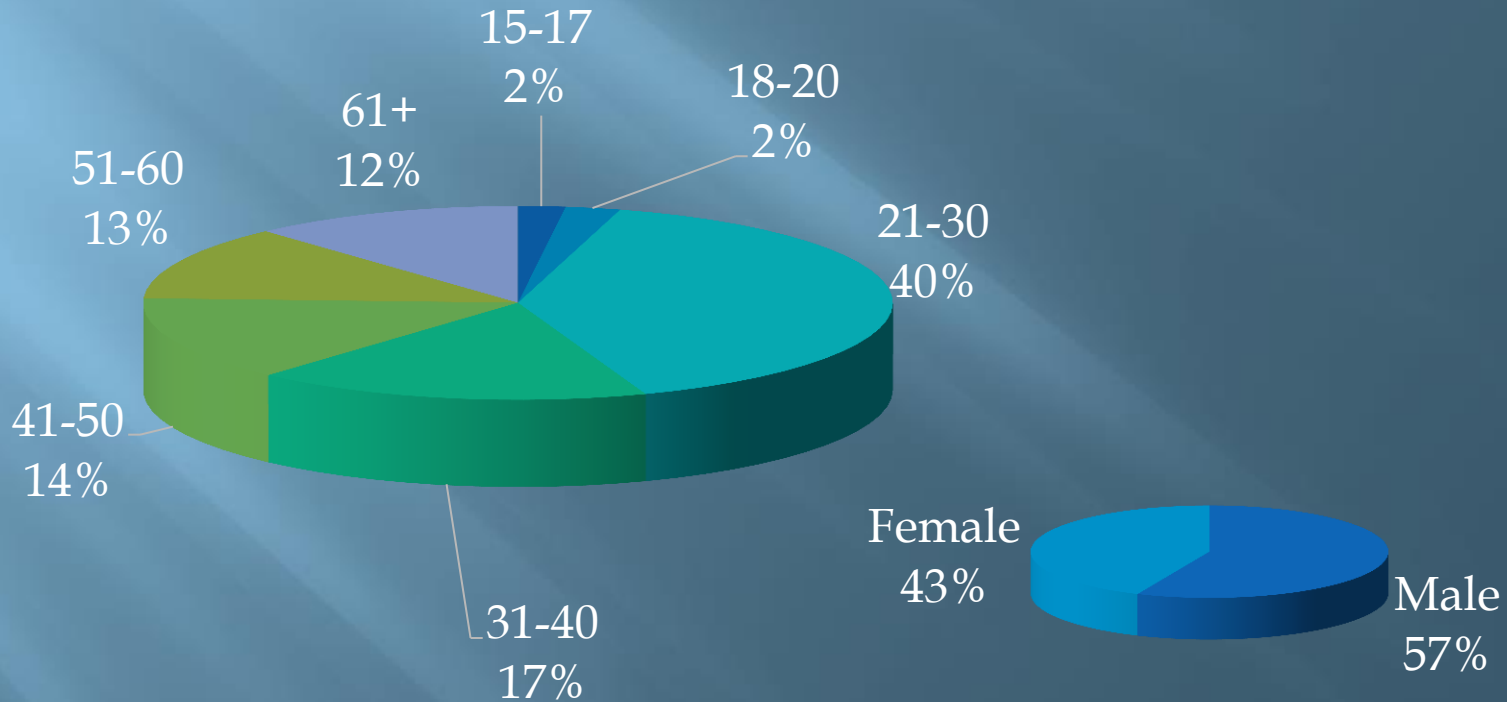

2420 Citations by Day of Week



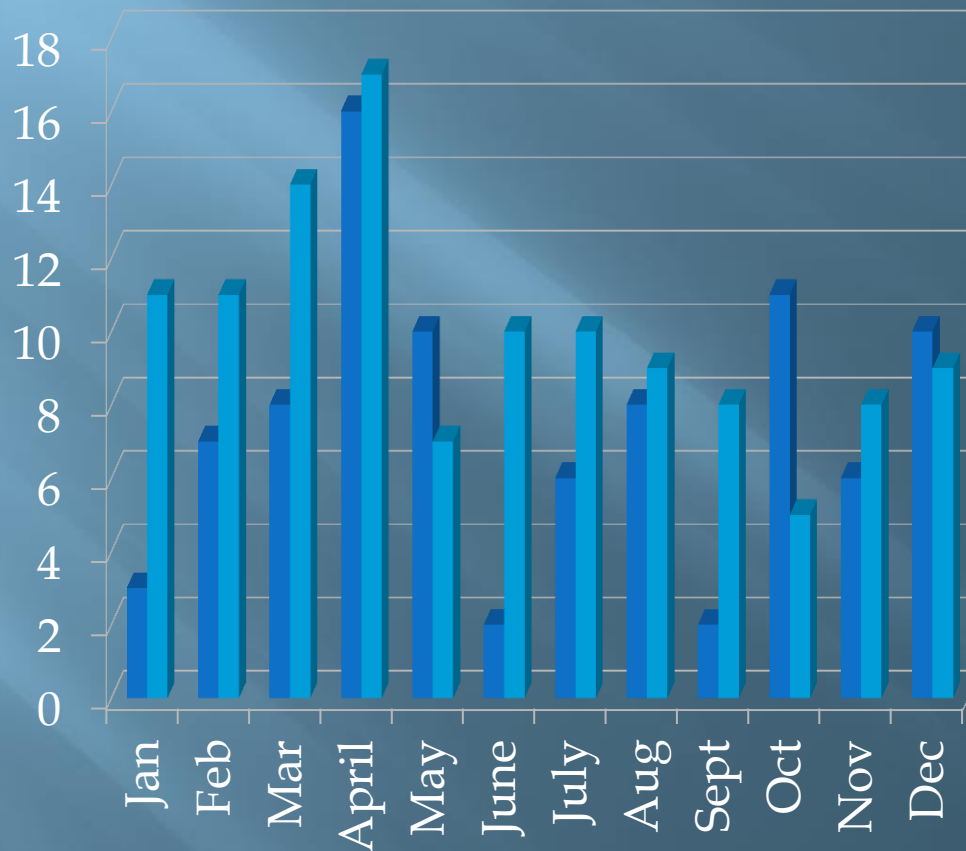

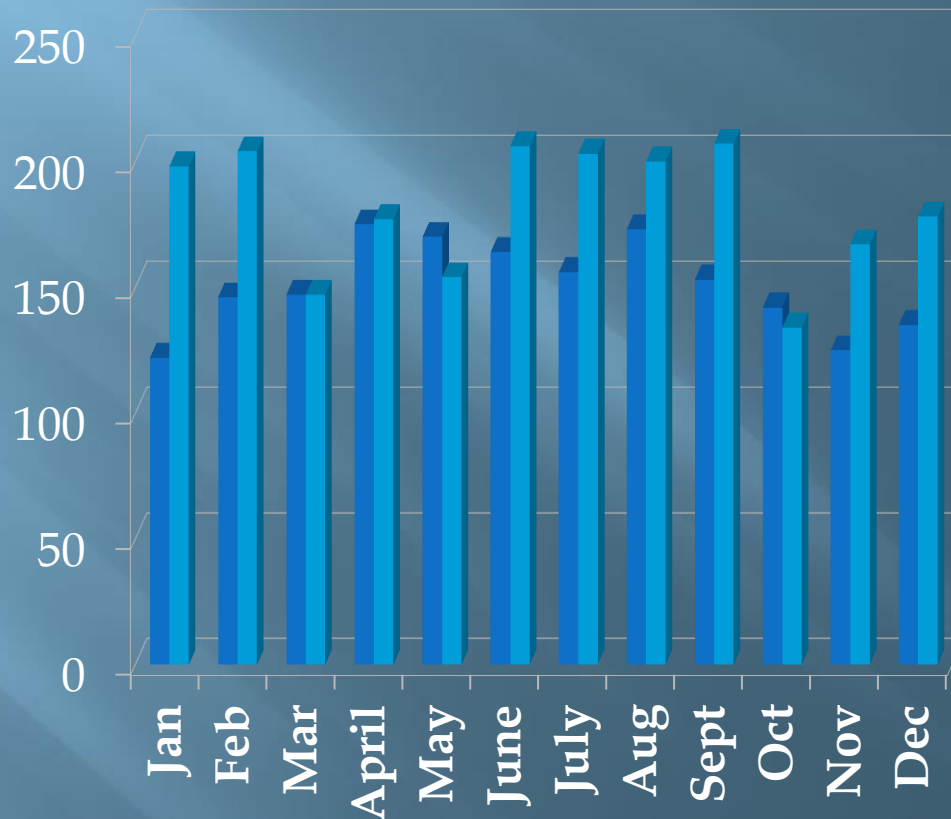

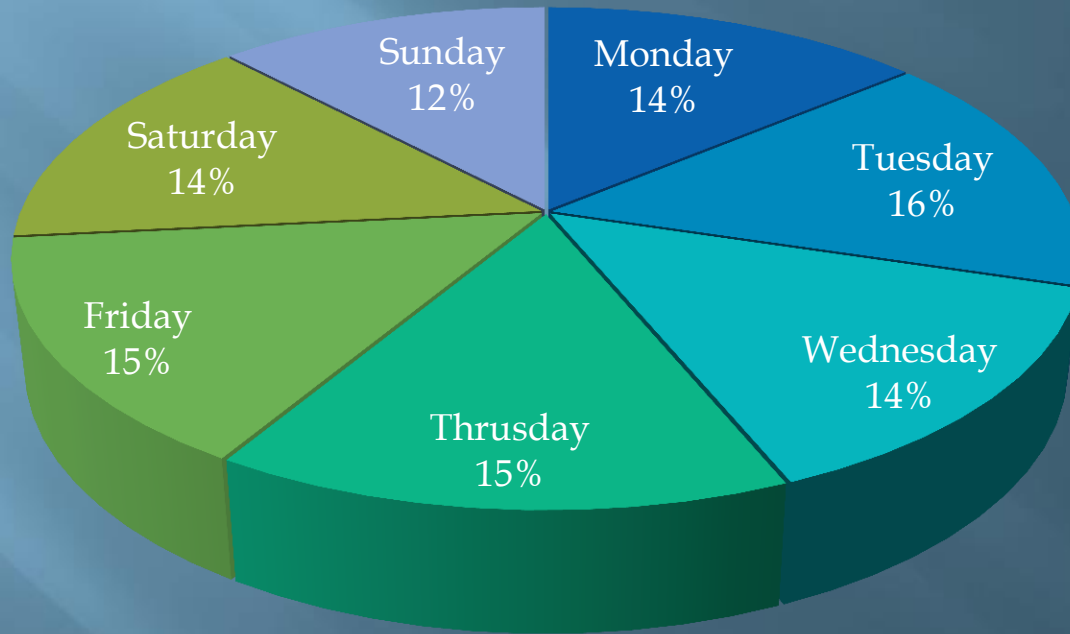

1808 Offense Reports by Day of Week

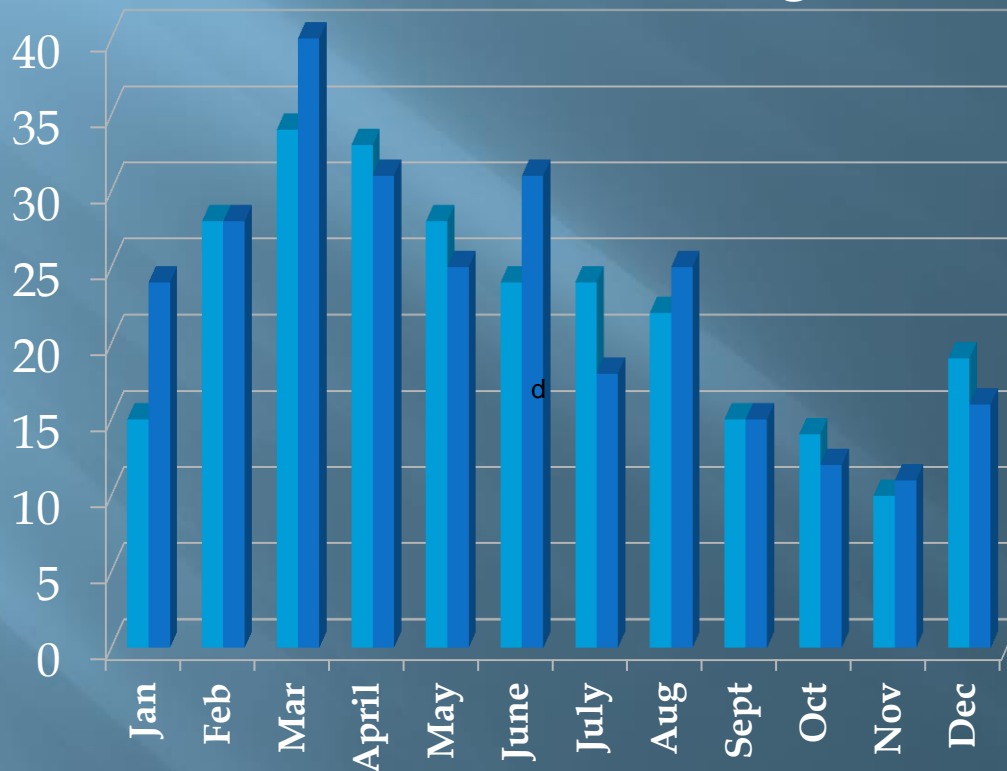

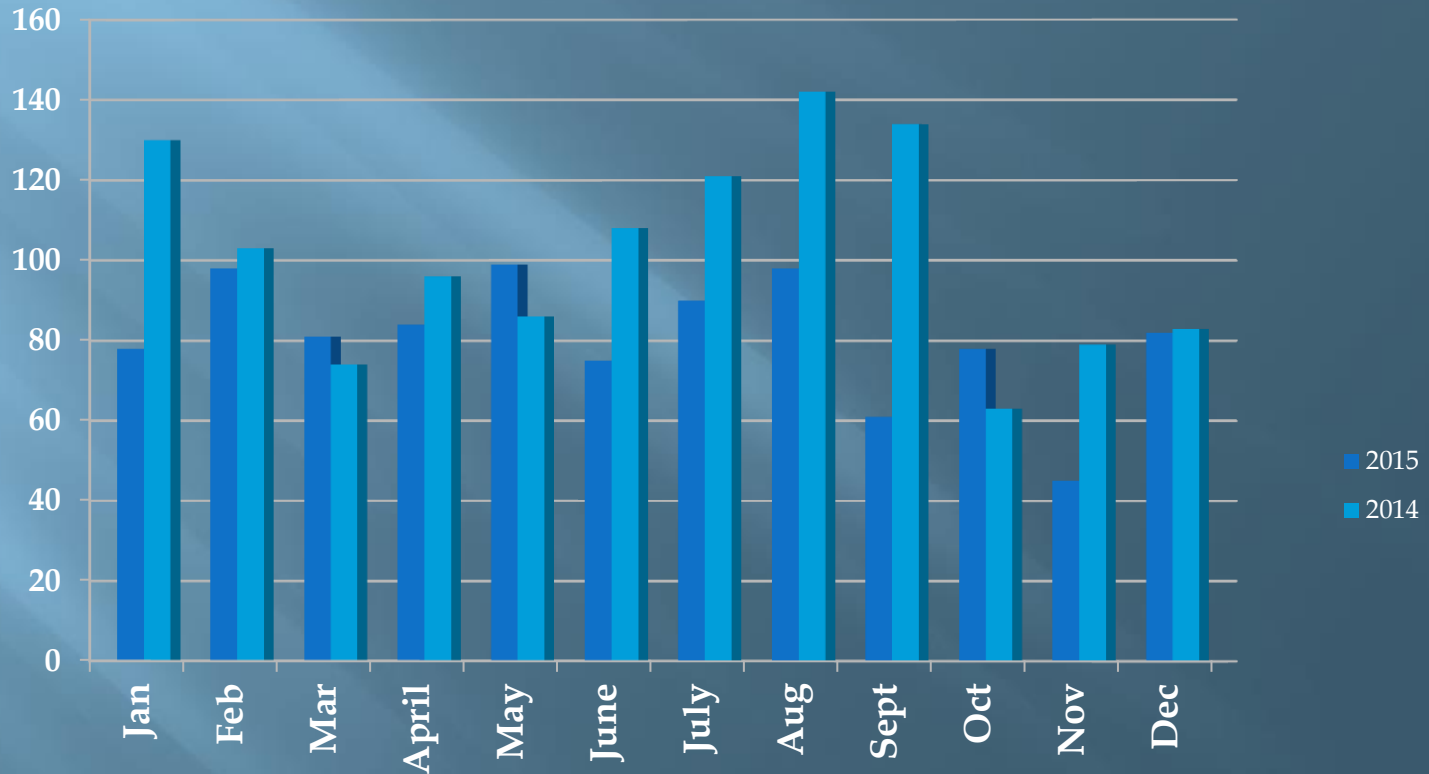

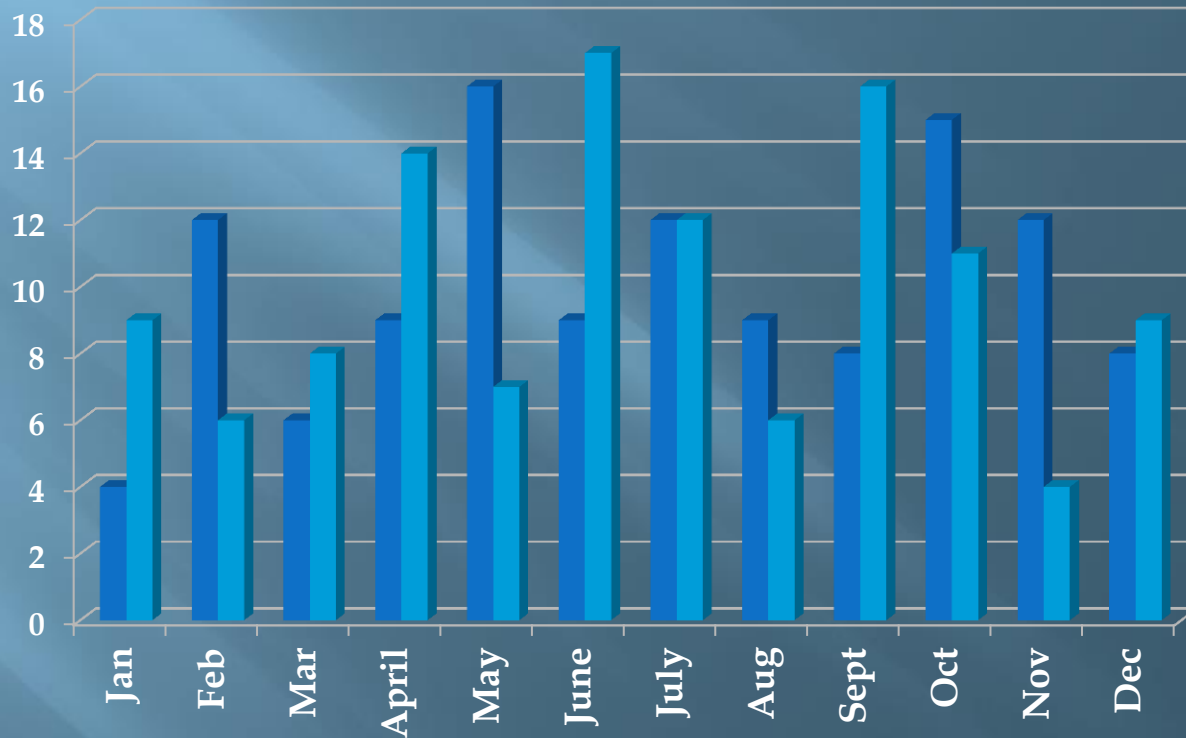

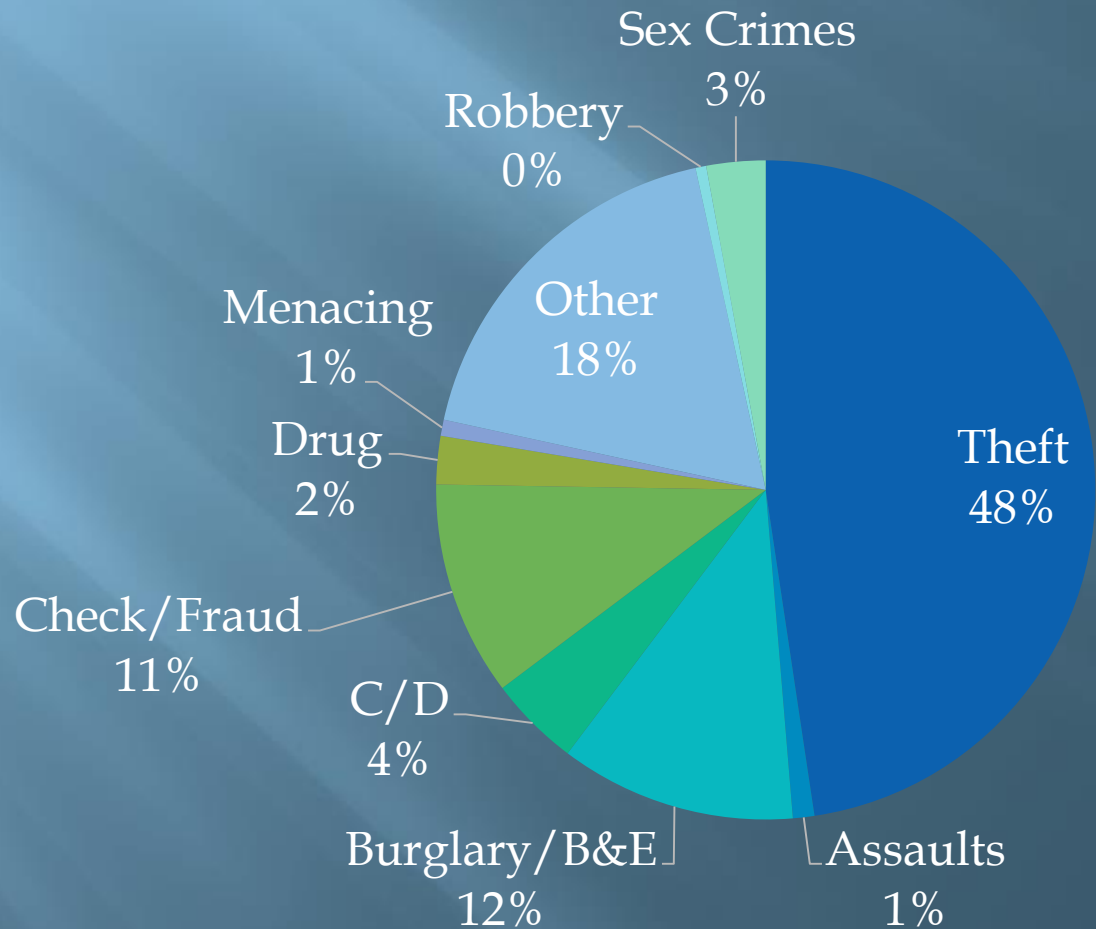

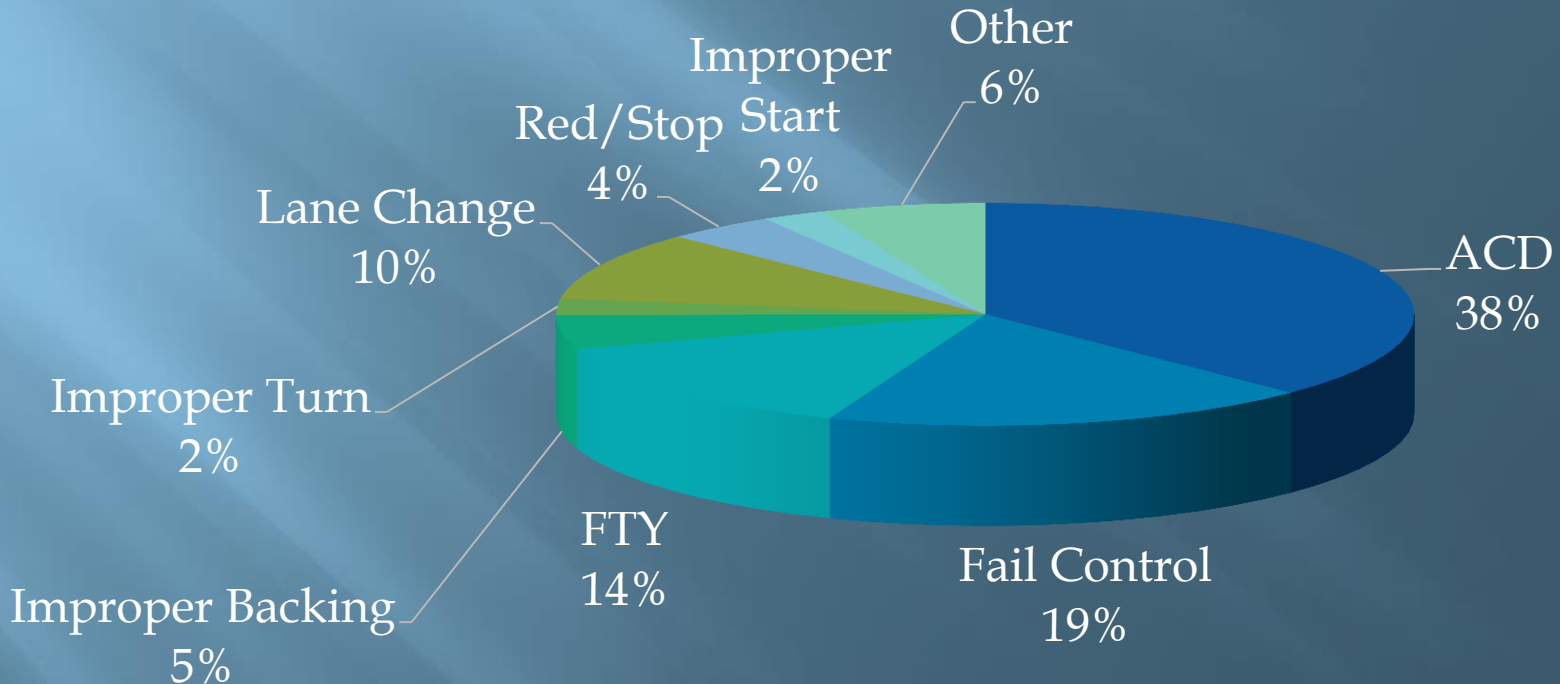
Types of Cases Assigned  
Total of 380 Cases




