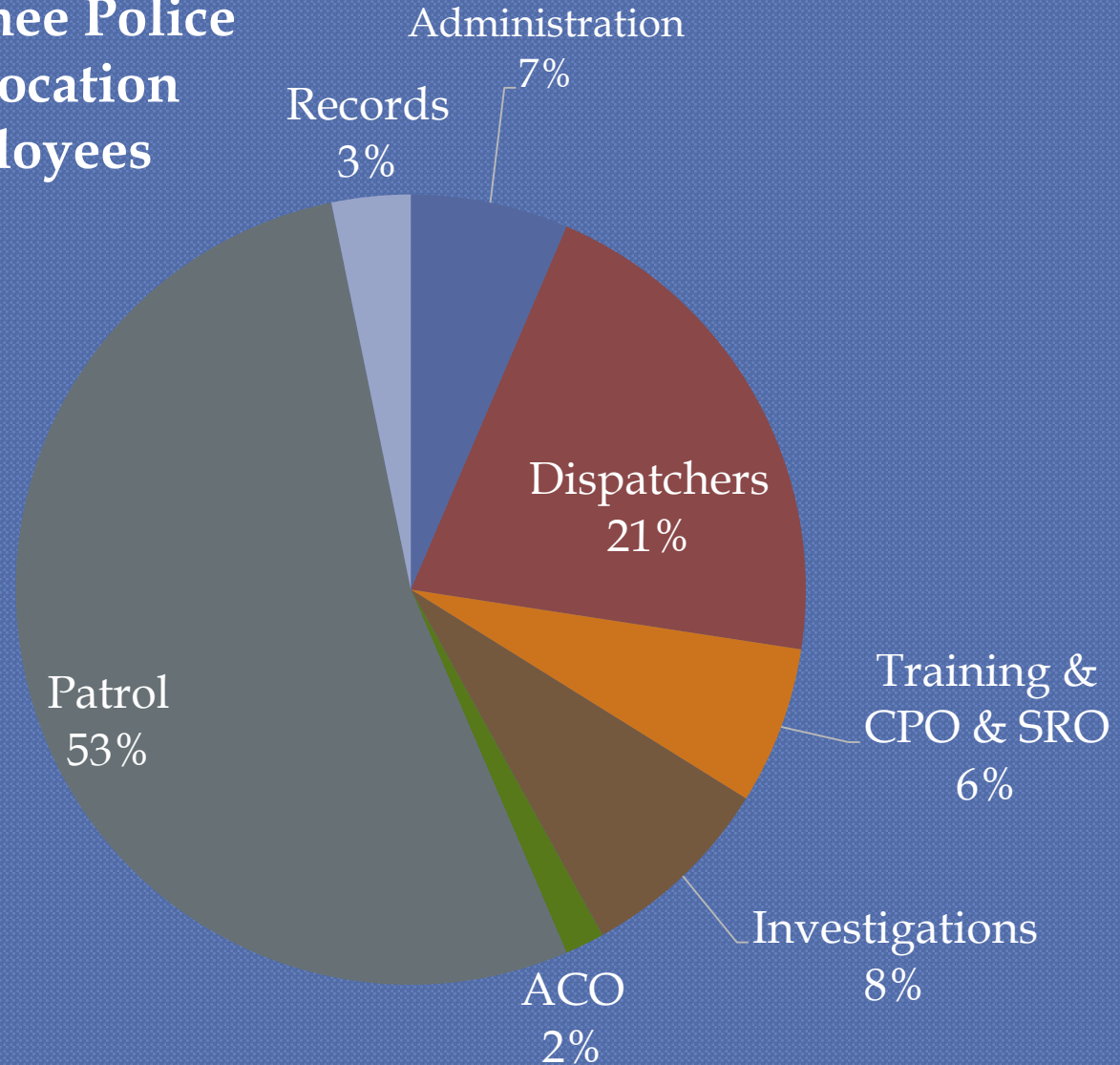

# Year in review

## STAFFING

One sergeant retired and a dispatcher resigned. One (1) officer was promoted to sergeant to fill the retirement. Two (2) police officers and four (4) dispatchers were hired to fill vacancies. Two (2) of the dispatchers were full time and two (2) were part time. All new employees completed field training.

## SCHOOL RESOURCE OFFICER

Maumee Police continue to staff a school resource officer at the Maumee High School and another officer at Gateway Middle School. The school resource officer assists with school discipline, truancy issues and campus security. In addition, the officer builds relationships with the students, educators, administration and provides various topical lessons in the classroom.



# Year in review

## BUSINESS VISITS

The Maumee Police Chief along with the Maumee Fire Chief and Safety Director made weekly community visits to citywide small business and large corporations. It proved valuable to develop relationships and foster a networking environment with the Maumee business community.

## OHIO COLLABORATIVE CERTIFICATION

The Police Division continued to revise certification with the Ohio Collaborative Advisory Board of the Ohio Criminal Justice Services. The Division met the standards for policy and practice in the areas of Use of Force, Training, Recruitment and Hiring Standards. We consider this a benchmark of policies and standards that meet or exceed the professional best practices in the policing service.

# Year in review

## MPD OVI ARRESTS

The Police Division made 113 OVI arrests during 2017. Males comprised 67% of the arrests. Females comprised 33% of the arrests. 38% refused a breath/blood test, while 62% submitted to the requested chemical test. 85% were the result of a traffic stop, and 15% of the arrests involved a traffic crash.

## SPEED DETECTION TRAILER

The Maumee Police Division utilizes a mobile speed detection trailer throughout our city limits. The device is primarily an awareness tool for the motoring public to observe their vehicle speed in comparison to the posted limit. The speed device was deployed 305 days for a total of 7,329 hours,



# Year in review

## LUCAS COUNTY OVI TASK FORCE

The City of Maumee received \$12,118.46 of federal grant funding for MPD's participation in the Lucas County OVI Task Force during 2017. The grant includes repayment of direct labor costs, fringe benefits and transportation / fuel costs. Officers worked 182 hours of traffic enforcement, making 313 traffic stops and issued 150 traffic citations.

MPD facilitated an OVI Checkpoint in September 2017. The event was staffed by the Maumee Police Division and other officers of the OVI Task Force. A total of 568 vehicles traveled thru the checkpoint. Five hundred fourteen (514) of those vehicles were checked by officers. Twenty eight (28) vehicles were diverted for further investigation. Arrests and citations include: One (1) OVI, five (5) Expired License Plate, two (2) Expired Operator's License, and two (2) Driving under Suspension. One (1) vehicle ran through checkpoint almost striking the officer flagging cars into checkpoint. The vehicle was pursued resulting in the OVI arrest.



# Year in review

## COLLEGE INTERNSHIPS

The Police Division facilitated four (4) college and two (2) local high school internships. These internships are geared toward allowing the student the opportunity to see firsthand all facets of police work. Students spend time with Road Patrol, Detectives, School Resource Officers, DARE/Crime Prevention. Additionally, students had the opportunity to participate in some of our training programs.

# Accidents

The number of accidents at the most hazardous intersection increased from 63 in 2016 to 73 in 2017. The total number of accidents in the 10 most hazardous intersections also decreased, from 262 in 2016, to 254 in 2017. There is a three way tie for third place.

Three intersections dropped from the list this year: the Anthony Wayne Trail @ Gibbs, Conant @ Holland, and Anthony Wayne Trail @ Fallen Timbers.

There were two fatal accidents for 2017 that led to two deaths.



# Crime Prevention

## CRIME PREVENTION SPECIALIST

The Maumee Police Division maintains three officers certified as Crime Prevention Specialists.

These officers maintain their certification by attending continuing education classes.

## THE "ARE YOU OK?" PROGRAM

For twenty-eight years, the Maumee Police Division has operated the "Are You O.K.?" program. Known as R.U.O.K., the program continues to check the safety of our senior citizens as well as our hotel night clerks and gas station attendants. Each participant receives a daily or nightly call checking on his or her safety. A police crew is sent to check their safety if there is no answer.

The program has helped many residents since its inception. The program then expanded to check the safety of 24-hour gas station employees and hotel desk clerks. The program currently has nine individual subscribers, along with ten hotels and two gas stations.

The Senior Citizens program called the "Senior Outreach" program continues to be effective. This program involves a weekly in-person check (in the home) by a uniformed officer to ensure the needs of the senior are being met. There are currently five senior residents utilizing the program.

## CHILD SAFETY SEAT CHECKS

The Maumee Police Division has two officers that are certified technicians in child passenger restraints. They are certified through the Safe Kids Coalition Child Passenger Safety Training Program. This training enables the Maumee Police Division to provide our community with highly trained experts in the proper installation and implementation of child car seats.

In 2017, seventeen child safety seat checks were performed for citizens working or living within the City of Maumee.

## SEATBELT SAFETY

The Crime Prevention Officer taught the Third Grade Safety Belt Program to all third-grade students in the Maumee School District. One hundred and eighty-three students received practical training in the Ohio Department of Public Safety education program. The program encompassed the proper use of seat belts, statistics about accidents/seatbelt usage, and information on air bags. Each child received material and information to share with their family members. As part of the program, each student was deputized as Seat Belt Deputies as they pledged to wear their seatbelts and to remind family members to wear their seatbelts as well.

## SAFETY CITY

The City of Maumee Safety City program celebrated its 38th year in 2017. Ninety-two children participated in the summer program to help prepare four and five year olds to safely attend Kindergarten. Safety City consisted of classroom instruction, crafts, songs, and practical exercises in vehicle and pedestrian safety. Lessons were conducted on our miniature Safety City equipped with streets, crosswalks, traffic signals, railroad tracks, and faux buildings. Safety City consisted of 2 sessions per day over a two week period in June. The sessions lasted 2-1/2 hours each day.

The staff included three Maumee Police Officers, two teachers, and 14 high school and middle school student volunteers (along with two college interns). Safety City is located at Wayne Trail Elementary School.

The Maumee Police Division and the Maumee Board of Education sponsor the Safety City program. McDonald's Restaurant (Conant Street) and the Maumee Municipal Court support the program through donated products and services. St. Luke's Hospital Ladies Auxiliary provides each graduate of Maumee Safety City with a bicycle safety helmet. They also receive a t-shirt from the Maumee Police Division.

## THE D.A.R.E. PROGRAM

The DARE program provides the students with the tools necessary to make the right decisions when it comes to alcohol, tobacco, other drugs, and violence. It is taught at Wayne Trail Elementary School, Gateway Middle School, and St. Joseph's Maumee School. The DARE program was taught to four-hundred and ten students in the fifth and seventh grades this year.

The fifth grade program culminated with two separate graduation ceremonies. The first DARE graduation took place at the Maumee High School Performing Arts Center with the fifth-grade students of Wayne Trail Elementary. The second event occurred at St. Joseph's School Maumee.

The Maumee DARE officer also had a booth at the Maumee Uptown Fair. Many of the area DARE students attended this event along with DARE night at Ohio Skate, which provided an opportunity to reinforce the DARE drug-free choice.

Charlie's Dodge continues to kindly provide the Maumee DARE program with a donated vehicle with graphics.

The Maumee Police Division received a grant for the 2016-2017 school year from the Ohio Attorney General's Office. The awarded amount of \$18,252.60 helps to defer the cost of teaching the DARE program in the Maumee school system.

## BIKE SAFETY

Bike safety/education is an important part of the Maumee crime prevention program. A bike rodeo was held at Fairfield Park in May 2017. Sixty-seven children participated in the rodeo free of charge. Maumee Police Division Bike Officers, Citizen Police Academy Volunteers, Safe Kids volunteers, as well as volunteers from TAB (Toledo Area Bicyclists) assisted the crime prevention staff by inspecting each bike, conducting safety checks and making repair recommendations. Cyclists participated in an agility course to test their skills.

Toledo Metroparks also joined in this year with information about bike paths in the area and their frog mascot.

Those who attended took home a safety packet and bicycle helmets were given away free of charge to any cyclist who needed one.

The Maumee Police Division participated in the Maumee Municipal Court's "Bike Helmet Reward" Program. The Maumee Court, under the leadership of Judge Gary Byers, supplied area police officers with coupons. When the officers observed children wearing bike helmets, they provided them with the coupon good for a free ice cream cone. These coupons have helped to increase the use of bike helmets by cyclists, skateboarders, and even those on rollerblades in our community.

The Maumee Police Division continues to provide bike licenses free of charge.

A licensed bike enables an owner to be identified and the bike returned when found or recovered.

## COMMUNITY WATCH MAP

In 2017, a “Community Watch Map” was created to keep residents informed of police-related calls in our city. The Google Map can be accessed through the City of Maumee’s main website. The map shows a visual icon indicating the general area where the police call was handled including but not limited to: thefts, burglaries, assaults, criminal damage calls, drug-related calls, OVI’s, accidents and much more. When clicking on the icon, there is a brief synopsis of the call along with the date the call was taken and a report number. Residents are encouraged to utilize the map to stay informed and possibly provide any leads to help our department follow-up on unsolved crime.

# Crime Prevention

This was the 15<sup>th</sup> year for the School Resource Officer (SRO) Program in the City of Maumee. Officer Scott Russell worked as the primary SRO for Maumee High School. Additionally, Officer Russell assisted SRO at Gateway Middle School as needed.

SRO Russell wrote (22) incident reports with (17) arrests and (2) crash reports on high school property during the 2017 school year. Officer Russell also received investigations from the road patrol and detective bureau for possible follow-up and all incidents that involved Maumee students were included in this summary. Officer Russell assisted on three Maumee Fire EMS runs to the High School.

SRO Russell attends the majority of the disciplinary meetings at the Maumee High School. This provides insight and behavioral recommendations at the discretion of the school administrators. The SRO also meets with school administrators, counselors, the In-School Reassignment (ISR) Supervisor, and students on a daily basis.

During the 2017 school year SRO Russell assisted with three A.L.I.C.E drills performed at the Maumee High School with teachers and staff. A.L.I.C.E drills with a building evacuation due to an unauthorized person gaining entry drill, a lockdown, and one table top discussion where handouts for room preparation were given to the staff accompanied with a discussion on knowing your surroundings.

Chief Macdonald implemented the use of the SRO to enforce truancy within the district. This new function now allows the SRO to work with school administration to assist in getting students back to school or finding alternate learning settings for them. SRO Russell visited seven students' homes for truancy issues.

SRO Russell has been able to assist elementary school principals in situations ranging from consultations with students, safety/security issues and investigations of criminal complaints, parking complaints, and parent complaints.

The SRO has become an important resource for school administration, staff, and the students of the district. The visibility created by the SRO and the positive interaction with the staff and students of the district has contributed to a positive partnership between the police division and the Maumee Schools. The SRO position has also continued to be a great tool in gathering information about criminal activity within the City of Maumee.



# Crime Prevention

Gateway Middle School Resource Officer:

The goal of the Gateway Middle School S.R.O is to develop positive student and staff relationships to facilitate open communication regarding criminal activity or behavior that would endanger the students or staff. The relationship and trust built between the officer and student has been instrumental in identifying problems that could lead to a school or student safety concern.

Throughout the year, the Gateway Middle School Resource Officer provided student and staff instruction on response to active threats. The Gateway Middle School S.R.O. spent time in the classrooms, teaching lessons on internet safety, refusal skills and forensic science. When violations of the law occurred within the school, the individual incidents were investigated and referrals were made to the appropriate agencies. The school resource officer works closely with the school counselors and assists in identifying and responding to mental health concerns when they pose a risk to the student's safety.





# Crime Prevention

Starting in August of the 2017-2018 school year, Gateway Middle School was assigned a new SRO for the building. Ptl Loren Boos replaced Ptl Derek Sanderson as the new SRO for the middle school. Ptl Boos has been with the police division for 16 years. Prior to the Maumee Police Division, Officer Boos worked for BGSU Police Department and Bettsville PD. Over his 16 years with the division, he has filled many rolls with the division such as: SRU (Special Response Unit) for 14 years, FTO (Field Training Officer) for 10 years, property room officer, bike patrol officer, Detective & Firearms Instructor.

As a new SRO, Officer Boos has transitioned the safety drills to a more reality based training. In making the drills more realistic, the students and staff are more prepared in case of a critical incident. Additionally, this training has been conducted at Fairfield Elementary and Fort Miami Elementary. The students and staff in all the buildings are adapting well and learning what to do and not to do during a critical incident.

# Training

The Maumee Police Division continues the tradition of training our officers to be the very best in the area.

2017 saw another increase in the total number of training hours officers received over the previous year.

2017 the Police and Fire division updated the class room at the Public Safety Training center to include new AV system, tables, internet, floor. We can now host training here and bring in instructors from all over.

2017 the Police Division along with the support of our City Council, took a step forward and began designing an outdoor firearms range to be located at the Public Safety Training Center. An outdoor range will provide us with the venue to expand our firearms training program and allow our officers to experience training that cannot be replicated on an indoor range.

A new Audio Visual computer system was installed in the training room at the Maumee Police Division, the updated technology allows us to continue training officers, host regional meetings and continue with our Citizen's Police Academy.

# Training

A new roll call training program was implemented, where policies and procedures are reviewed monthly with each officer and dispatcher by the shift sergeant.

A new training program and training manual was created for the dispatcher training process. This 60 plus day training program, is broken into 3 separate phases to insure the new dispatcher progresses through the program and receives a more standardized training.

A new police officer field training program, training manual, training briefs, and reporting system was put into place. This 20 week program is structured with specific training briefs for each day of training. The program is broken into 3 phases that has specific training categories that the probationary officer must be proficient in, before advancing into the next phase. At the end of phase 3, the probationary officer is shadowed, for 2 weeks, by the Field Training Officer, who only observes and offers no help or advice. This ensures that the probationary officer is ready to be on his own, before actually being on his own.

We hired 2 new Patrol Officers, each went through the new extensive 20-week Field Training Program.

We also hired and trained 2 new full-time dispatchers.

# Training

The Police Division continues to commit an officer to the Northwest Ohio Bomb Squad, holding monthly training. We also serve as storage site for the team's equipment.

The Division assigned 1 new detective, who went through investigator training and evidence technician training.

All police officers went through defensive driving training.

We continue our commitment to train every officer in Crisis Intervention Training (CIT). Starting this year, we are now hosting the 40 CIT training at or Mingo Training Facility several times a year.

The entire Patrol staff participated in annual Use of Force training, along with Rescue Task Force Training.

We held annual firearms qualifications in several weapon platforms.

One half of the entire Division went through semi-annual First Aid training.

We hosted area-wide training in Death Notification School.

Each officer completed 20 hours of Continuing Professional Training that was mandated by the state.

# Investigations

## MAJOR INVESTIGATIONS

### **Sex Crime**

A prostitution sting, as part of Operation Metro Shield (county-wide targeted enforcement effort), was conducted by Maumee Detectives at a local motel in June. As a result, 3 individuals were arrested on drug and/or sex-related offenses.

### **Rape**

There were three (3) reported cases of rape investigated by the detective bureau. One (1) case resulted in the arrest of the alleged suspect; however prosecution was later declined by the Lucas County Grand Jury. One (1) case unfounded and one (1) case was denied prosecution.

### **Sexual Assault**

There were four (4) sexual assault cases investigated by the detective bureau. One (1) case was cleared by arrest. One (1) case was denied prosecution due to a lack of evidence. Two (2) cases were closed by exception due to lack of cooperation by the alleged victims.

### **Missing Persons**

Four (4) missing persons/runaway cases were investigated by the Detective Bureau. All subjects reported missing were located.



# Investigations

## **Robbery**

There was one (1) aggravated robbery investigation assigned to the Detective Bureau. Although a deadly weapon was not involved, the victim suffered serious physical harm. After an extensive investigation, DNA evidence was collected and used to identify the suspect who was eventually located and arrested in Michigan.

## **Residential Burglary**

Twenty-three (23) residential burglary cases were assigned to the detective bureau for further investigation. Four (4) cases were cleared by arrest, nine (9) cases were closed after all investigative leads had been exhausted and ten (10) cases were closed due to a lack of leads.

## **Breaking and Entering**

Five (5) breaking and entering cases were investigated by the detective bureau. Three (3) cases were cleared by arrest. One arrest involved an organized criminal enterprise that was later linked to other similar thefts in adjacent states, currently being investigated by the Federal Bureau of Investigation (FBI). Two (2) cases were closed after all investigative leads had been exhausted.





# Investigations

## Theft

One hundred ninety-six (196) theft cases were assigned to the detective bureau for investigation. Of these, eighty-nine (89) cases were cleared by arrest or exceptional means. Ninety-one (91) cases were closed due to either a lack of investigative leads, exhaustion of investigative leads, referred to another agency or determined to be unfounded. Sixteen (16) cases are currently under investigation.

## Fraud

Twenty-four (24) fraud cases were assigned to the detective bureau. Of these, six (6) cases were cleared. Sixteen (16) cases were closed due to either a lack of investigative leads, exhaustion of investigative leads or referred to another law enforcement organization. The remaining two (2) cases were determined to be unfounded.

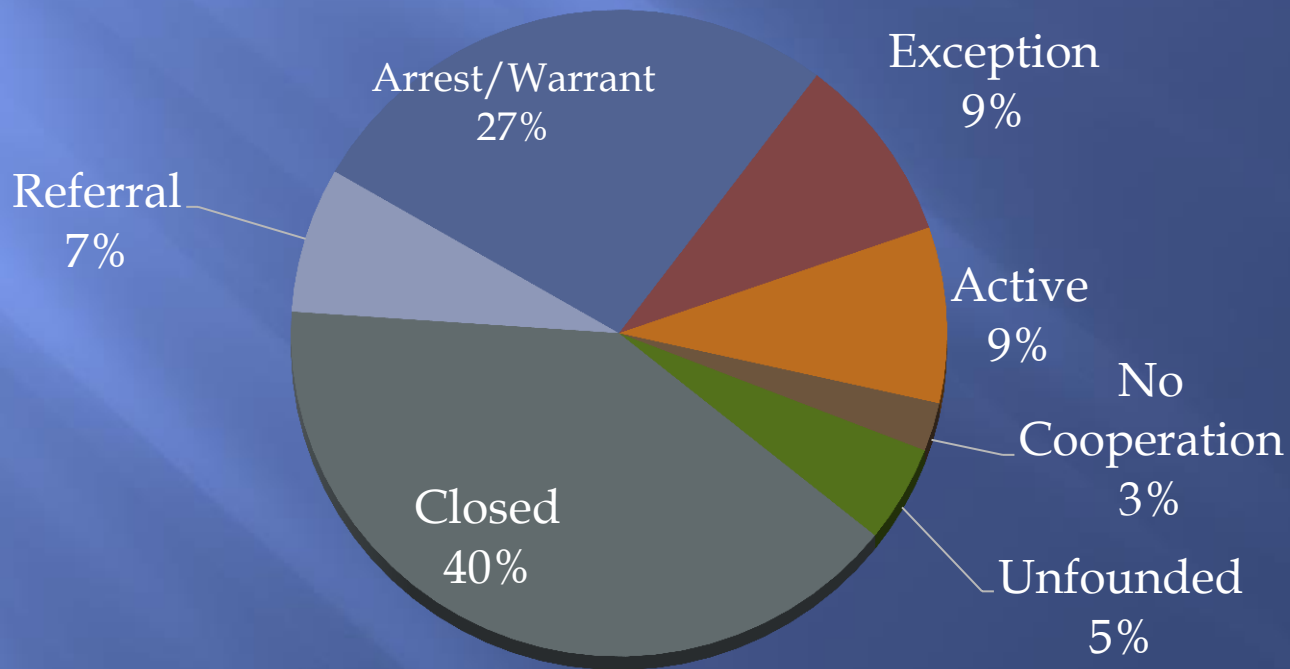
## Summary

In 2017 the detective bureau investigated a total of 329 offenses that were reported to have occurred in the City of Maumee. Of those, 23 remain under investigation. Of the remaining 306 closed cases, 148 were cleared by arrest or exceptional means (44.9%), 108 were closed due to lack or exhaustion of investigative leads (32.8%), and 40 were closed by referral to another law enforcement agency or determined to be unfounded (12.1%). The majority of cases assigned to the detective bureau were theft related (196) which totaled 59.5% of all criminal investigations for the year.

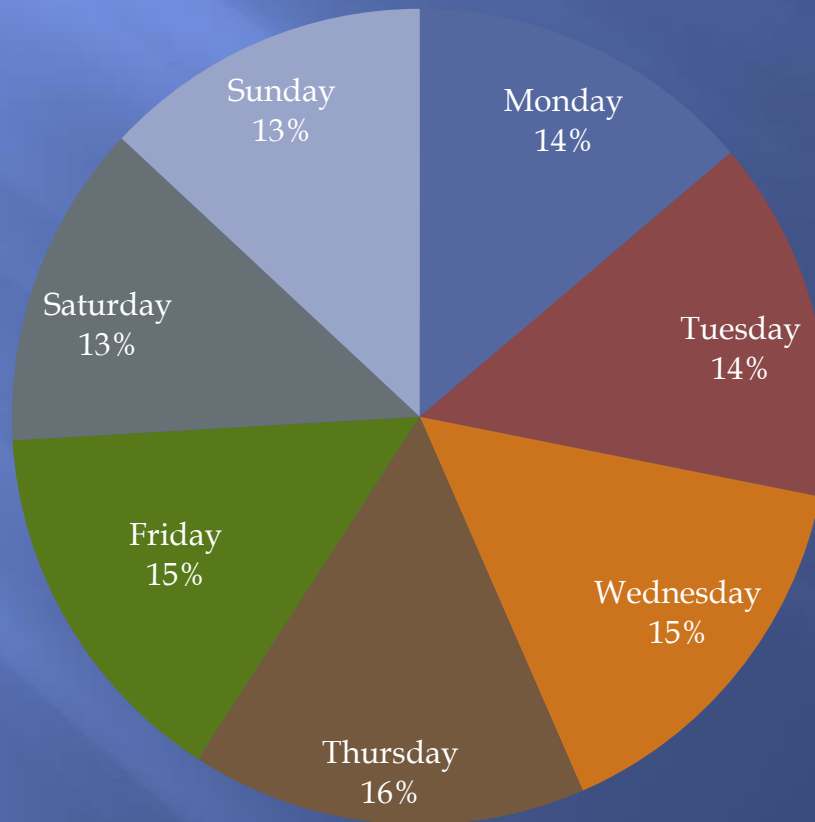

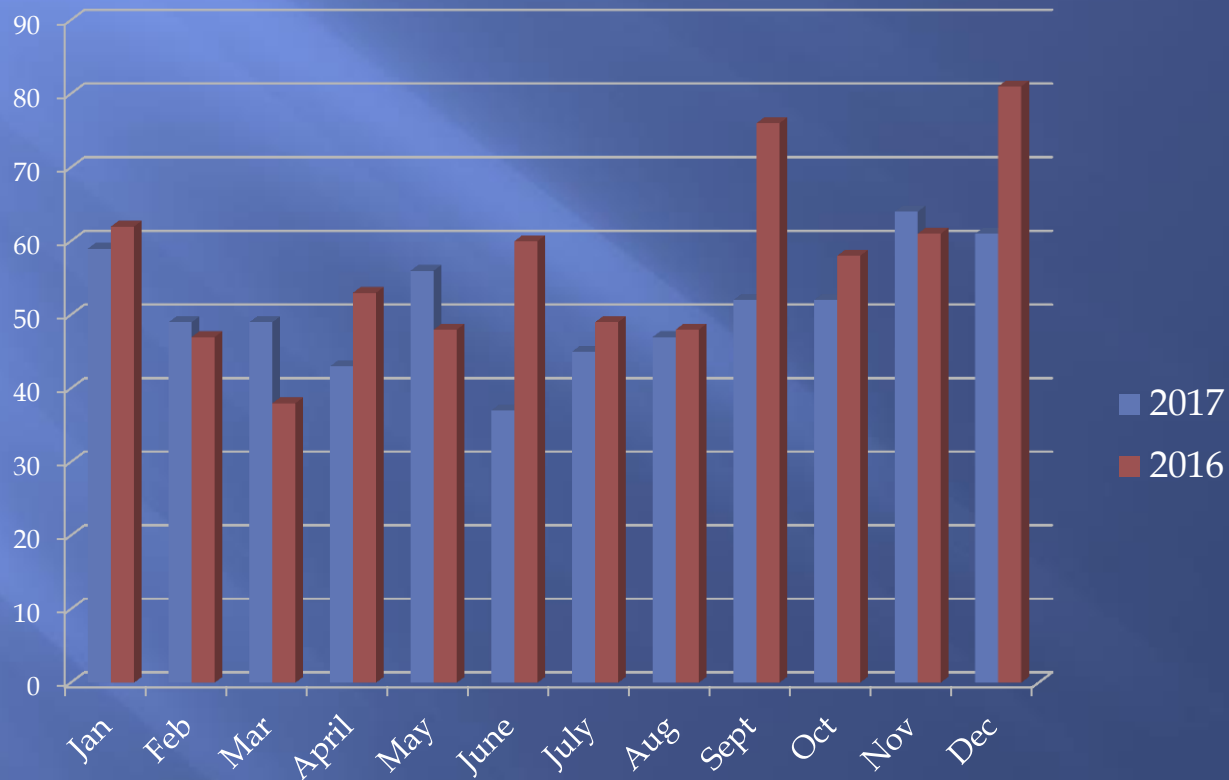

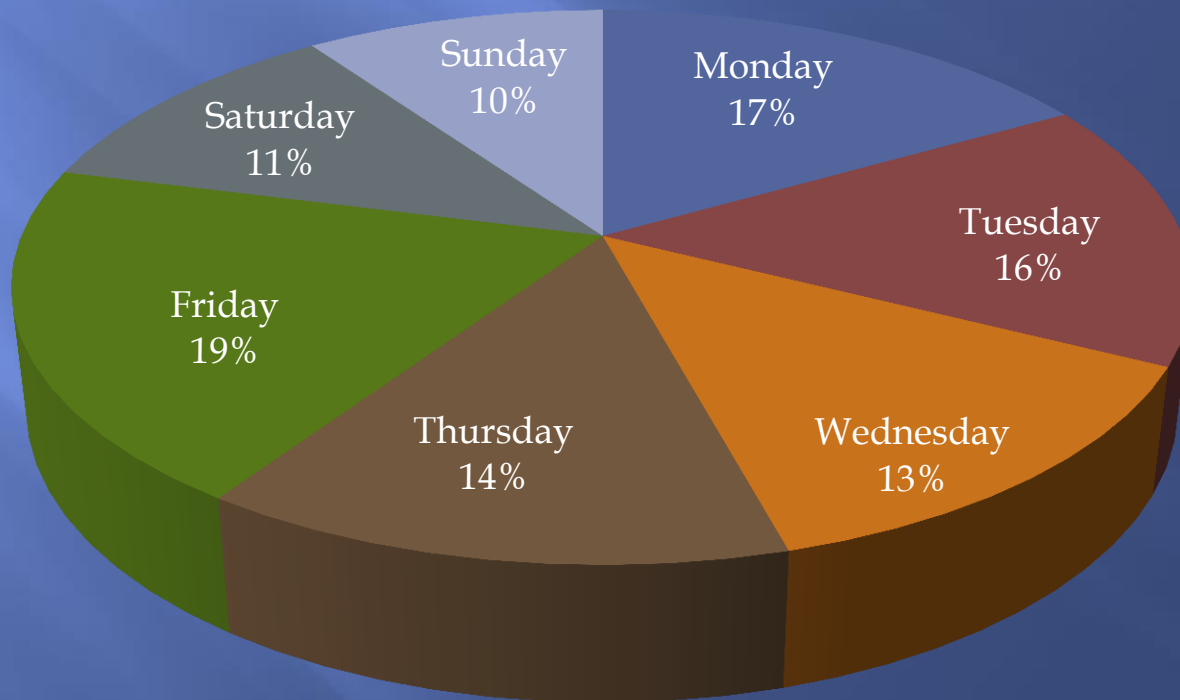

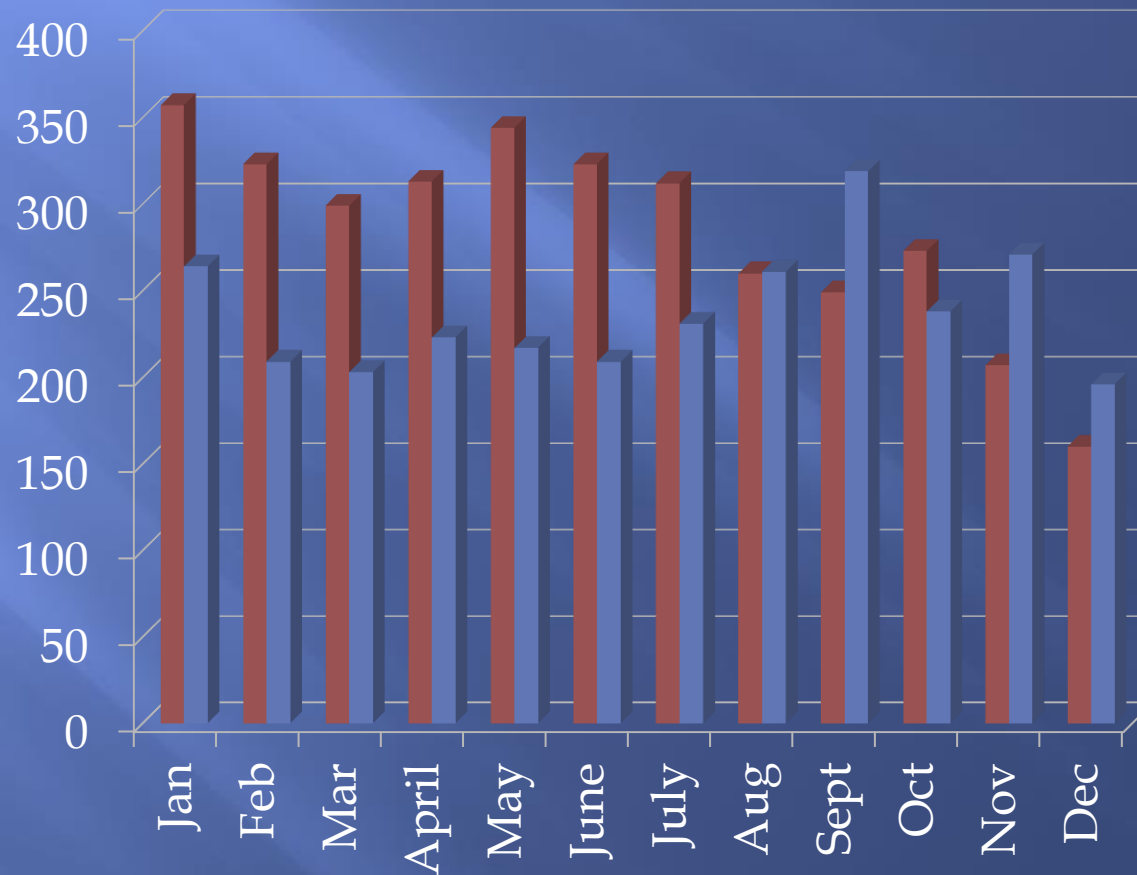

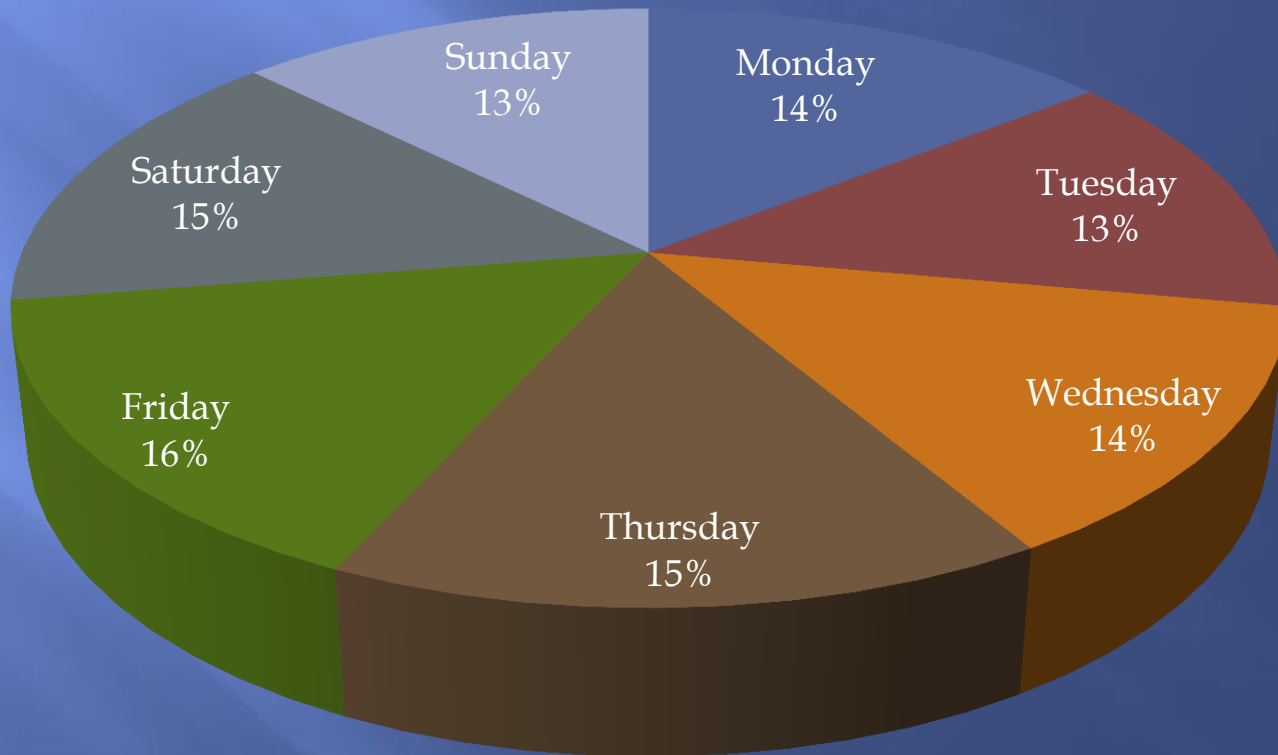

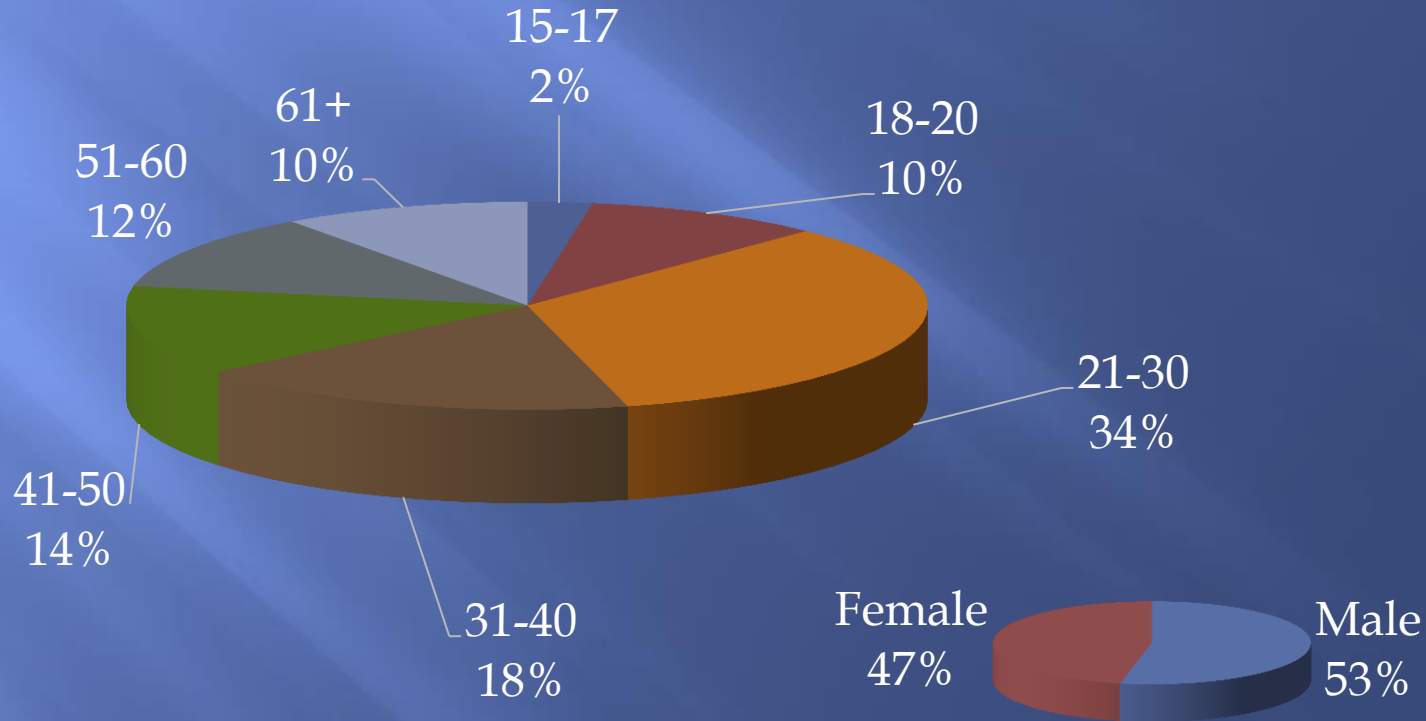
3420 Citations by Day of Week

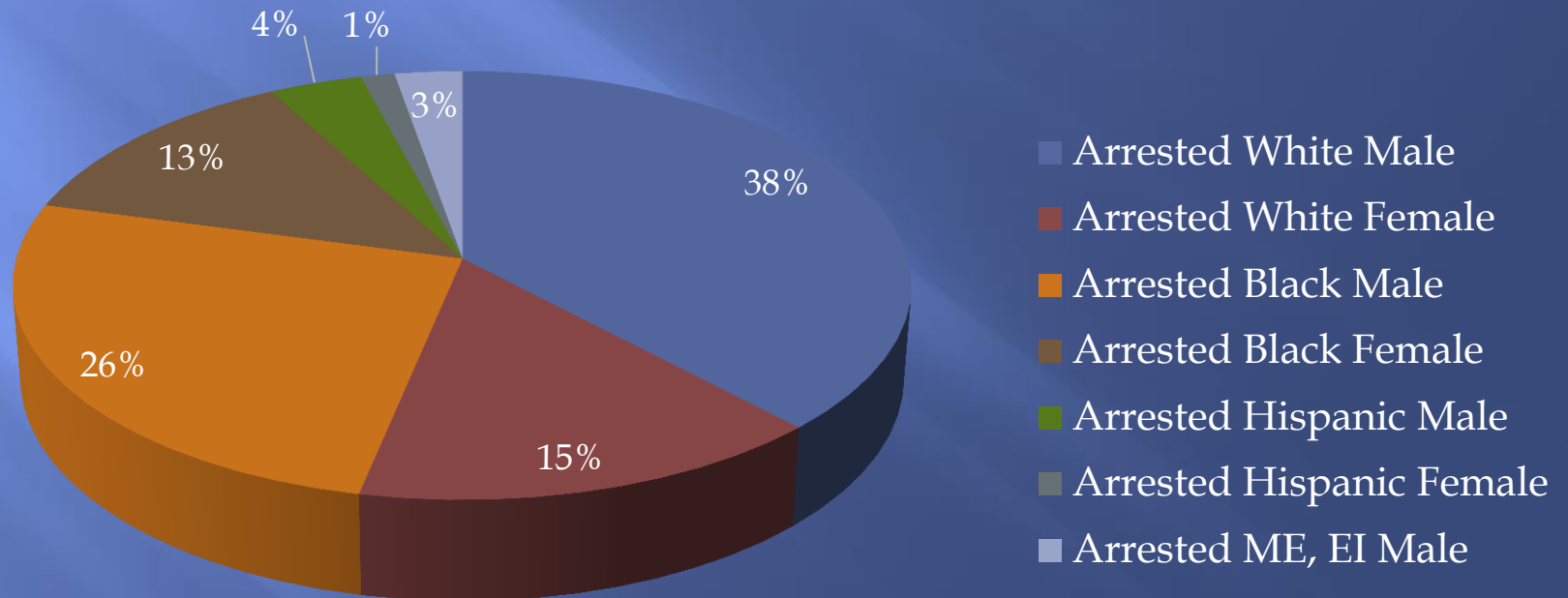
## Citations by Age

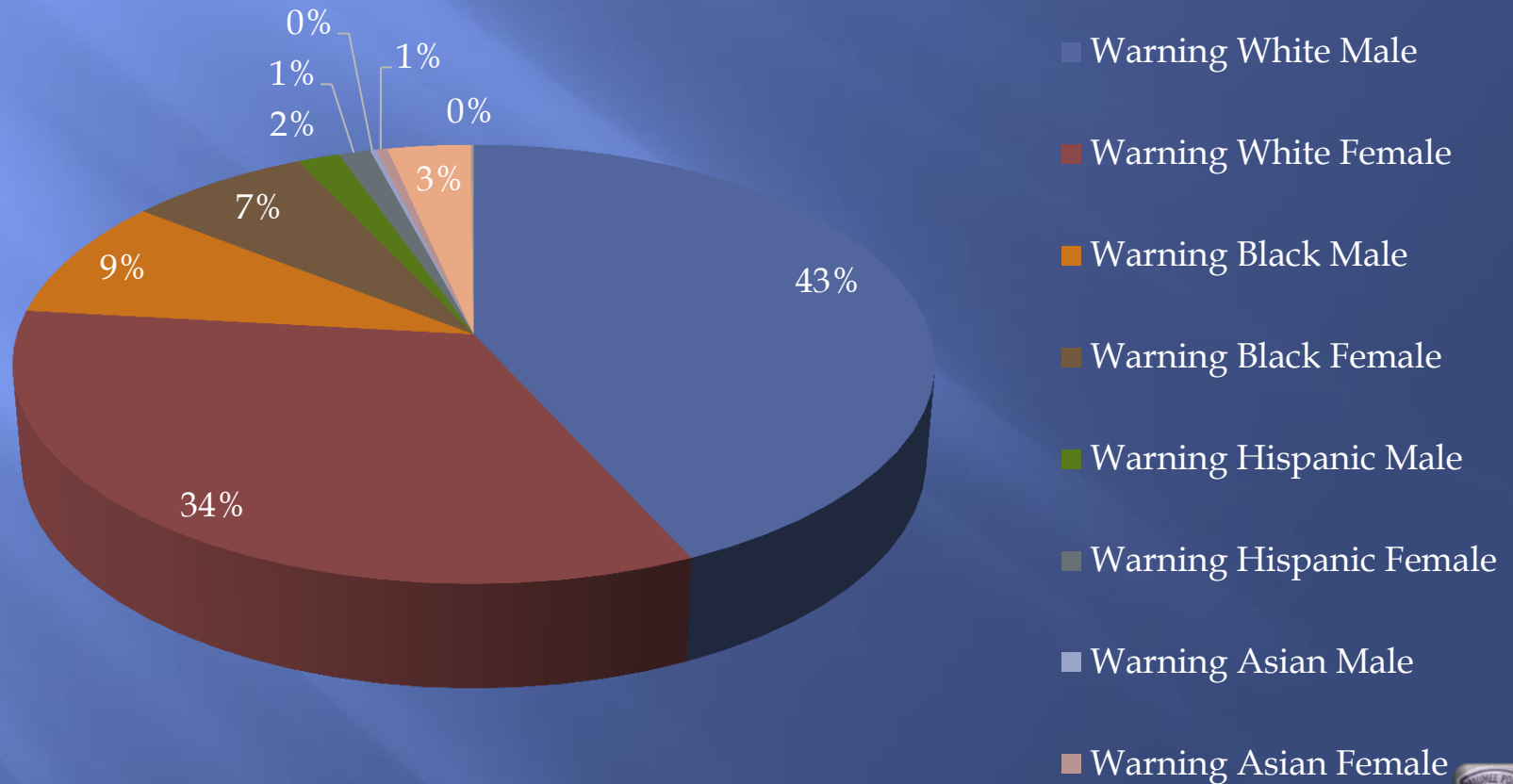

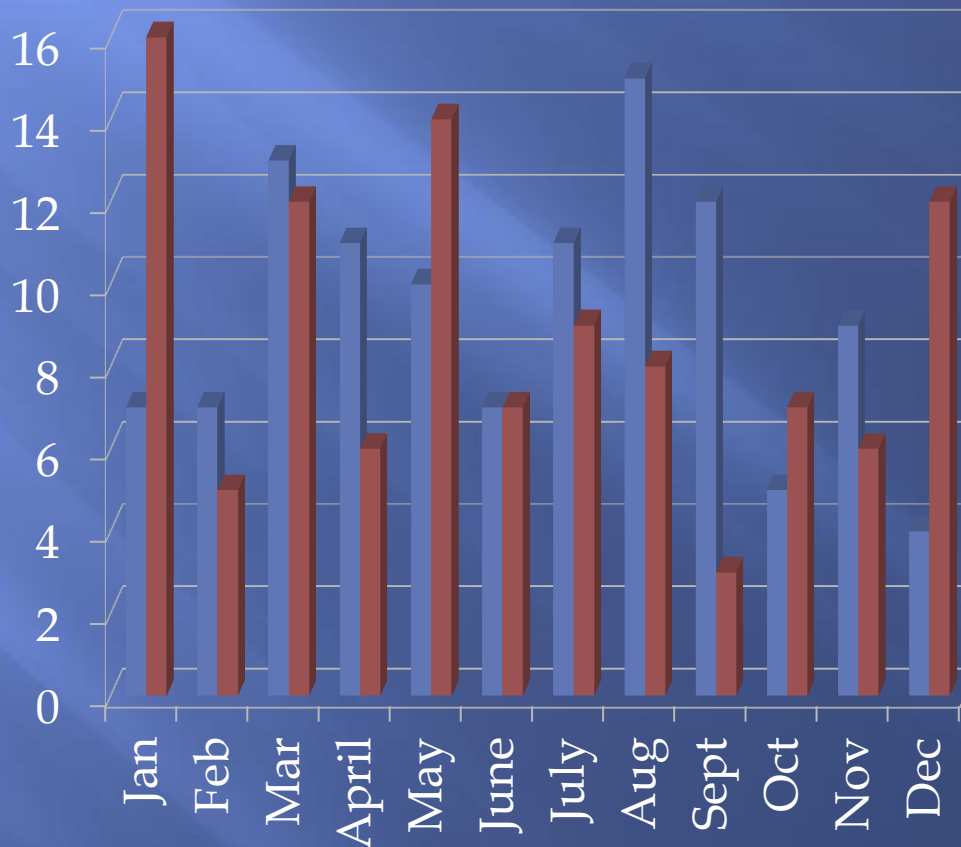

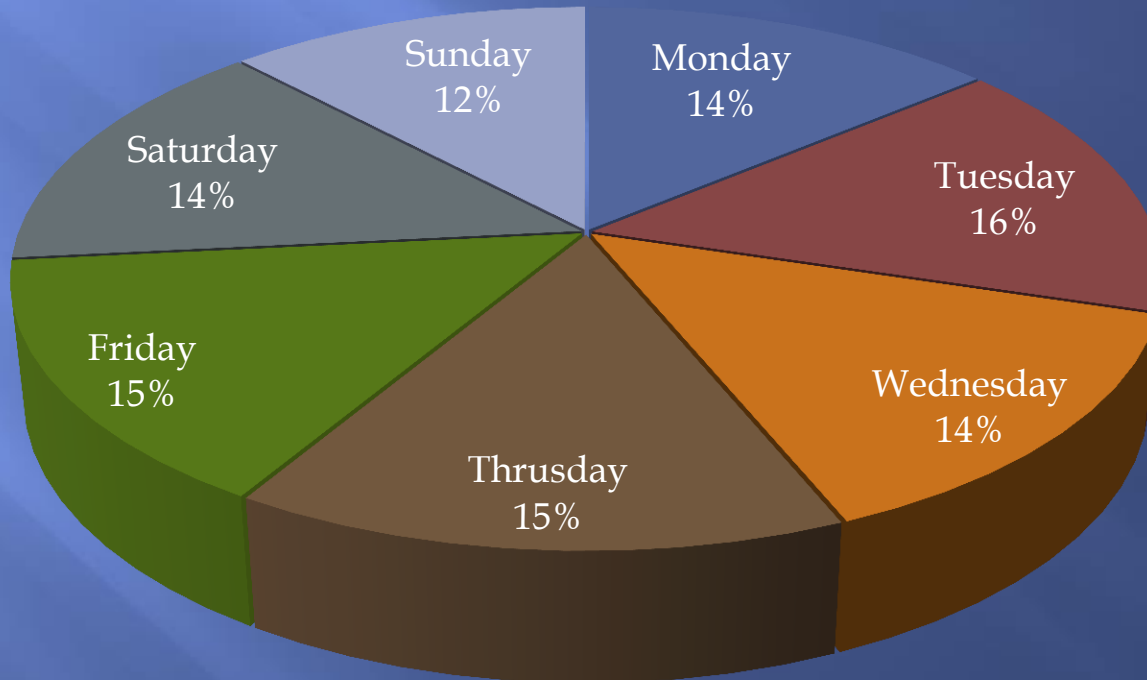

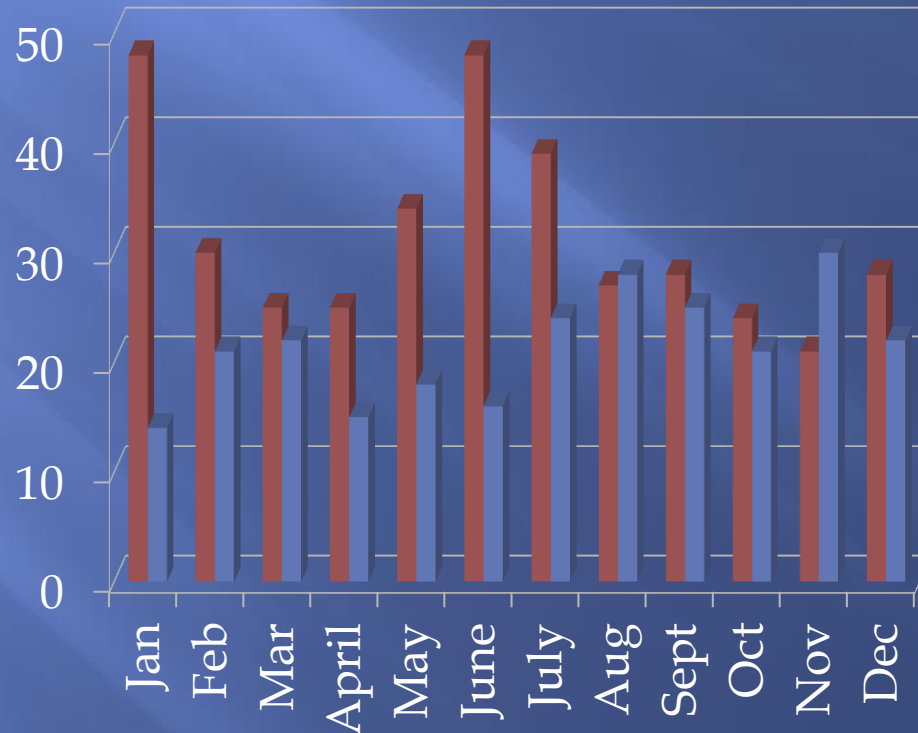

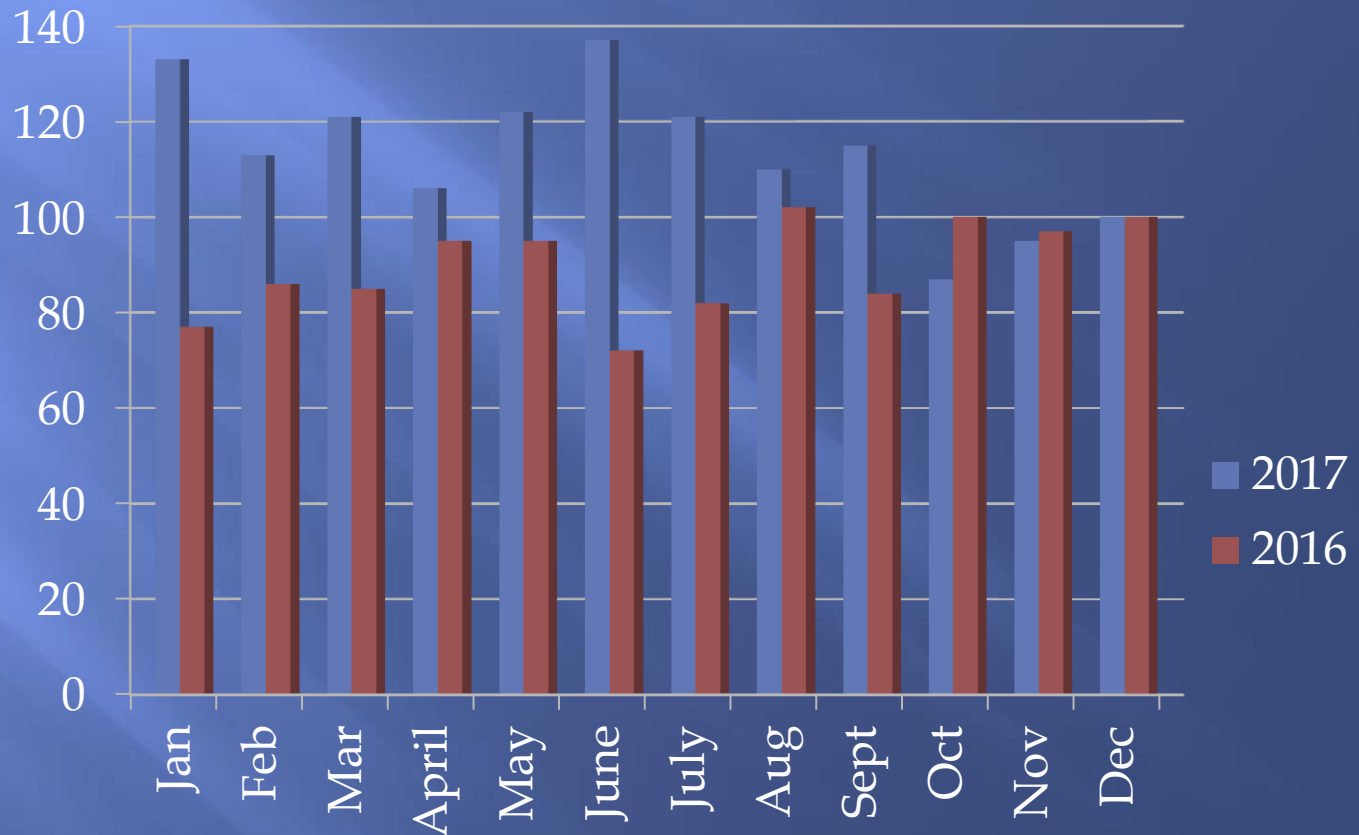

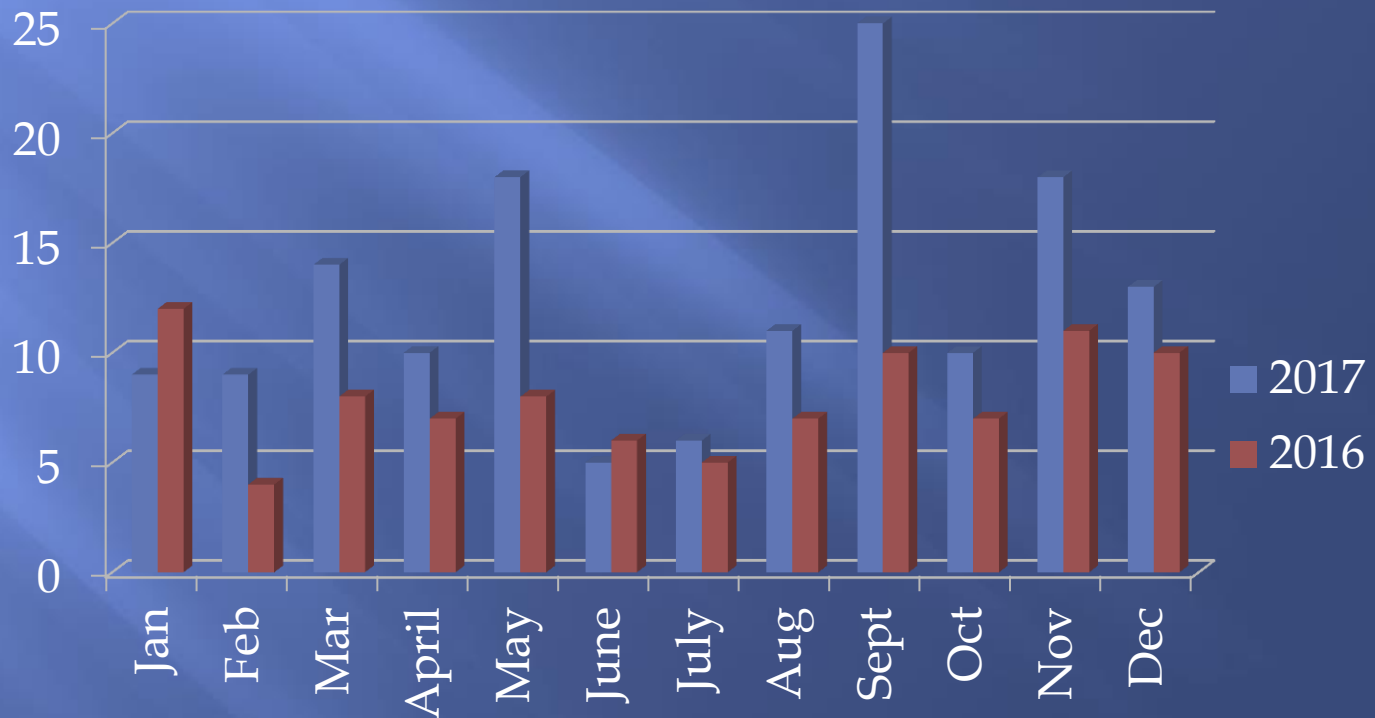

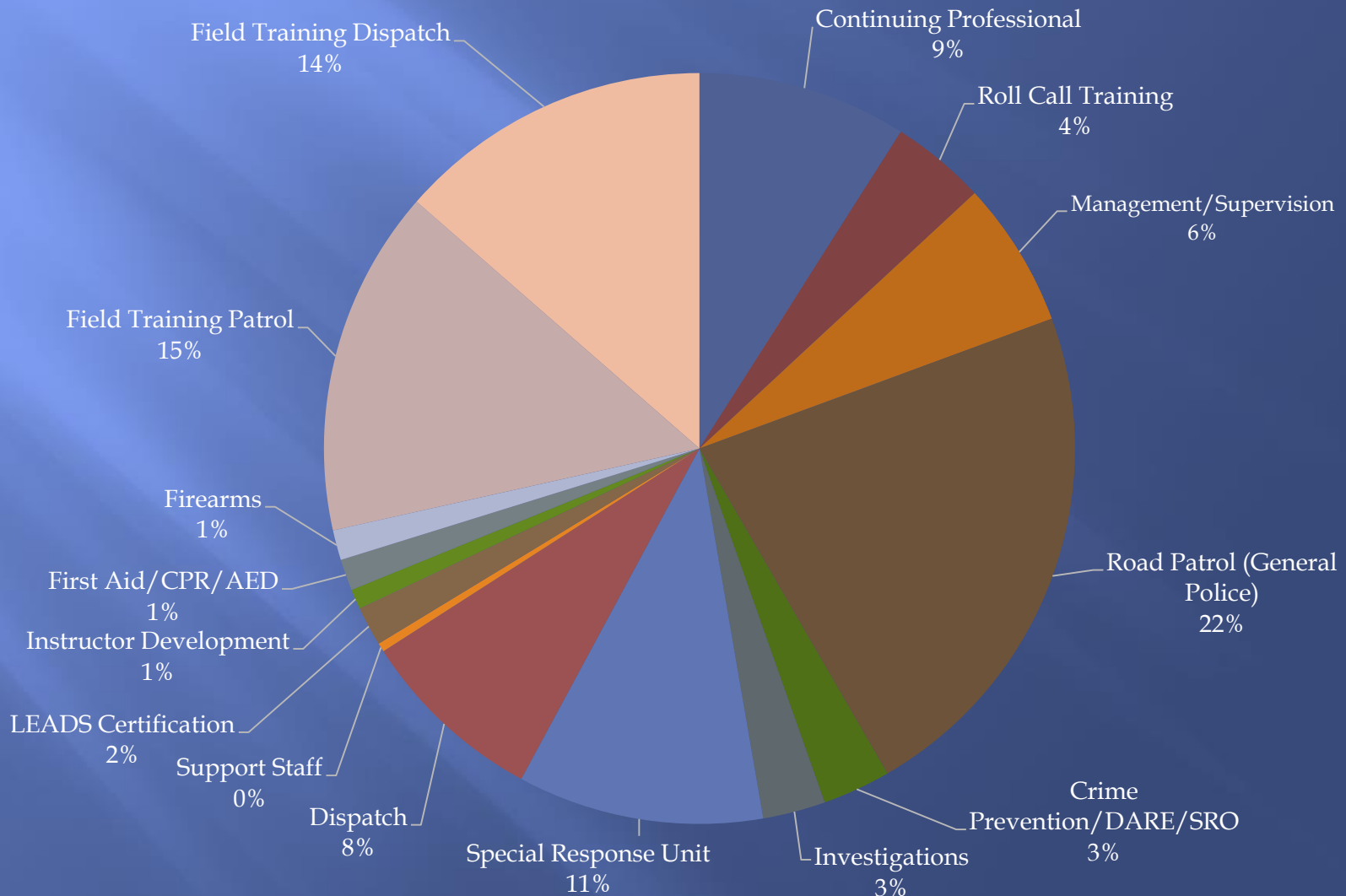

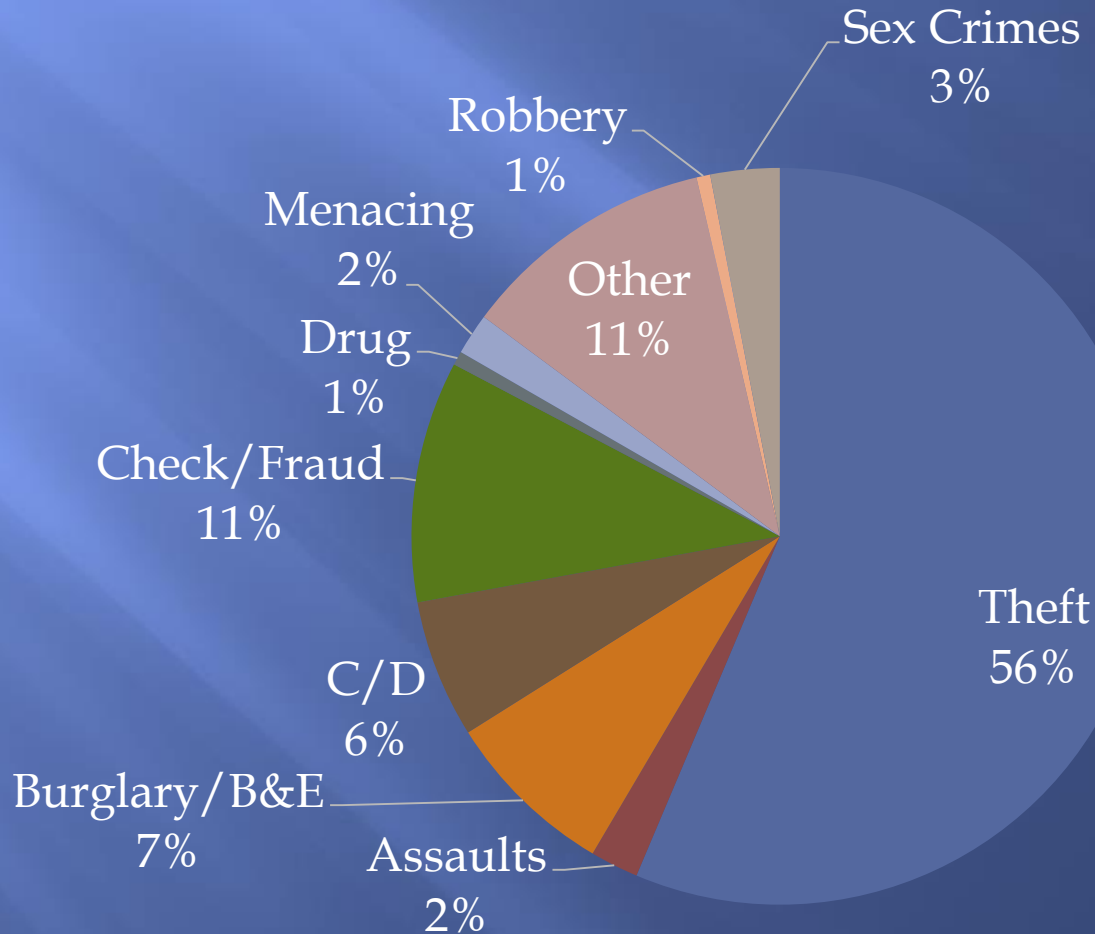

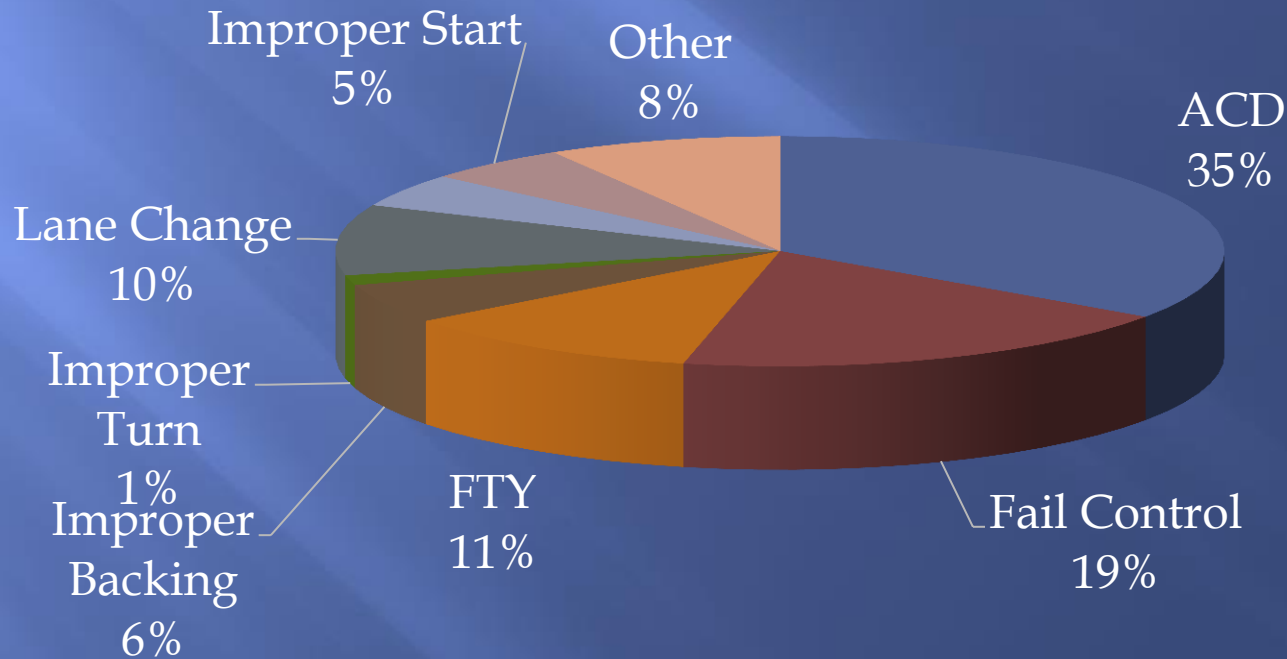
