

### SCHOOL RESOURCE OFFICER

Maumee Police continue to staff a school resource officer at the Maumee High School and another officer at Gateway Middle School. The school resource officer assists with school discipline, truancy issues and campus security. In addition, the officer builds relationships with the students, educators, administration and provides various topical lessons in the classroom.

### **BUSINESS VISITS**

The Maumee Police Chief along with the Maumee Fire Chief and Safety Director made weekly community visits to citywide small business and large corporations. It proved valuable to develop relationships and foster a networking environment with the Maumee business community.

## SPEED DETECTION TRAILER

The Maumee Police Division utilizes two mobile speed detection trailers throughout our city limits. The devices are primarily an awareness tool for the motoring public to observe their vehicle speed in comparison to the posted limit. The speed devices were deployed for a total of 9456 hours.



### MPD OVI ARRESTS:

The Police Division made 117 OVI arrests during 2018. Males comprised 70% of the arrests. Females comprised 30% of the arrests. 45% refused a breath/blood test, while 55% submitted to the requested chemical test. 89% were the result of a traffic stop, and 11% of the arrests involved a traffic crash.

### **LUCAS COUNTY OVI TASK FORCE:**

The City of Maumee received \$9210.65 of federal grant funding for MPD's participation in the Lucas County OVITF during 2018. The grant includes repayment of direct labor costs, fringe benefits and transportation / fuel costs. Officers worked 162 hours of traffic enforcement, making 191 traffic stops and issued 94 traffic citations.

MPD facilitated an OVI Checkpoint in October 2018. The event was staffed by members of the Maumee Police Division, Lucas County Sheriff's Office, Waterville Township and the Oregon Police Department. A total of 556 vehicles traveled thru the checkpoint. 541 of those vehicles were checked by officers. 28 vehicles were diverted for further investigation. Arrests and citations include: 2 Child restraint, 8 Driving Under Suspension, and 3 expired plates.



## **INTERNSHIPS:**

The Police Division facilitated six college internships for area students. These internships are geared toward allowing the student the opportunity to see firsthand all facets of police work. Students spend time with Road Patrol, Detectives, School Resource Officers, DARE/Crime Prevention. Some students also had the opportunity to participate in some of our training programs.

# Accidents

The number of accidents at the most hazardous intersection increased from 73 in 2017 to 104 in 2018. The total number of accidents in the 10 most hazardous intersections also increased, from 254 in 2017, to 262 in 2018. There is a two way tie for ninth place.

Three intersections dropped from the list this year: Anthony Wayne Trail & Ford, Conant St & Holland and Russell & Fallen Timbers.

There was one fatal accidents for 2018 that led to one death.



#### CRIME PREVENTION SPECIALIST

The Maumee Police Division maintains three officers certified as Crime Prevention Specialists. These officers maintain their certification by attending continuing education classes.

#### THE "ARE YOU OK?" PROGRAM

For twenty-nine years, the Maumee Police Division has operated the "Are You O.K.?" program. Known as R.U.O.K., the program continues to check the safety of our senior citizens as well as our hotel night clerks and gas station attendants. Each participant receives a daily or nightly call checking on his/her safety. A police crew is sent to check their safety if the call goes unanswered.

The program has helped many residents since its inception. The program then expanded to check the safety of 24-hour gas station employees and hotel desk clerks. The program currently has twelve individual subscribers, along with ten hotels and two gas stations.

Further, in 2016, a new program for Senior Citizens called the "Senior Outreach" program was created. This program involves a weekly in-person check (in the home) by a uniformed officer to ensure the needs of the senior are being met. There are currently six senior residents receiving a weekly visit. In addition, contact has been made with numerous other seniors in the community to offer our services and to give them a direct link to the police division (if ever needed).



#### CHILD SAFETY SEAT CHECKS

The Maumee Police Division has two officers that are certified technicians in child passenger restraints. They are certified through the Safe Kids Coalition Child Passenger Safety Training Program. This training enables the Maumee Police Division to provide our community with highly trained experts in the proper installation and implementation of child car seats for the safety of their children.

In 2018, thirty child safety seat checks were performed for citizens working or living within the City of Maumee.

#### **SEATBELT SAFETY**

The Crime Prevention Officer taught the "Third Grade Safety Belt Program" to all third-grade students in the Maumee School District. One hundred and seventy-two students received practical training in the Ohio Department of Public Safety education program. The program encompassed the proper use of seat belts, statistics about accidents/seatbelt usage, and information on air bags. Each child received material and information to share with their family members. As part of the program, each student was deputized as Seat Belt Deputies as they pledged to wear their seatbelts and to remind family members to wear their seatbelts as well.

### **SAFETY CITY**

The City of Maumee Safety City program celebrated its 39th year in 2018. Eighty-seven children participated in the summer program to help prepare four and five year olds to safely attend Kindergarten. Safety City consisted of classroom instruction, crafts, songs, and practical exercises in vehicle and pedestrian safety. Lessons were conducted on our miniature Safety City equipped with streets, crosswalks, traffic signals, railroad tracks, and faux buildings. Safety City consisted of 2 sessions per day over a two week period in June. The sessions lasted 2-1/2 hours each day.

The staff included two Maumee police officers, two teachers, one Maumee police dispatcher and 17 high school student volunteers. Safety City is located at Wayne Trail Elementary School.

The Maumee Police Division and the Maumee Board of Education sponsor the Safety City program.

The Maumee Municipal Court supports the program through donated products. St. Luke's Hospital Ladies Auxiliary provides each graduate of Maumee Safety City with a bicycle safety helmet. They also receive a t-shirt from the Maumee Police Division.



#### THE D.A.R.E. PROGRAM

The DARE program provides the students with the tools necessary to make the right decisions when it comes to alcohol, tobacco, other drugs, and violence. It is taught at Wayne Trail Elementary School, Gateway Middle School, and St. Joseph's Maumee School. The DARE program was taught to three-hundred and sixty-six students in the fifth and seventh grades this year.

The fifth grade program culminated with two separate graduation ceremonies. The first DARE graduation took place at the Maumee High School Performing Arts Center with the fifth-grade students of Wayne Trail Elementary. The second event occurred at St. Joseph's School Maumee.

The Maumee DARE officer also had a booth at the Maumee Uptown Fair. Many of the area DARE students attended this event along with DARE night at Ohio Skate, which provided an opportunity to reinforce the DARE drug-free choice.

Charlie's Dodge continues to kindly provide the Maumee DARE program with a donated vehicle with graphics.

The Maumee Police Division received a grant for the 2017-2018 school year from the Ohio Attorney General's Office. The awarded amount of \$18,205.60 helps to defer the cost of teaching the DARE program in the Maumee school system.



### **BIKE SAFETY**

Bike safety/education is an important part of the Maumee crime prevention program. A bike rodeo was held at Fairfield Park in May 2018. Sixty children participated in the rodeo <u>free</u> of charge. Maumee Police Division Bike Officers, Citizen Police Academy Volunteers, Safe Kids volunteers, as well as volunteers from TAB (Toledo Area Bicyclists) assisted the crime prevention staff by inspecting each bike, conducting safety checks and making repair recommendations. Cyclists participated in an agility course to test their skills. Those who attended took home a safety packet and bicycle helmets were given away free of charge to any cyclist who needed one.

The Maumee Police Division participated in the Maumee Municipal Court's "Bike Helmet Reward" Program. The Maumee Court, under the leadership of Judge Daniel G. Hazard, supplied Safety City graduates with free ice cream coupons. These coupons were meant to encourage the use of bike helmets for the youth in our community in order to prevent serious head injuries.

The Maumee Police Division continues to provide bike licenses free of charge. A licensed bike enables an owner to be identified and the bike returned when found or recovered



### **COMMUNITY WATCH MAP**

In 2017, a "Community Watch Map" was created to keep residents informed of police-related calls in our city. The Google Map can be accessed through the City of Maumee's main website. The map shows a visual icon indicating the general area where the police call was handled including but not limited to: thefts, burglaries, assaults, criminal damage calls, drug-related calls, OVI's, accidents and much more. When clicking on the icon, there is a brief synopsis of the call along with the date the call was taken and a report number. Residents are encouraged to utilize the map to stay informed and possibly provide any leads to help our department follow-up on unsolved crime. Further, officers are encouraged to use the map to identity crime trends and traffic issues in order to better focus their patrol efforts.

#### SCHOOL RESOURCE OFFICER

This was the 16<sup>th</sup> year for the School Resource Officer (SRO) Program in the City of Maumee. Officer Scott Russell worked as the primary SRO for Maumee High School. Officer Russell assisted SRO Loren Boos Gateway Middle School.

SRO Russell wrote (23) incident reports with (21) arrests during the 2018 school year. Officer Russell also received investigations from the road patrol and detective bureau for possible follow-up. Officer Russell documented two incidents of a Maumee student in mental crisis and assisted on two Maumee Fire EMS runs to the High School. Officer Russell also wrote two reports for criminal trespass due to suspicious individuals trying to gain access to the High School building or property.

SRO Russell provides insight and behavioral recommendations at the discretion of the school administrators. The SRO also meets with school administrators, counselors, the In-School Reassignment (ISR) Supervisor, and students on a daily basis.

During the 2018 school year SRO Russell assisted with A.L.I.C.E drills performed at the Maumee High School, Wayne Trail Elementary school, and Union Pre-School with teachers and staff. Those A.L.I.C.E drills included building evacuations due to a perceived interior threat, lockdown and secure in place due to an external issue, and District wide safety day where Officer Boos and Officer Russell discussed several topics on school safety.

The use of the SRO to enforce truancy within the district allows the SRO to work with school administration to assist in getting students back to school or finding alternate learning settings for them. SRO Russell attended six attendance intervention meetings and visited one student's home for truancy issues.

## Gateway Middle School Resource Officer:

The goal of the Gateway Middle School S.R.O is to develop positive student and staff relationships to facilitate open communication regarding any criminal activity or behavior that would endanger the students or staff. The relationships and trust built between the officer and students has been instrumental in identifying problems that could lead to a school or student safety concern.

Throughout the year, the Gateway Middle School School Resource Officer provided student and staff instruction on response to active threats. The Gateway Middle School S.R.O. spent time in the classrooms, teaching lessons on internet safety, refusal skills and forensic science. When violations of the law occurred within the school, the individual incidents were investigated and referrals were made to the appropriate agencies. The school resource officer works closely with the school counselors and assists in identifying and responding to mental health concerns when they pose a risk to the student's safety.

Home

Starting in August of the 2017-2018 school year, Gateway Middle School was assigned a new SRO for the building. I, Ptl. Loren Boos, became the new SRO for the middle school. I have been with the police division for 17 years, and prior to the Maumee Police Division I have worked for BGSU Police Department and Bettsville PD. Over my 17 years with the division, I have filled many rolls with the division such as: SRU (Special Response Unit) for 15 years, FTO (Field Training Officer) for 11 years, property room officer, bike patrol officer, Detective & Firearms Instructor.

As a new SRO, I have transitioned some of the drills we perform in the schools from going through the motions to ramping the drills up to make them more realistic so that the students and staff are more prepared in case of a critical incident. I have not only done this in the middle school but the two elementary schools that I am also responsible for, Fairfield Elementary and Fort Miami Elementary. All the students and staffs in all the buildings are adapting well and are learning what to do and not to do during a critical incident.

The Maumee Police Division continues the tradition of training our officers to be the very best in the area.

2018 saw another increase in the total number of training hours officers of our road patrol officers.

2018 the Police Division along with the support of our City Council, began construction of the outdoor range at Public Safety Training Center. An outdoor range will provide us with the venue to expand our firearms training program and allow our officers to experience training that cannot be replicated on an indoor range.

Police and Fire continued their training of the Rescue Task Force (RTF) model and conducted several training exercises working together on life saving skills and scene safety. Roll call training program continues to review policies and procedures with each officer and dispatcher by the shift sergeant.



We hired 3 new patrolmen who completed the 20 week field training program which is structured with specific training briefs for each day of training. The program is broken into 3 phases that has specific training categories that the probationary officer must be proficient in, before advancing into the next phase. At the end of phase 3, the probationary officer is shadowed, for 2 weeks, by the Field Training Officer, who only observes and offers no help or advice. This ensures that the probationary officer is ready to be on his own, before actually being on his own.

The Police Division added an officer and now commits two officers to the Northwest Ohio Bomb Squad, holding monthly training. We also serve as storage site for the team's equipment.

We continue our commitment to train every officer in Crisis Intervention Training (CIT). We are now hosting the 40 hour CIT training at our Mingo Training Facility several times a year.

The entire Patrol staff participated in annual Use of Force training.

We held annual firearms qualifications in several weapon platforms.



New Patrol Rifles were purchased for all of the police vehicles and all of the officers had transitional training for the new platform.

One half of the entire Division went through semi-annual First Aid training.

The Continuing Professional Training mandated by the state for 2017, had no mandates for 2018.

In 2018 we developed 2 new instructors for Subject Control, ASP, OC, and Taser. They have created a new training program that focuses on deescalating situations to result in a better outcome.

In 2018 the Special Response Unit began an 8 hour training day each month, which results in better training on more complex topics.

## **MAJOR INVESTIGATIONS**

### **Sex Crimes**

A prostitution sting was conducted at a local hotel in August, in cooperation with the FBI Northwest Ohio Violent Crimes Against Children Task Force. This initiative was an attempt to identify possible victims of human trafficking. As a result, 9 individuals were arrested for various offenses to include Soliciting, Felony Drug Possession, Possession of Drug Abuse Instruments as well as multiple outstanding warrants. No individuals were determined to be human trafficking victims.

## Rape

There were six (6) reported cases of rape investigated by the detective bureau. Two (2) cases resulted in the arrest and conviction of the suspect. One (1) case was closed due to the victim refusing to cooperate. Prosecution was denied on two (2) cases and the remaining case (1) was determined to be unfounded.

## Sexual Assault

There were two (2) sexual assault cases investigated by the detective bureau. One (1) case was cleared by arrest. One (1) case was cleared by exception due to several factors.

## **Missing Persons**

Three (3) missing person cases were investigated by the detective bureau, one involving a juvenile. All subjects reported missing were located. Foul play was not a factor in any of the cases.

## Robbery

There were two (2) robbery cases investigated by the detective bureau, one of which was an aggravated robbery. A deadly weapon was brandished; however the victim/employee did not suffer any physical harm. This case was closed after all leads were exhausted and the suspect currently remains unidentified. The remaining robbery that was investigated involved a suspect who had demanded money from the victim (no weapon). A week after the offense occurred, the suspect was identified and arrested.

## Residential Burglary

Fourteen (14) residential burglary cases were assigned to the detective bureau for further investigation. Four (4) were cleared by arrest, four (4) cases were closed after all investigative leads had been exhausted and two (2) were closed either due to a lack of leads/evidence or insufficient evidence that the crime occurred. Three (3) cases were determined to be unfounded and one (1) case remains under investigation.

## **Breaking and Entering**

Sixteen (16) breaking and entering cases were investigated by the detective bureau. One (1) case was cleared by arrest. Seven (7) cases were closed due to a lack of evidence/leads. Six (6) were closed after all investigative leads were exhausted and two (2) remain under investigation.

### Theft

One hundred fifty-three (153) theft cases were assigned to the detective bureau for investigation. Of these, forty-nine (49) cases were cleared by arrest or exceptional means. Ninety (90) cases were closed due to either a lack of investigative leads, exhaustion of investigative leads, referred to another agency or determined to be unfounded. Fourteen (14) cases are currently under investigation.

#### Fraud

Twenty-eight (28) fraud cases were assigned to the detective bureau. Of these, ten (10) cases were cleared. Eighteen (18) cases were closed due to either a lack of investigative leads, exhaustion of investigative leads or referred to another law enforcement organization.

### **Alcohol Sales-Minors**


In July, the detective bureau conducted an alcohol compliance check of applicable businesses. An underage adult was utilized to accomplish this task. The underage adult attempted to purchase alcoholic beverages from each permit holder and was unsuccessful at each attempt. Every business was found to be in strict compliance, therefore preventing the sale of alcohol to an underage person.

## Summary

In 2018 the detective bureau investigated a total of 275 offenses that were reported to have occurred in the City of Maumee. Of those, 17 remain under investigation. Of the remaining 258 closed cases, 103 were cleared by arrest or exceptional means (39.9%), 113 were closed due to the lack of, or exhaustion of investigative leads (43.7%). There were 12 cases closed by referral to another law enforcement agency or determined to be unfounded (4.6%). The remaining cases were closed due to the victim failing to cooperate, the death of the offender, or prosecution being declined. The majority of cases assigned to the detective bureau were theft offenses (153) which totaled 55.6% of all criminal investigations for the year.






Motor Vehicle Crash Reports By Month




3019 Citations by Day of Week










Types of Cases Assigned Total of 277 Cases
