



SCHOOL RESOURCE OFFICER

Maumee Police continue to staff a school resource officer at the Maumee High School and another officer at Gateway Middle School. The school resource officer assists with school discipline, truancy issues and campus security. In addition, the officer builds relationships with the students, educators, administration and provides various topical lessons in the classroom.

BUSINESS VISITS

The Maumee Police Chief along with the Maumee Fire Chief and Safety Director made weekly community visits to citywide small business and large corporations. It proved valuable to develop relationships and foster a networking environment with the Maumee business community.

SPEED DETECTION TRAILER

The Maumee Police Division utilizes two mobile speed detection trailers throughout our city limits. The devices are primarily an awareness tool for the motoring public to observe their vehicle speed in comparison to the posted limit. The speed devices were deployed for 218 days each, for a total of 10,464 hours.



MPD OVI Arrests:

The Police Division made 140 OVI arrests during 2019. Males comprised of 77% of the arrests. Females comprised 23% of the arrests. 32% refused a breath/urine/blood test, while 68% submitted to the requested chemical test. 79% were the result of a traffic stop, and 12% of the arrests involved a crash. 9% were discovered from miscellaneous calls for service.

Lucas County OVI Task Force:

The City of Maumee received \$7,561.39 of federal grant funding for MPD's participation in the Lucas County OVITF during 2019. The grant includes repayment of direct labor costs, fringe benefits and transportation/fuel costs. Officers worked 132 hours of traffic enforcement, making 167 traffic stops and issued 57 traffic citations.

MPD Facilitated an OVI checkpoint in November of 2019. The event was staffed by members of the Maumee Police Division and Lucas County Sheriff's Office. A total of 530 vehicles traveled thru the checkpoint. 423 of those vehicles were checked by officers. 41 vehicles were diverted for further investigation. Arrests and citations include: 2 citations for no driver's license, 3 Driving Under Suspension, 2 Expired Plates, 2 warrant arrests and 3 OVI arrests.

Internships:

The Police Division facilitated six college and one high school internship for area students. The internships provided by Maumee PD allow the students to observe firsthand the all that encompasses police work. The students rotate their time between Road Patrol, Detective Bureau, School Resource Officers, DARE/Crime Prevention and shadowing the SRU team. Students were also able to participate with internal training here at the Police Division.

Accidents

The number of accidents at the most hazardous intersection decreased from 104 in 2018 to 36 in 2019. The total number of accidents in the 10 most hazardous intersections also decreased from 262 in 2018, to 200 in 2019.

Three intersections dropped from the list this year: Anthony Wayne Trail & Michigan, Anthony Wayne Trail & Detroit and Russell & Dussel Dr & Holland.

There were no fatal crashes in 2019.



CRIME PREVENTION SPECIALIST

The Maumee Police Division maintains two officers certified as Crime Prevention Specialists. These officers maintain their certification by attending continuing education classes.

THE "ARE YOU OK?" PROGRAM

For thirty years, the Maumee Police Division has operated the "Are You O.K.?" program. Known as R.U.O.K., the program continues to check the safety of our senior citizens as well as our hotel night clerks and gas station attendants. Each participant receives a daily or nightly call checking on his/her safety. A police crew is sent to check their safety if the call goes unanswered.

The program has helped many residents since its inception. The program then expanded to check the safety of 24-hour gas station employees and hotel desk clerks. The program currently has fourteen individual subscribers, along with ten hotels and two gas stations.

Further, in 2016, a new program for Senior Citizens called the "Senior Outreach" program was created. This program involves a weekly in-person check (in the home) by a uniformed officer to ensure the needs of the senior are being met. There are currently six senior residents receiving a weekly visit. In addition, contact has been made with numerous other seniors in the community to offer our services, give referral sources and to provide them a trustworthy link to the police division (if ever needed).



CHILD SAFETY SEAT CHECKS

The Maumee Police Division has three officers that are certified technicians in child passenger restraints. They are certified through the Safe Kids Coalition Child Passenger Safety Training Program. This training enables the Maumee Police Division to provide our community with highly trained experts in the proper installation and implementation of child car seats for the safety of their children.

In 2019, thirty-one child safety seat checks were performed for citizens working or living within the City of Maumee.

SEATBELT SAFETY

The Crime Prevention Officer taught the "Third Grade Safety Belt Program" to all third-grade students in the Maumee School District. One hundred and fifty-six students received practical training in the Ohio Department of Public Safety education program. The program encompassed the proper use of seat belts, statistics about accidents/seatbelt usage, and information on air bags. Each child received material and information to share with their family members. As part of the program, each student was deputized as Seat Belt Deputies as they pledged to wear their seatbelts and to remind family members to wear their seatbelts as well.

SAFETY CITY

The City of Maumee Safety City program celebrated its 40th year in 2019. Sixty-seven children participated in the summer program to help prepare four and five year olds to safely attend Kindergarten. Safety City consisted of classroom instruction, crafts, songs, and practical exercises in vehicle and pedestrian safety. Lessons were conducted on our miniature Safety City equipped with streets, crosswalks, traffic signals, railroad tracks, and faux buildings. Safety City took place at Wayne Trail Elementary School and consisted of two sessions per day over a two-week period in the month of June. Each session lasted 2-1/2 hours each day.

The staff included four Maumee police officers, two teachers, one Maumee police dispatcher and 16 student volunteers (14 from Maumee HS, 1 from Anthony Wayne HS & 1 college intern from BGSU).

The Maumee Police Division and the Maumee Board of Education sponsor the Safety City program. The Maumee Municipal Court supports the program through donated products. St. Luke's Hospital Ladies Auxiliary provides each graduate of Maumee Safety City with a bicycle safety helmet. They also receive a

t-shirt from the Maumee Police Division.



THE D.A.R.E. PROGRAM

The DARE program provides the students with the tools necessary to make the right decisions when it comes to alcohol, tobacco, other drugs, and violence. It is taught at Wayne Trail Elementary School, Gateway Middle School, and St. Joseph's Maumee School. The DARE program was taught to four-hundred and thirteen students in the fifth and seventh grades this year.

The fifth grade program culminated with two separate graduation ceremonies. The first DARE graduation took place at the Maumee High School Performing Arts Center with the fifth-grade students of Wayne Trail Elementary. The second event occurred at St. Joseph's School Maumee.

The Maumee DARE officer also had a booth at the Maumee Uptown Fair. Many of the area DARE students attended this event along with DARE night at Ohio Skate, which provided an opportunity to reinforce the DARE drug-free choice.

Charlie's Dodge continues to kindly provide the Maumee DARE program with a donated vehicle with graphics. The Jeep Cherokee (green) was changed out for a 2019 Jeep Compass Renegade (black) in November 2019 with eye-catching new graphics that include the Maumee panther.

The Maumee Police Division received a grant for the <u>2018-2019</u> school year from the Ohio Attorney General's Office. The awarded amount of **\$18,594.16** helps to defer the cost of teaching the DARE program in the Maumee school system.



BIKE SAFETY

Bike safety/education is an important part of the Maumee crime prevention program. A bike rodeo was held at Fairfield Park in May 2019. Due to rainy weather during set-up time, forty children participated in the rodeo <u>free</u> of charge this year. The rodeo started with volunteers from TAB (Toledo Area Bicyclists) assisting the crime prevention staff by inspecting each bike, conducting safety checks and making repair recommendations. Next, cyclists received a free bike helmet (if needed) and participated in an agility course to test their skills with the assistance of the Maumee Police Division Bicycle Officers. Finally, the Citizen's Police Academy graduates assisted in many other aspects of the rodeo including passing out safety packets to all who attended.

Also, the Maumee Police Division participated in the Maumee Municipal Court's "Bike Helmet Reward" Program. The Maumee Court, under the leadership of Judge Daniel G. Hazard, supplied Safety City graduates with free ice cream coupons. These coupons were meant to encourage the use of bike helmets for the youth in our community in order to prevent serious head injuries.

The Maumee Police Division continues to provide bike licenses free of charge. A licensed bike enables an owner to be identified and the bike returned when found or recovered.



COMMUNITY WATCH MAP

In 2017, a "Community Watch Map" was created to keep residents informed of police-related calls in our city. The Google Map can be accessed through the City of Maumee's main website. The map shows a visual icon indicating the general area where the police call was handled including but not limited to: thefts, burglaries, assaults, criminal damage calls, drug-related calls, OVI's, accidents and much more. When clicking on the icon, there is a brief synopsis of the call along with the date the call was taken and a report number. Residents are encouraged to utilize the map to stay informed and possibly provide any leads to help our department follow-up on unsolved crime. Further, officers are encouraged to use the map to identity crime trends and traffic issues in order to better focus their patrol efforts.

This was the 17th year for the School Resource Officer (SRO) Program in the City of Maumee. Officer Scott Russell worked as the primary SRO for Maumee High School. Officer Russell assisted SRO Loren Boos Gateway Middle School.

SRO Russell responded to 28 calls for service during the 2019 school year. Officer Russell also received investigations from the road patrol and detective bureau for possible follow-up. Officer Russell documented incidents of a Maumee student in mental crisis and assisted on Maumee Fire EMS runs to the High School.

SRO Russell provides insight and behavioral recommendations at the discretion of the school administrators. The SRO also meets with school administrators, counselors, the In-School Reassignment (ISR) Supervisor, and students on a daily basis.

During the 2019 school year SRO Russell assisted with A.L.I.C.E drills performed at the Maumee High School, Wayne Trail Elementary school, and Union Pre-School with teachers and staff. Those A.L.I.C.E drills included building evacuations due to a perceived interior threat, lockdown and secure in place due to an external issue, and District wide safety day where Officer Boos and Officer Russell discussed several topics on school safety.

The use of the SRO to enforce truancy within the district allows the SRO to work with school administration to assist in getting students back to school or finding alternate learning settings for them. SRO Russell attended eight attendance intervention meetings during 2019 school year.

SRO Russell has been able to assist elementary school principals in situations ranging from consultations with students, safety/security issues and investigations of criminal complaints, parking complaints, and parent complaints.

The SRO has become an important resource for school administration, staff, and the students of the district. The visibility created by the SRO and the positive interaction with the staff and students of the district has continued to create a positive image of the Maumee Police Department. The SRO position has also continued to be a great tool in gathering information about criminal activity within the City of Maumee.

Gateway Middle School Resource Officer:

The goal of the Gateway Middle School S.R.O is to develop positive student and staff relationships to facilitate open communication regarding any criminal activity or behavior that would endanger the students or staff. The relationships and trust built between the officer and students has been instrumental in identifying problems that could lead to a school or student safety concern.

Throughout the year, the Gateway Middle School School Resource Officer provided student and staff instruction in response to active threats. The Gateway Middle School S.R.O. spent time in the classrooms, teaching lessons on internet safety, refusal skills and forensic science. When violations of the law occurred within the school, the individual incidents were investigated and referrals were made to the appropriate agencies. The school resource officer works closely with the school counselors and assists in identifying and responding to mental health concerns when they pose a risk to the student's safety.

During 2019, the Gateway Middle School Resource Officer gave Gateway Middle School, Ft. Miami Elementary and Fairfield Elementary instruction in the A.L.I.C.E (Alert, Lockdown, Inform, Counter, Evacuate) program. State mandated safety drills were conducted at all of the schools.

When the schools were not in session, "Run, Hide, Fight" active threat training was given to local businesses at their request. I was able to go into several businesses throughout Maumee and give active threat presentations. The feedback was tremendous and the need and requests for more businesses are increasing for the summer time.

The middle school resource officer assisted in instructing at the two-week long Maumee Safety City Program. For the remainder of the summer, when school was not in session, the SRO from Gateway Middle School and the High School, for the first time ever, arranged for community organized events with the students from the high school and middle school aged kids. These events consisted of three different events, all being held on Gateway Middle School grounds, which were, a kickball tournament, a cornhole tournament and a wiffle ball tournament. We received very good turnouts and they will be returning this summer as well.



Home

Starting in August of the 2017-2018 school year, Gateway Middle School was assigned a new SRO for the building. I, Ptl. Loren Boos, became the new SRO for the middle school. I have been with the police division for 17 years, and prior to the Maumee Police Division I have worked for BGSU Police Department and Bettsville PD. Over my 17 years with the division, I have filled many rolls with the division such as: SRU (Special Response Unit) for 15 years, FTO (Field Training Officer) for 11 years, property room officer, bike patrol officer, Detective & Firearms Instructor. As a new SRO, I have transitioned some of the drills we perform in the schools from going through the motions to ramping the drills up to make them more realistic so that the students and staff are more prepared in case of a critical incident. I have not only done this in the middle school but the two elementary schools that I am also responsible for, Fairfield Elementary and Fort Miami Elementary. All the students and staffs in all the buildings are adapting well and are learning what to do and not to do during a critical

incident.

The Maumee Police Division continues the tradition of training our officers to be the very best in the area through a plethora of training opportunities.

2019 had a significant increase in the total hours of training department wide with an increase of 1,673.75 hours.

2019 the police division continued to provide area businesses with Active Shooter training free of charge. This training helps to create stronger bonds between the community businesses and police department.

In 2019 we hired 3 new Patrolman, who each completed the 20 week field training program which is structured with specific training briefs for each day of training. The program is broken into three phases that has specific training categories that the probationary officer must be proficient in, before advancing to the next phase of training. At the conclusion of phase three, the probationary officer is shadowed, for two weeks, by the Field Training Officer, who only observes and offers no help or advice. This ensures that the probationary officer is ready to be on his/her own, before officially being released from the program.



The Division continued to get our newer officers trained as Crisis Intervention Officers through (CIT) training. We currently hold a CIT course at our facilities each year. As a department we will now be hosting OPOTA certified training courses here at our facilities. This allows for our officers to take part in some of Ohio's best Law Enforcement training.

In 2019 the police division also welcomed 2 new full time dispatchers to the division. The dispatchers, like the new patrol hires, go through a vigorous field training program to ensure that they are capable of performing dispatching duties.

The entire Patrol Staff participated in annual Use of Force training held at the Police Department.

Officers also received force on force training which is practical training, using Simunition gear and equipment. This training puts officers through real life scenarios in which they interact with human actors.

We held several firearms qualifications in multiple weapon platforms.

New laser systems and holsters were purchased for the division and transitional training was completed for proper use of the equipment.

One half of the Police Division completed mandatory semi-annual 1st Aid training.

The School Resource Officers' held three different days during the summer for fun activities with the kids of the Maumee community to engage in. The events were prepared by the School Resource Officers' planned two kickball tournaments and a corn hole tournament.

MAJOR INVESTIGATIONS

Homicide

One (1) aggravated murder case was investigated by the detective bureau. This case currently remains under investigation. The last incident of this nature occurred in 2002.

Rape

There were five (5) reported cases of rape investigated by the detective bureau. Prosecution was denied on three (3) cases. One (1) case was closed due to the victim refusing to cooperate. One (1) case is currently under investigation.

Sexual Assault

There were four (4) sexual assault cases investigated by the detective bureau. One (1) case was cleared by arrest. One (1) case was cleared by exception due to several factors. Prosecution was denied one (1) case and the remaining case is currently under investigation.

Missing Persons

Two (2) missing person cases were investigated by the detective bureau, one involving a juvenile. Both were located and no foul play was involved.



Robbery

There were three (3) robbery cases investigated by the detective bureau, one of which was an aggravated robbery. A deadly weapon was brandished; however the victim/employee did not suffer any physical harm. This case is still under investigation. One (1) case (no weapon) was cleared by arrest, and the remaining case was closed due to a lack of cooperation of the victim.

Breaking and Entering

Five (5) breaking and entering cases were investigated by the detective bureau. Three (3) cases were cleared by exception. One (1) case was closed due to a lack of evidence/leads and one (1) remains under investigation.

Theft

One hundred sixty-seven (167) theft cases were assigned to the detective bureau for investigation. Of these, forty-four (44) cases were cleared by arrest and twenty-six (26) by exceptional means. Seventy-one (71) cases were closed due to either a lack of investigative leads, exhaustion of investigative leads, or referred to another agency due to jurisdiction/venue. Six (6) cases were determined to be unfounded and the victim refused to cooperate in five (5) cases. Prosecution was denied on two (2) cases and thirteen (13) are currently under investigation.



Fraud


Twenty-one (21) fraud cases were assigned to the detective bureau. Of these, seven (7) cases were cleared. Eight (8) cases were closed due to either a lack of investigative leads, exhaustion of investigative leads or referred to another law enforcement organization. Two (2) cases were determined to be unfounded and four (4) cases are currently under investigation.

Summary

In 2019 the detective bureau investigated a total of 318 offenses that were reported to have occurred in the City of Maumee. Of those, 42 remain under investigation. Of the remaining 276 closed cases, 105 were cleared by arrest or exceptional means (37%). 131 were closed due to the lack of, or exhaustion of investigative leads (41%). There were 6 cases closed by referral to another law enforcement agency (2%) or determined to be unfounded (3%). The remaining cases were closed due to the victim failing to cooperate, the death of the offender, or prosecution being declined. The majority of cases assigned to the detective bureau were theft offenses (167) which totaled 52.5% of all criminal investigations for the year.




