ORDINANCE NO. 004 - 2023

AN ORDINANCE ENACTING ZONING FOR CERTAIN REAL PROPERTY WITHIN THE CITY OF MAUMEE, AND DECLARING AN EMERGENCY.

WHEREAS, certain real property was annexed into the City of Maumee and Council is required to establish zoning for said real property;

WHEREAS, the Maumee Planning Commission has met and recommended that this real property be zoned R-4.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Maumee, Ohio that:

SECTION 1. The City of Maumee, Ohio hereby adopts and enacts R-4 zoning for the following real estate:

SEE EXHIBIT A ATTACHED HERETO AND INCORPORATED HEREIN BY REFERENCE.

SECTION 2. This Ordinance is declared to be an emergency measure immediately necessary to preserve the public interest and for the health, safety and welfare of the citizens of the City of Maumee, and more specifically to allow for the immediate update of the zoning code so as to allow development of the subject property to proceed in a timely manner which will be a benefit for the citizens of Maumee, wherefore this ordinance will go into immediate effect upon its adoption by council

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Revised Code of Ohio.


