

ORDINANCE NO. 022-2023

AN ORDINANCE AMENDING ORDINANCE 030-2022 AND ESTABLISHING BASIS FOR ALLOCATION OF ASSESSMENTS FOR COSTS OF LIGHTING THE STREETS AND PUBLIC WAYS IN THE CITY OF MAUMEE, OHIO, AND DECLARING AN EMERGENCY

WHEREAS the City of Maumee establishes rates on an annual basis for street lighting within the City of Maumee; WHEREAS the methods for determining and assessing the cost have previously been established by prior Ordinances. NOW THEREFORE, BE IT ORDAINED by the Council of the City of Maumee, Lucas County Ohio, all members elected thereto concurring and as follows:

SECTION 1. The assessments for street lighting, the rates and criteria for determining assessments for the cost and expense of lighting the streets and public ways in the City of Maumee, Ohio, for 2023 and thereafter until amended be, and the same hereby are, approved, confirmed adopted and amended as set forth below:

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any if its committees that resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Revised Code of Ohio.

SECTION 3. This Ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately from and after its passage. The reason for the emergency lies in the fact that this Ordinance is necessary for the immediate preservation of the public peace, health and safety in that said criteria should be adopted immediately for the efficient conduct of municipal affairs and so the assessments can be calculated and sent to the County Auditor in a timely manner.


