

RESOLUTION NO. 020-2023

A RESOLUTION AUTHORIZING SUPPORT FOR PROJECT iAM 2024 AND SEVERAL COMPONENT ACTIONS TO FACILITATE THE EVENT.

WHEREAS, the City of Maumee has supported Project iAM and the Acoustics for Autism event that annually takes place within the City of Maumee;

WHEREAS, the City Council of the City of Maumee wishes to continue to support Project iAM and Acoustics for Autism and finds that the use of City property and resources, placement of tents, closure of roads and suspension of the DORA for Project iAM and Acoustics for Autism would be for a public purpose as defined by Ohio law; that the actions taken would be for the general good of the residents of the City of Maumee and surrounding area; promotes the public health and general welfare of the City of Maumee; and serves a public purpose by providing support for this cause and their annual event.

THEREFORE, BE IT RESOLVED by the Council for the City of Maumee, Ohio, that:

SECTION 1. That the City Council of the City of Maumee, Ohio, hereby authorizes, for 2024 the use of City property and resources on behalf of Project iAM. The City Administrator is authorized to suspend the DORA during the Acoustics for Autism event on March 3, 2024, authorized to approve the request and plans for an F2 liquor permit for the event, and close the West MEWS parking lot from the Friday, March 1, 2024 through Monday, March 4, 2024. The City of Maumee further authorizes Project iAM to use the back theater at the Maumee Indoor Theater on March 3, 2024 from 12 noon until 4PM at no cost, authorizes the placement of tents on the portion of West Wayne Street that will be closed for the event, authorizes the placement of a tents on the West MEWS parking lots, authorizes the waiver of the noise ordinance for the event until March 3, 2024 at 11 PM and authorizes the closure of portions of the following streets for said event:

- (A) Conant Street between West John Street and West Wayne Street on March 3, 2024 from 6AM until 10 PM
- (B) West Dudley Street between Conant Street and Allen Street on March 3 2024 from 6AM until 11:59 PM
- (C) West Wayne Street between Conant Street and Allen Street from March 2, 2024 at 2PM until March 3, 2024 at 11:59 PM. The closure of Wayne Street will begin near the Masonic.Lodge and parking along Wayne closest to Conant will remain open along with access to Maumee Tackle and other businesses and parking will remain open at Maumee Tackle.
- (D) Allen Street between West Wayne Street and Dudley Street from March 3, 2024 at 6 AM until 11:59 PM.

SECTION 2. The City Administrator is authorized to take such further actions that do not involve the expenditure of funds, in addition to those set forth herein, as may be necessary including the closure of additional streets or parking lots as may be in the best interest of the City of Maumee for the Acoustics for Autism 2024 event.

SECTION 3. If any section, phrase, sentence, or portion of this resolution is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

SECTION 4. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including the Maumee Charter and Section 121.22 of the Revised Code of Ohio.
